The Work of this Contract consists of the installation of an uninterrupted power supply system for three commercial printers and associated equipment. Install electrical panel, uninterrupted power supply system, conduit, wiring and receptacles. The uninterrupted power supply system shall be connected to the Building Automation Control System. The Contractor shall furnish and install all items in accordance with Plans and Specifications.

The cost of the work is approximately \$120,000.00. The work to be performed under this contract shall be completed on or before *30 December 2014*.
