Dear Chairman Harvey and LURC Commission;

TransCanada representatives have spoken to me on several occasions and shared information to explain the proposed expansion of the Kibby Wind project onto Sisk Mountain. I understand that there will be some views of these turbines from various locations on Chain of Ponds. The tips of a few blades may even be visible from our camp on the northwestern shore of Long Pond.

My wife and I spend significant portions of each summer at this camp, which we enjoy for its own sake, not because of its real estate values. Because of the fact that we can only access our camp by boat and because the camp has no power or phone lines running to it, it is easy to forget just how close we actually are to Route 27, though the sound of truck traffic reminds us occasionally.

We support this project for several reasons. First, we are confident that there will be no noise or shadow flicker impacts at the more than 3 mile distance from the turbines. Second, we know that wind power is an important part of our energy future. So, we look forward to seeing it from various locations on the Chain of Ponds – even from our camp if it works out that way! Finally, we appreciate the value of providing jobs and investment in this part of Franklin County. Every little bit helps, especially in these tough economic times.
