Mission Statement

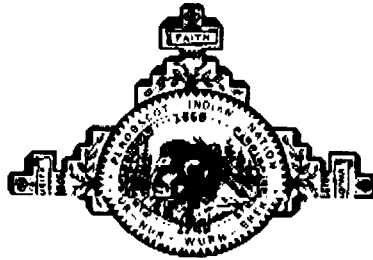
