- 4. As we are putting our bid together, we can across a discrepancy in the Bid Package. 00 11 13 Notice line 3 and 4 states that we do not need a bid bond vs 00 21 13 Instructions to Bidders line 3.5 states that we need a bid bond. Can you please clarify what is needed for the bid package?
 Bid bonds and contract bonds are required for this project by statute, based on the projected contract value. (See attached updated notice to contractors
- 5. Will there be access to the facility for all 7 days of the week?

Maine State Prison - Kitchen Floor Replacement

BGS Project No. 3596

The project scope is the replacement of the existing finished floor and some wall finish in the kitchen of the Maine State Prison. The project will include the removal of the existing floor and wall finish, repair of any damaged sub-floor or walls, and installation of a new floor and wall finish. There is potential mold observed on some walls, it will need to be identified and abated according to current laws. Before the installation of any flooring or wall material, the project includes disconnection, removal, and relocation of existing kitchen equipment, its safe storage and eventual re-installation of the same equipment after the floor has been replaced.

The cost of the work is approximately \$ 250,000. The work to be performed under this contract shall take no longer than **3 weeks start to finish** and be completed on or before the Final Completion date of *July 1, 2024*. The kitchen is integral to the operation of the facility and cannot be out of operation longer than the aforementioned 3 weeks.

- Submit bids on a completed Contractor Bid Form, plus bid security when required, all scanned and included as an attachment to an email with the subject line marked "Bid for Kitchen Floor Replacement Maine State Prison" and addressed to the Bid Administrator at:

 Bid submissions will be opened and read aloud at the time and date noted above at the Bureau of General Services office, accessible as a video conference call. Those who wish to participate in the call must submit a request for access to BGS.Architect@Maine.gov.
 - Any bid received after the noted time will not be considered a valid bid and will remain unopened. Any bid submitted by any other means will not be considered a valid bid. The Bid Administrator may require the Bidder to surrender a valid paper copy of the bid form or the bid security document in certain circumstances.
 - Questions on the bid opening process shall be addressed to the Bid Administrator: Deane Rykerson, Director, Division of Planning, Design & Construction, Bureau of General Services, 77 State House Station, Augusta, Maine 04333-0077, BGS.Architect@Maine.gov.
- The bid shall be submitted on the Contractor Bid Form (section 00 41 13) provided in the Bid Documents.
 The Owner reserves the right to accept or reject any or all bids as may best serve the interest of the
 Owner.
- 3. Bid security is required on this project.
 - If noted above as required, the Bidder shall include a satisfactory Bid Bond (section 00 43 13) or a certified or cashier's check for 5% of the bid amount with the completed bid form submitted to the Owner. The Bid Bond form is available on the BGS website.
- 4. Performance and Payment Bonds are required on this project.

 If noted above as required, or if any combination of Base Bid and Alternate Bids amounts selected in the award of the contract exceeds \$125,000.00, the selected Contractor shall furnish a 100%contract Performance Bond (section 00 61 13.13) and a 100% contract Payment Bond (section 00 61 13.16) in the contract amount to cover the execution of the Work. Bond forms are available on the BGS website.
- 5. Filed Sub-bids are not required on this project.
