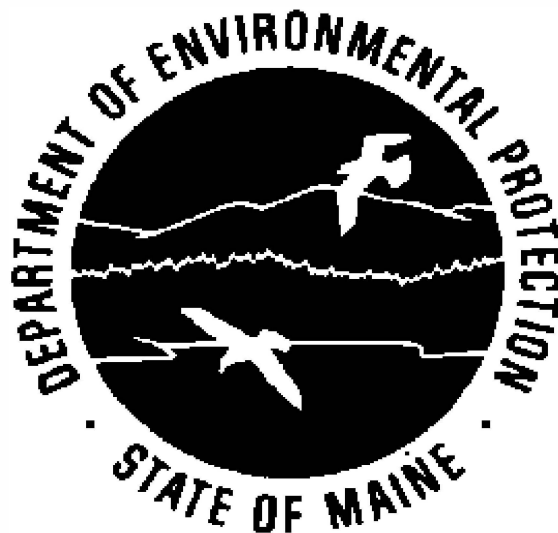

## INSTRUCTIONS

**This form can be used by applicants requesting a State General Permit in accordance with the provisions of State law, Title 38 M.R.S.A. §480-U, and a Federal permit in accordance with the provisions of federal law, 33 USC 1413, §404. The instructions for completing this application are listed below.**

### GENERAL INFORMATION

The application must be filled out completely before it is submitted to the Department of Environmental Protection (DEP) and the U. S. Army Corps of Engineers (Corps). If you have any questions about a submission requirement, please call the appropriate DEP regional office. The telephone numbers are at the end of the instructions. Incomplete applications will be returned.

The Department encourages applicants to schedule pre-application meetings with regional staff to discuss application requirements and the application review process early in the planning process (see the DEP issue profile sheet on pre-application meetings).

The DEP has 15 days to review the application for completeness. Once accepted as complete, the DEP has 45 days to complete its review. The Department will notify you of its decision prior to the end of the 45 day review period. If you wish, you may call the appropriate DEP regional office at any time to check on the status of the application. Permits issued by the Department are valid for 2 years.

The Corps will review the application and will try to notify applicants about the status of the Corps permit within the DEP review times discussed above. Questions about the Corps review can be directed to the Maine Project Office. The address and telephone number are at the end of the instructions.

Permits from the municipality may also be required. Please make sure you have had contact with the local government, and have received all necessary permits before beginning construction.

### DEFERRALS

The 45 day time limit for processing a complete application does not apply when winter conditions prevent the DEP from evaluating a permit application. Under such circumstances, the DEP can defer action for a reasonable period. The applicant will be notified of any necessary deferrals.

### SUBMISSIONS

Please submit **five (5) complete copies** of the application to the appropriate DEP regional office (addresses on page 3).

### SECTION 1. APPLICANT INFORMATION

**Name of applicant.** Write in the name(s) of the landowner or a person that has legal title, right, or interest in all of the property to be affected by the project. If the landowner is an agency, company, corporation, or other organization, please include the organization's name and the name of a person in authority we can contact about the project.

**Street/Box #, City, State, Zip.** Write in the full mailing address of the applicant. The DEP and the Corps will mail copies of any letters to this address.

**Telephone #.** Write in the applicant's daytime telephone number, including the area code. This should be a number where the applicant can usually be reached during normal working hours. If the applicant can not be reached during normal working hours, it may be helpful to have a local contact or agent (see below).

**Fax #.** Write in the applicant's fax # .

**E-mail address:** Write in the applicant's email address if the applicant chooses to receive notification of decision by electronic signature rather than regular mail.

**Local Contact or Agent.** The DEP and the Corps do not require an agent for this application. If the applicant has chosen to have a local contact or agent, please provide the name of that person. The agent can be an attorney, contractor, engineer, or other person willing to provide assistance. Agency staff will call the contact agent first if we have questions. The applicant will always be copied on any letters written about the project.

Please write the full mailing address of the agent. The DEP and the Corps will send original letters to this address. Also, write the full telephone number where the agent can be reached during normal working hours. Quick answers can help minimize delays in the application process.

If the agent has a fax number or email address, please write that on the application.

## SECTION 2. PROPERTY INFORMATION

**Name of Wetland, if named.** Please write in the name of the wetland that will be altered - as it appears on the U.S.G.S. topographic map. If the wetland does not have a name, please write "unnamed".

**Nearest Road, Street, or Route Number.** Please write in the name of the public road closest to the project site.

**City/Town, County.** Please write the name of the town or city, and county where the project will be located. This may be different from the applicant's mailing address.

**Tax Map #, Tax Lot #.** Write in the town tax map and lot number for the property where the project will be located. You can get these numbers from the local tax assessor.

**UTM locations.** Please list the UTM Northing and Easting location, if known.

**Name(s) of any person previously contacted at the DEP or Corps.** Write in names of all agency staff that you have previously contacted about this project.

## SECTION 3. ATTACHMENTS

Please attach all requested information. Label each attachment with the correct exhibit number. It will be helpful if the exhibits follow the cover sheet and signature sheet, and are in numerical order. Site plans may be larger than 8½" by 11". However, at least one set of 8½" by 11" plans must be submitted. Larger plans should be folded to no larger than an 8½" by 11" size. Please make sure that plans are clear, easy to read, and contain all of the information listed on the application form.

☞**NOTE: All plans, and engineering documents must be signed, dated and stamped by a professional engineer.**

For the Corps review, at least one set of project plans must be on 8 1/2" by 11" size paper. They must be clear, reproducible, and legible; and each sheet (including the location map) must have a consistent title block, numbering scheme, and date. PLEASE NOTE THAT REDUCTIONS OF LARGE SCALE PLANS ARE NOT GENERALLY ACCEPTABLE TO THE CORPS. The wetland delineation must be completed using the 1987 Corps of Engineers Wetland Delineation Manual, unless otherwise approved by the Corps. A COPY OF THE DELINEATION REPORT MUST BE SUBMITTED.

#### SECTION 4. ATTACHMENTS FOR CORPS REVIEW

The attachments in this section only apply to the federal permit requirements. The DEP general permit does not require this information, and these exhibits will not be reviewed by the DEP. However, the application will not be complete without all of these exhibits. Questions about this section should be directed to the Corps staff.

#### SECTION 5. FEES

Please be sure to attach a check for the application fee of \$199.00. Applications received without the proper fee will be returned. Make checks payable to: Treasurer State of Maine.

#### SECTION 6. SIGNATURE

Please read this section of the application carefully. If you do not understand the terms you are agreeing to, please call the DEP for clarification. The application must be signed by the applicant, or an agent legally authorized to act on behalf of the applicant. The agent authorization only allows the agent to answer questions and act on the applicant's behalf during the application process. The applicant is still responsible for making sure the project meets all of the requirements for a general permit.

#### VIOLATIONS

Any actions taken that are not in compliance with the standards of the general permit or the approved plans are a violation of the general permit and may be subject to enforcement action by the DEP and/or the Corps.

A.  **Attach as Exhibit #1** written certification by a knowledgeable professional that the cranberry cultivation project will not be located in a wetland that has special characteristics. Please see attached form, page #7.

B.  **Attach as Exhibit #2** site plans\*, drawn to scale, that include the following elements:

1. A location map, using a USGS topo sheet with the project location clearly marked
2. A plan view showing existing and proposed beds, dikes, ditches, roads, ponds, and other appurtenant facilities (include north arrow)
3. Cross-sectional drawings of beds, dams, dikes, ditches, and ponds (reference on the plan view)
4. Length, width and depth of beds, dikes and ditches
5. Delineation of the wetland boundaries and calculated area of wetlands affected \*
6. Type and size of water control structures
7. Location of water sources

**Note:** Appurtenant facilities including, but not limited to, storage buildings, parking areas and processing areas, may not be located in freshwater wetland. This limitation does not apply to pump houses, roadways, service areas and other appurtenant facilities directly related and needed to carry out the water related activities.

C. An applicant or permit holder who directly or indirectly retains an environmental professional for the purpose of providing information to the department shall disclose to the department if the environmental professional has a direct or indirect financial interest in the applicant, the permit holder or the property or activity that is the subject of the permit.  If professional answers yes, then the agent MUST submit a statement stating "what is the interest??"

*\* For the Corps review, at least one set of project plans must be on 8 1/2" by 11" size paper. They must be clear, reproducible, and legible; and each sheet (including the location map) must have a consistent title block, numbering scheme, and date. PLEASE NOTE THAT REDUCTIONS OF LARGE SCALE PLANS ARE NOT GENERALLY ACCEPTABLE TO THE CORPS. The wetland delineation must be completed using the 1987 Corps of Engineers Wetland Delineation Manual, unless otherwise approved by the Corps. A COPY OF THE DELINEATION REPORT MUST BE SUBMITTED.*

C.  **Attach as Exhibit #3** a narrative describing:

1. Existing vegetation
2. Water sources for the project
3. Amounts, types, and sources of fill material to be discharged over the beds
4. Amounts, types, and sources of fill material to be discharged in waters or wetlands

D.  **Attach as Exhibit #4** a soil erosion and sedimentation control plan that is consistent with erosion and sediment control specifications as determined by the Department of Agriculture, Food & Rural Resources and the DEP.

E.  **Attach as Exhibit #5** a plan for water recovery system, including either a reservoir or the cranberry beds themselves, that is designed to contain the runoff from the project area during a 10-year, 24-hour storm event.

F.  **Attach as Exhibit #6** a plan to maintain a 75-foot buffer strip from any river or stream draining a watershed of 100 acres or more. Excavated ditches and water intake and outfall pipes or control structures may be allowed in the 75-foot buffer area.

G.  **Attach as Exhibit #7** design specifications for water intake and outfall pipes and excavated ditches which must be consistent with specifications as determined by the Department of Agriculture, Food & Rural Resources and the DEP.

- H.  **Attach as Exhibit #8** a plan to maintain minimum downstream flows for each water supply area, if a river, stream, or brook is used as a water supply. Minimum base flow is the aquatic base flow for that watershed, or a flow that can be shown to protect designated uses and characteristics assigned in Section 465. If a river, stream or brook will not be used as a water supply, this exhibit should clearly indicate that fact

*For Corps Review, submit a water source budget including the source of water, quantity removed from the source, the projected impact on adjacent wetlands (from drawdown, etc.), and back-up water supply source.*

- I.  **Attach as Exhibit #9** a management plan that includes a pesticide and fertilizer program approved by the Department of Agriculture, Food & Rural Resources. The plan must include the following practices:

1. The application of nutrients and soil amendments in terms of timeliness, amounts, materials and method of application;
2. The use of current integrated pest management practices for applying pesticides properly and in the minimum amounts necessary to control pests; and
3. The management of water in terms of bed drainage, runoff disposal, sprinkler irrigation, control devices to separate natural water from pumping supply for irrigation purposes, back-siphoning prevention devices (for chemigation) and flooding.

- J.  **Attach as Exhibit #10** a certification that the requirements for a "natural cranberry bog" cultivation project will be met, if applicable. See Subsection 2.D. of 38 M.R.S.A. 480-U.

#### 4. ATTACHMENTS FOR CORPS REVIEW

*Information applicable to the Corps General Permit only:*

- A.  **Attach as Exhibit #11** the soil series in the project area, confirmed by a field check.
- B.  **Attach as Exhibit #12** a discussion of any alternatives that may avoid or minimize waterway or wetland impacts. For example, if a road crossing is proposed, was alternative access or crossing at a narrower point considered?
- C.  **Attach as Exhibit #13** a discussion of any historic properties in the area. Applicants must submit a copy of the application and plans to the Maine Historic Preservation Commission at the same time or before they apply for Corps review. The MHPC can be contacted at 207-287-2132 for more information. Submit any Commission correspondence to the Corps upon receipt.

5. **FEES:** State application fee - **\$199.00**. Submit with application. Make checks payable to: Treasurer State of Maine. NO Corps application fees are required.

**PRIVACY ACT STATEMENT**

**NOTE:** Any changes in project plans must be submitted to the DEP and the Corps in writing and must be approved by both agencies prior to implementation. Failure to do so may result in enforcement action and/or the removal of the project changes.

**\*\*\* In general, the Department will not have to enter a building to ensure that a cranberry operation is in compliance with the NRPA. If the Department does find that entry into a building such as a pump house is necessary, the applicant will be notified and the reason for the inspection will be explained at least 24 hours prior to entry into the building.**

## PUBLIC NOTICE FILING AND CERTIFICATION

Department Rules, Chapter 2, require an applicant to provide public notice for the Cranberry General Permit within 30 days prior to filing the application. In the notice, the applicant must provide the information included in the attached Notice of Intent to File form. "Abutter" for the purposes of the notice provision means any person who owns property that is contiguous with the property on which the project requiring a license from the Department is proposed.

1. **Newspaper:** You must publish the Notice of Intent to File in a newspaper circulated in the area where the activity is located. The notice must appear in the newspaper within 30 days prior to the filing of the application with the Department. You may use the attached Notice of Intent to File form, or one containing identical information, for newspaper publication.
2. **Abutters and Others Owning Land Within 1,000 Feet:** You must mail a copy of the Notice of Intent to File to abutters and all persons owning land within 1,000 feet of the proposed project. Their names and addresses can be obtained from the town tax maps or local officials. They must receive notice within 30 days prior to the filing of the application with the Department.
3. **Municipal Office or County Commissioner(s):** You must mail a copy of the Notice of Intent to File and a duplicate of the entire application to the Municipal Office or, if the proposed project is located in an unorganized or deorganized area of the State, to the county commissioner(s). The Municipal Office or county commissioner(s) must receive notice within 30 days prior to the filing of the application with the Department.

**ATTACH a copy of the published notice and a list of persons to whom notice was provided.**

### CERTIFICATION

By signing below, the applicant or authorized agent certifies that:

1. A Notice of Intent to File was published in a newspaper circulated in the area where the project site is located within 30 days prior to filing the application;
2. A mailing of the Notice of Intent to File was sent to all abutters and all other persons owning land within 1,000 feet of the proposed project within 30 days prior to filing of the application;
3. A mailing of the Notice of Intent to File, and a duplicate copy of the application was sent to the town office of the municipality in which the project is located or, if applicable, to the county commissioner(s); and

Provided notice of and held a public informational meeting, if required, in accordance with the Department's Chapter 2 rules, Processing of Applications and Other Administrative Matters, Section 12, prior to filing the application. Section 480-U are met. A "natural cranberry bog" means an area with indigenous large cranberries, *Vaccinium macrocarpon* Ait., comprising more than 50% of the cover in the herbaceous layer; and "cover in the herbaceous layer" means all herbaceous or woody vegetation less than 10 inches in height.

\*\* *For Corps review, applicants must contact Linda Welch of the U.S. Fish & Wildlife Service at 207-827-5938 for information about federally listed threatened or endangered species or critical habitat in the project area. Any USFWS documentation must be included in this application.*
