**5. State and Federal Regulations**

Lead abatement contractors and abatement personnel must be knowledgeable about and comply with all applicable Occupational Health and Safety regulations of the Maine Bureau of Labor Standards, Federal Occupational Safety and Health Administration regulations, the Maine Department of Environmental Protection and the U.S. Department of Transportation. Please provide a statement.

## 6. Record Keeping Requirements

A statement must be submitted affirming that the Lead Abatement Contractor maintains the following documents at the abatement work site throughout the duration of such activity, and would make the documents immediately available to the Department upon request:

- \* A current copy of the rules, Chapter 424 "Lead Management Regulations";
- \* A copy of the on-going lead abatement project design;
- \* Records of all project documentation.
- \* Other documentation relevant to project.
- \* A listing of all employees, by name, social security number and Department certification number, who are assigned to the on-going project;
- \* A listing of each of the subcontractors involved in the on-going project;
- \* A Department certification card for each employee involved in the ongoing project;
- \* A daily sign-in/out log clearly identifying each employee involved in the on-going project by name and Department certification number, identifying the length of time each spent at the project location;
- \* A copy of the notification of the project provided to the Department.

## 7. Application and License Fees:

The application must include a non-refundable cashiers, certified or company check in the amount of **\$275.00** made payable to the **Maine Environmental Protection Fund**.
