

Maine DMR Shellfish Growing Area Classification Program Tabulated Data Report

Growing Area: EP

DMR collects additional water samples during flood events, to document pollution sources and under other adverse conditions which may not be included in this tabulated data report. Please refer to the specific growing area annual, triennial or sanitary survey report for further information on these samples and explanation of current classifications in each growing area. The 30 most recent data scores are used in the P90 calculation to determine classifications in a growing area.
