

# Maine DMR Shellfish Growing Area Classification Program Tabulated Data Report

**Growing Area:** WA

DMR collects additional water samples during flood events, to document pollution sources and under other adverse conditions which may not be included in this tabulated data report. Please refer to the specific growing area annual, triennial or sanitary survey report for further information on these samples and explanation of current classifications in each growing area. The 30 most recent data scores are used in the P90 calculation to determine classifications in a growing area. **Adversity:** B = minimum 5 enclosed boats (i.e. not open skiffs) that might have a head; F= statewide flood closure, H= seasonal habitation of homes; M= marinas with 10 or more enclosed boats in the water; N= flowing streams, stormwater pipes, or overland runoff, P= rain or mixed precipitation anytime within past 2 days (i.e.thunderstorms, rainfall more than a drizzle); T= thawing snow and ice melt; S= sewage treatment plant malfunction or bypass events; W= Waterfowl (10 or more), domestic or wild animals (i.e., at the station or in close enough proximity to have a possible impact).
