New FSA/OTC Regulations – Effective January 1, 2011

Flexible Spending Account funds can no longer be used to purchase OTC medicines and drugs unless the medicine or drug is prescribed with a written order from a medical doctor or other individual who is legally authorized to issue prescriptions, as defined by each state. However, ***insulin remains a covered expense, with or without a prescription.***

Instructions

For reimbursable over-the-counter expenses, please attach a copy of the original prescription issued by your medical care provider, and a copy of the receipt from the provider or vendor (e.g., a retail store) that includes the following:

- the date the expense was incurred
- the specific OTC item purchased (i.e., product name and quantity or size if applicable)
- the amount of the charges

In the absence of a detailed receipt, please provide corroborating documentation, such as a copy of the product packaging with identifying information that matches a line item on the available receipt (e.g., the UPC code number).
