

### 2010 TRIGGER REPORT - GENERAL ELECTION

#### For Legislative Candidates (party candidates only)

- Traditionally financed legislative candidates with a publicly funded opponent are required to file a Trigger Report when the total of all receipts or the total of all expenditures, whichever is greater, exceeds the trigger amount of: **\$4,144 for a House candidate or \$19,078 for a Senate candidate.**
- When you file a Trigger Report, the Commission staff will notify you of additional accelerated reports your campaign is required to file.
- The summary information contained in this report must be itemized in the appropriate regular campaign finance report (i.e., 42-Day Post-Primary, 42-Day Pre-General, 11-Day Pre-General or 42-Day Post-General).
