HEADS AND HIDES PRIVILEGES - The law now allows taxidermists to buy, sell or barter raw, untanned hides or heads of wild animals without obtaining a hide dealer license. However taxidermists doing so must obtain and maintain the hide record books. If you need hide report books, indicate the number of books you will need in Question 5 on the front of this application.
