New Respiratory Protection Standard in Effect

The Respiratory Protection Standard for Maine public sector workplaces became effective October 1, 1999. By November 1, 1999, each employer who is affected must have a written respiratory protection plan in place. By August 2, 2000, full compliance is expected. Videotape on Respirator Fit-testing Available

Public Sector Enforcement Officers Enforce Computer Safety Law

Under Maine Law, employees who use computers four or more hours a day must be trained how to work safely on the computer. This training must occur within the first month after hiring and on an annual basis. In recent months, Public Sector Enforcement Officers have cited a variety of workplaces for failure to comply with this law. Applying Heat to Equipment Being Worked on Can be Unsafe

According to the U.S. Mine Safety and Health Administration (MSHA), three workers died this year while using heat to assist with repairs on heavy equipment. MSHA recommends the following:

- DO NOT use heat or open flame where lubricants, oil, or grease are present.
- DO NOT use heat or open flame where there is a fire or explosion hazard.
- NEVER apply a heat source to a tire rim/hub until the tire has been removed from the hub assembly.
- Staff required to service tire and rims need tire and rim safety training.
- Before heating components refer to the equipment manual or contact the manufacturer for special safety precautions.
