## APPLICATION INSTRUCTIONS FOR REINSTATEMENT OF LICENSE

Enclosed in this packet of information is all the material you will need to reinstate your cosmetology, barber, aesthetic or manicuring license with the Barbering & Cosmetology Program.

### PROCEDURES TO REINSTATE YOUR LAPSED LICENSE

**\*\*Fax submissions of applications and supporting documentation will not be accepted.**

The licensee must complete an **Application for reinstatement of license**. The following must be submitted with the application:

**Appropriate Fee**

Pursuant to Title 32, Chapter 126, §14235 “A license may be renewed up to 90 days after the date of its expiration upon payment of a late fee as set under section 14238 in addition to the renewal fee. Any person who submits an application for renewal more than 90 days after the license expiration date is subject to all requirements governing new applicants under this chapter, including a late fee, renewal fee and additional late fee as set under section 14238, except that the program, after giving due consideration to the protection of the public, may waive requirements.

### PROCESSING TIME:

- ✓ Please do not call our office regarding the status of your application as numerous calls will delay the timeliness of processing applications. Information regarding the status of applications may be found at the Office of Professional and Occupational Regulation’s website [www.maine.gov/professionallicensing](http://www.maine.gov/professionallicensing). We appreciate your thoughtful attention to this request.
- ✓ Once your license is issued it is immediately visible online with an “active” status. Licenses are printed off site and require at least 14 days for delivery.

- **How far back do I go answering the criminal question?** Any conviction, ever.

### NOTICES

**BACKGROUND CHECK:** Pursuant to 5 MRS §5301 - 5303, the State of Maine is granted the authority to take into consideration an applicant's criminal history record. The Office of Professional and Occupational Regulation requires a criminal history records check as part of the application process for all applicants.

**PUBLIC RECORD:** This application is a public record for purposes of the Maine Freedom of Access Law (1 MRS §401 et seq). Public records must be made available to any person upon request. This application for licensure is a public record and information supplied as part of the application (other than social security number and credit card information) is public information. Other licensing records to which this information may later be transferred will also be considered public records.
