APPROVAL OF MINUTES

LIMITED LICENSE TRAINEE STATUS

Bruce A. Hansen – A request for the Limited License Trainee status for Category III and IV (Chest and Extremities) was reviewed. Mr. Hanson would like to train at Islands Community Medical Services, Inc. on Vinalhaven under the supervision of Dr. Richard J. Donahue. Terry Zipper moved to approve. Seconded by Carrie Steele. REVIEW OF RULES

The Board conducted an overview of what it wanted to achieve with its rules review, and began that review. The impetus for conducting this activity at this time is the fact that some institutions are opting for academic – rather than JRCERT – accreditation, but the rules, as currently written, do not accommodate this option. In addition to changing this, the board will include more statutory citations, and align the definitions and continuing education standards with those of the American Registry of Radiologic Technologists (ARRT). Dawn Commune is checking the ARRT definitions and Continuing Education standards to assure that the rules to be developed will comport with them.

(The ARRT is introducing an additional licensing exam in January of 2003, for Bone Densitometry Equipment Operators. The board has not determined whether it will be contemplating this category in its rules; if so, this may require a law change, as well.)

OTHER BUSINESS

A Certificate of Appreciation will be prepared for former board member Theresa Vieira, and Dawn Commune will also send her a letter, thanking her for her service to the board.
