

## **State Representative District 1**

In York County, the part of the municipality of Kittery east and southeast of a line described as follows: Beginning at the point where the northwestern boundary of Block 1006 of Tract 038002 intersects the Kittery-York boundary; (the block immediately to the west of I-95); then southwest along the boundary of Block 1006 of Tract 038002 until it intersects with I-95; then southwest along I-95 until it intersects with Block 1046 of Tract 038002; then along the western boundary of Block 1046 of Tract 038002 until it intersects with State Route 236; then northwest along the centerline of State Route 236 until it intersects with the Kittery-Eliot boundary.

## **State Representative District 2**

In York County, the municipality of Eliot; and

the part of the municipality of Kittery west and northwest of a line described as follows: Beginning at the point where the northwestern boundary of Block 1006 of Tract 038002 intersects the Kittery-York boundary; (the block immediately to the west of I-95); then southwest along the boundary of Block 1006 of Tract 038002 until it intersects with I-95; then southwest along I-95 until it intersects with Block 1046 of Tract 038002; then along the western boundary of Block 1046 of Tract 038002 until it intersects with State Route 236; then northwest along the centerline of State Route 236 until it intersects with the Kittery-Eliot boundary; and

the part of the municipality of South Berwick south, southeast and southwest of a line described as follows: Beginning at the point where Old Bennett Road intersects with the South Berwick-York boundary; then north and then west along the centerline of Old Bennett Road until it intersects with Bennett Road; then north along the centerline of Bennett Road until it intersects with Witchtrot Road; then southwest along the centerline of Witchtrot Road until it intersects with York Woods Road; then west along the centerline of York Woods Road until it intersects with the Dow Highway (Route 236); then northwest along the centerline of the Dow Highway until it intersects with Old Mill Road; then northwest along the centerline of Old Mill Road until it intersects with Liberty Street; then northwest along the centerline of Liberty Street until it intersects with Main Street; then southwest along the centerline of Main Street (across the Salmon Falls River) until it intersects with the South Berwick-New Hampshire boundary.

### **State Representative District 3**

In York County, the part of the municipality of York east and southeast of a line described as follows: Beginning at the point where I-95 intersects the Kittery-York boundary; then northeast and then north along I-95 until it intersects with the southeastern boundary of Block 2019 of Tract 036002; then northeast along the eastern boundary of Block 2019 of Tract 036002 until it intersects with the northwestern boundary of Block 2021 of Tract 036002; then north along the northwestern boundary of Block 2021 of Tract 036002 until it intersects the York-Ogunquit boundary.

## **State Representative District 4**

In York County, the municipality of Ogunquit; and

the part of the municipality of Sanford east, northeast and southeast of a line described as follows: Starting at the point where Abenaki Lane intersects with the Sanford-North Berwick boundary; then east along the centerline of Abenaki Lane until it intersects with Country Club Road; then north and northwest along the centerline of County Club Road until it intersects with Alfred Road; then northeast along the centerline of Alfred Road until it intersects with Canes Brook; then north and northwest along Canes Brook until it intersects with Hay Brook; which is also the Sanford-Alfred boundary; and

the part of the municipality of Wells west, southwest and south of a line described as follows: Beginning at the point where the Wells-Ogunquit boundary intersects with the western boundary of Block 3062 of Tract 034002; then north along the western boundary of Blocks 3062, 3063 and 3064 of Tract 034002 until it intersects with Green Brook; then northwest and north along Green Brook until it intersects with Cheney Woods Road; then northeast along the centerline of Cheney Woods Road until it intersects with Littlefield Road; then northwest along the centerline of Littlefield Road until it intersects with North Berwick Road; then west along the centerline of North Berwick Road until it intersects with Dodge Road; then northwest along the centerline of Dodge Road until it intersects with Bragdon Road; then north along the centerline of Bragdon Road until it intersects with Perry Oliver Road; then northwest and north along the centerline of Perry Oliver Road until it intersects with Horace Mills Road; then north along the centerline of Horace Mills Road until it intersects with the Wells-Sanford boundary; and

the part of the municipality of York west and northwest of a line described as follows: Beginning at the point where I-95 intersects the Kittery-York boundary; then northeast and then north along I-95 until it intersects with the southeastern boundary of Block 2019 of Tract 036002; then northeast along the eastern boundary of Block 2019 of Tract 036002 until it intersects with the northwestern boundary of Block 2021 of Tract 036002; then north along the northwestern boundary of Block 2021 of Tract 036002 until it intersects the York-Ogunquit boundary.

## **State Representative District 5**

In York County, the municipality of Berwick; and

the part of the municipality of North Berwick west and southwest of a line described as follows: Beginning at the point where Little River Road intersects the North Berwick-Lebanon boundary; then southeast along the centerline of Little River Road until it intersects with Lebanon Road; then southeast along the centerline of Lebanon Road until it intersects with Beech Ridge Road; then southeast along the centerline of Beech Ridge Road until it intersects with Clark Road; then northeast along the centerline of Clark Road until it intersects with Lebanon Road; then east and southeast along the centerline of Lebanon Road until it intersects with High Street; then south along the centerline of High Street until it intersects with Elm Street; then south along the centerline of Elm Street until it intersects with Frost Brook; then southeast along Frost Brook until it intersects with the North Berwick-South Berwick boundary.

## **State Representative District 6**

In York County, the part of the municipality of North Berwick east and northeast of a line described as follows: Beginning at the point where Little River Road intersects the North Berwick-Lebanon boundary; then southeast along the centerline of Little River Road until it intersects with Lebanon Road; then southeast along the centerline of Lebanon Road until it intersects with Beech Ridge Road; then southeast along the centerline of Beech Ridge Road until it intersects with Clark Road; then northeast along the centerline of Clark Road until it intersects with Lebanon Road; then east and southeast along the centerline of Lebanon Road until it intersects with High Street; then south along the centerline of High Street until it intersects with Elm Street; then south along the centerline of Elm Street until it intersects with Frost Brook; then southeast along Frost Brook until it intersects with the North Berwick-South Berwick boundary; and

the part of the municipality of South Berwick north, northeast and northwest of a line described as follows: Beginning at the point where Old Bennett Road intersects with the South Berwick-York boundary; then north and then west along the centerline of Old Bennett Road until it intersects with Bennett Road; then north along the centerline of Bennett Road until it intersects with Witchtrot Road; then southwest along the centerline of Witchtrot Road until it intersects with York Woods Road; then west along the centerline of York Woods Road until it intersects with the Dow Highway (Route 236); then northwest along the centerline of the Dow Highway until it intersects with Old Mill Road; then northwest along the centerline of Old Mill Road until it intersects with Liberty Street; then northwest along the centerline of Liberty Street until it intersects with Main Street; then southwest along the centerline of Main Street (across the Salmon Falls River) until it intersects with the South Berwick-New Hampshire boundary.

## **State Representative District 7**

In York County, the part of the municipality of Wells north, northeast and east of a line described as follows: Beginning at the point where the Wells-Ogunquit boundaries intersects with the western boundary of Block 3062 of Tract 034002; then north along the western boundary of Blocks 3062, 3063 and 3064 of Tract 034002 until it intersects with Green Brook; then northwest and north along Green Brook until it intersects with Cheney Woods Road; then northeast along the centerline of Cheney Woods Road until it intersects with Littlefield Road; then northwest along the centerline of Littlefield Road until it intersects with North Berwick Road; then west along the centerline of North Berwick Road until it intersects with Dodge Road; then northwest along the centerline of Dodge Road until it intersects with Bragdon Road; then north along the centerline of Bragdon Road until it intersects with Perry Oliver Road; then northwest and north along the centerline of Perry Oliver Road until it intersects with Horace Mills Road; then north along the centerline of Horace Mill Road until it intersects with the Wells-Sanford boundary.

## **State Representative District 8**

In York County, the part of the municipality of Kennebunk north and west of a line described as follows: Beginning at the point where Durrells Bridge Road intersects with the Kennebunk-Arundel boundary; the southwest along the centerline of Durrells Bridge Road until it intersects with Summer Street; then southeast along the centerline of Summer Street until it intersects with Heath Road; then southwest along the centerline of Heath Road until it intersects with Sea Road; then southeast along the centerline of Sea Road until it intersects with the northern boundary of Block 1024 of Tract 028002; then south along the boundary of Block 1024 of Tract 028002 until it intersects with the Mousam River; then southeast along the Mousam River until it intersects with the Atlantic Ocean.

## **State Representative District 9**

In York County, the municipality of Kennebunkport; and

the part of the municipality of Biddeford southeast of a line described as follows: Beginning at the point where Guinea Road intersects with the Biddeford-Kennebunkport boundary; then northeast along the centerline of Guinea Road until it intersects with Meetinghouse Road; then southeast along the centerline of Meetinghouse Road until it intersects with Marblehead Lane; then northeast along the centerline of Marblehead Lane until it intersects with Pool Street; then southeast along the centerline of Pool Street until it intersects with Moors Brook; then northeast along Moors Brook until it intersects with the Saco River; then north along the western bank of the Saco River until it intersects with the western boundary of Block 2008 of Tract 025400; then northeast along the boundary of Block 2008 of Tract 025400 until it intersects with the Biddeford-Saco boundary (in the Saco River); and

the part of the municipality of Kennebunk south and east of a line described as follows: Beginning at the point where Durrells Bridge Road intersects with the Kennebunk-Arundel boundary; then southwest along the centerline of Durrells Bridge Road until it intersects with Summer Street; then southeast along the centerline of Summer Street until it intersects with Heath Road; then southwest along the centerline of Heath Road until it intersects with Sea Road; then southeast along the centerline of Sea Road until it intersects with the northern boundary of Block 1024 of Tract 028002; then south along the boundary of Block 1024 of Tract 028002 until it intersects with the Mousam River; then southeast along the Mousam River until it intersects with the Atlantic Ocean.

## **State Representative District 10**

In York County, the municipalities of Arundel and Dayton; and

the part of the municipality of Lyman east and south of a line described as follows: Beginning at the point where Jellerson Road intersects with the Lyman-Waterboro boundary; then southeast along the centerline of Jellerson Road until it intersects with Clarks Woods Road; then southeast along the centerline of Clarks Woods Road until it intersects with Frost Road; then south along the centerline of Frost Road until it intersects with South Waterboro Road; then east along the centerline of South Waterboro Road until it intersects with Kennebunk Pond Road; then south along the centerline of Kennebunk Pond Road until it intersects with Alfred Road; then west along the centerline of Alfred Road until it intersects with the Lyman-Alfred boundary.

## **State Representative District 11**

In York County, the part of the municipality of Biddeford bounded by a line described as follows: Beginning at the point where the Biddeford-Dayton boundary intersects with the Biddeford-Saco boundary; then southeast and east along the Biddeford-Saco boundary (in the Saco River) until it intersects with the Boston and Maine Railroad; then southwest along the Boston and Maine Railroad until it intersects with the southern bank of the Saco River; then east along the southern bank of the Saco River until it intersects with the eastern boundary of Block 3010 of Tract 025201; then southeast along the boundary of Block 3010 of Tract 025201 until it intersects with the end of Harvey Street; then southwest along the centerline of Harvey Street until it intersects with Main Street; then southeast along the centerline of Main Street until it intersects with Elm Street; then southwest along the centerline of Elm Street until it intersects with the eastern boundary of Block 1014 of Tract 025201; then southeast along the boundary of Block 1014 of Tract 025201 until it intersects with Graham Street; then southwest along the centerline of Graham Street until it intersects with Emmons Place; then southeast along the centerline of Emmons Place until it intersects with Alfred Street; then southwest along the centerline of Alfred Street until it intersects with Ray Street; then southeast and then southwest along the centerline of Ray Street until it intersects with Victory Avenue; the southeast along the centerline of Victory Avenue until it intersects with Prospect Street; then southwest along the centerline of Prospect Street until it intersects with West Street; then southeast along the centerline of West Street until it intersects with West Brook; then northeast and northwest along West Brook until it intersects with the northern boundary of Block 1015 of Tract 025300; then southeast along the boundary of Block 1015 of Tract 025300 until it intersects with the end of Parkside Drive; then northeast and then northwest along the centerline of Parkside Drive until it intersects with Pool Street; then southeast along the centerline of Pool Street until it intersects with Libby Drive; then north along the centerline of Libby Drive until it ends at the boundary of Block 1002 of Tract 025300; then northwest along the boundary of Block 1002 of Tract 025300 until it intersects with the boundary of Block 1000 of Tract 025300; then northeast along the boundary of Block 1000 of Tract 025300 until it intersects with the Biddeford-Saco boundary (in the Saco River); then southeast and east along the Biddeford-Saco boundary until it intersects with the boundary of Block 1000 of Tract 025300; then southeast along the boundary of Block 1000 and Block 1003 of Tract 025300 until it intersects with Moors Brook; then west along Moors Brook until intersects with Pool Street; then northwest along the centerline of Pool Street until it intersects with Marblehead Lane; then southwest along the centerline of Marblehead Lane until it intersects with Meetinghouse Road; then northwest along the centerline of Meetinghouse Road until it intersects with Guinea Road; then southwest along the centerline of Guinea Road until it intersects with the Biddeford-Kennebunkport boundary; then northwest along the Biddeford-Kennebunkport boundary until it intersects with the Biddeford-Arundel boundary; then northwest along the Biddeford-Arundel boundary until it intersects with the Biddeford-Dayton boundary; then northeast along the Biddeford-Dayton boundary back to the beginning point.

## **State Representative District 12**

In York County, the part of the municipality of Biddeford bounded by a line described as follows: Beginning at the point where the Boston and Maine Railroad intersects with the Biddeford-Saco boundary; then southwest along the Boston and Maine Railroad until it intersects with the southern bank of the Saco River; then east along the southern bank of the Saco River until it intersects with the eastern boundary of Block 3010 of Tract 025201; then southeast along the boundary of Block 3010 of Tract 025201 until it intersects with the end of Harvey Street; then southwest along the centerline of Harvey Street until it intersects with Main Street; then southeast along the centerline of Main Street until it intersects with Elm Street; then southwest along the centerline of Elm Street until it intersects with the western boundary of Block 1013 of Tract 025201; then southeast along the boundary of Block 1013 of Tract 025201 until it intersects with Graham Street; then southwest along the centerline of Graham Street until it intersects with Emmons Place; then southeast along the centerline of Emmons Place until it intersects with Alfred Street; then southwest along the centerline of Alfred Street until it intersects with Ray Street; then southeast and then southwest along the centerline of Ray Street until it intersects with Victory Avenue; the southeast along the centerline of Victory Avenue until it intersects with Prospect Street; then southwest along the centerline of Prospect Street until it intersects with West Street; then southeast along the centerline of West Street until it intersects with West Brook; then northeast and northwest along West Brook until it intersects with the southwestern boundary of Block 1014 of Tract 025300; then southeast along the boundary of Block 1014 of Tract 025300 until it intersects with the end of Parkside Drive; then northeast and then northwest along the centerline of Parkside Drive until intersects with Pool Street; then southeast along the centerline of Pool Street until it intersects with Libby Drive; then north along the centerline of Libby Drive until it ends at the boundary of Block 1002 of Tract 025300; then northwest along the boundary of Block 1002 of Tract 025300 until it intersects with the boundary of Block 1000 of Tract 025300; then northeast along the boundary of Block 1000 of Tract 025300 until it intersects with the Biddeford-Saco boundary (in the Saco River); then northwest along the Biddeford-Saco boundary back to the beginning point.

In York County, the municipality of Old Orchard Beach.

## **State Representative District 14**

In York County, the part of the municipality of Saco east and south of line described as follows: Beginning at the point where the Boston and Maine Railroad intersects with the Saco-Biddeford boundary; then northeast along the Boston and Maine Railroad until it intersects with Lincoln Street; then northwest along the centerline of Lincoln Street until it intersects with Maple Street; then northeast along the centerline of Maple Street until it intersects with Bradley Street; then southeast along the centerline of Bradley Street until it intersects with Stacy Street; then northeast along the centerline of Stacy Street until it intersects with Ura Street; then northwest along the centerline of Ura Street until it intersects with Franklin Street; then northeast along the centerline of Franklin Street until it intersects with North Street; then southeast along the centerline of North Street until it intersects with Union Street; then northeast along the centerline of Union Street until it intersects with Clark Street; then southeast along the centerline of Clark Street until it intersects with Main Street; then northeast along the centerline of Main Street until it intersects with Goosefare Brook; then northeast and then southeast along Goosefare Brook (which also is the Saco-Old Orchard boundary) until it intersects with the Atlantic Ocean.

## **State Representative District 16**

the part of the municipality of Buxton south of a line described as follows: Beginning at the point where Flaggy Meadow Road intersects with the Buxton-Gorham boundary; then southwest along the centerline of Flaggy Meadow Road until it intersects with Groveville Road; then southwest along the centerline of Groveville Road until it intersects with Long Plains Road; then northwest along the centerline of Long Plains Road until it intersects with the northern boundary of Block 3001 of Tract 020000; then southwest along the boundary of Block 3001 of Tract 020000 until it intersects with River Road; then northwest along the centerline of River Road until it intersects with the northern boundary of Block 3043 of Tract 020000; then west along the boundary of Block 3043 of Tract 020000 until it intersects with the eastern shore of the Saco River; and

the part of the municipality of Saco bounded by a line described as follows: Beginning at the point where McKenney Road intersects with the Saco-Buxton boundary; then southeast along the centerline of McKenney Road until it intersects with the eastern boundary of Block 1017 of Tract 005100; then southwest along the boundary of Blocks 1017, 1029 and 1028 of Tract 005100 until it intersects with Stackpole Creek; then southwest along Stackpole Creek until it intersects with the Saco-Dayton-Buxton boundary; then southwest along the Saco-Dayton boundary until it intersects with the Saco-Buxton boundary; then northeast along the Saco-Buxton boundary back to the beginning point.

## **State Representative District 17**

In York County, the municipality of Waterboro; and

## **State Representative District 18**

In York County, the part of the municipality of Sanford bounded by a line described as follows: Beginning at the point where Canes Brook intersects with the Sanford-Alfred boundary; then southeast and south along Canes Brook until it intersects with Alfred Road; then south along the centerline of Alfred Road until it intersects with Main Street; then northwest along the centerline of Main Street until it intersects with Emerson Street; then southwest along the centerline of Emerson Street until it intersects with the southern boundary of Block 2003 of Tract 030203; then southwest along the southern boundary of Block 2003 of Tract 030203 until it intersects with Twombly Road; then north along the centerline of Twombly Road until it intersects with Pine Avenue; then west along the centerline of Pine Avenue until it intersects with Cox Lane; then north along the centerline of Cox Lane until it intersects with Beverly Street; then north along the centerline of Beverly Street until it ends; then north along the western boundary of Block 3000 of 030203 until it intersects with Beacon Street; then west along the centerline of Beacon Street until it intersects with Kimball Street; then east along the centerline of Kimball Street until it intersects with Middle Street; then north and then northwest along the centerline of Middle Street until it intersects with Lebanon Street; and then northeast along the centerline of Lebanon Street until it intersects with Hanson Ridge Road; then northwest along the centerline of Hanson Ridge Road until it intersects with Douglas Street; then north along the centerline of Douglas Street until it intersects with Grandview Avenue; then east along the centerline of Grandview Avenue until it intersects with North Street; then north and northeast along the centerline of North Street until it intersects with Main Street; then northwest on the centerline of Main Street until it intersects with the boundary of Block 2018 of Tract 030100; then south along the boundary of Block 2018 of Tract 030100 until it intersects with Sanford High School Boulevard; then east and northeast along the centerline of Sanford High School Boulevard until it intersects with Votech Drive; then northeast along the centerline of Votech Drive until it intersects with the boundary of Block 2003 of Tract 030100; then northeast along the boundary of Block 2003 of Tract 030100 until it intersects with Votech Drive; then southeast along the centerline of Votech Drive until it intersects with Sanford High School Boulevard; then southeast along the centerline of Sanford High School Boulevard until it intersects with River Street; then north along the centerline of River Street until it intersects with Pleasant Street; then northwest along the centerline of Pleasant Street until it intersects with Railroad Avenue; then northeast and then north along the centerline of Railroad Avenue until it intersects with the Sanford-Alfred boundary; and then southeast along the Sanford-Alfred boundary to the beginning point.

## **State Representative District 19**
