Dear Parents/Guardians of Sample A. Sample:

Buckingham County Public Schools (“BCPS”), like many school systems and organizations across the country, has unfortunately been the victim of an email compromise incident where an unauthorized user briefly gained access to a single BCPS business email account. We are writing to share with you how this incident may have affected your student’s health-related information and, as a precaution, we are providing you with steps you can take to protect this information.

Although we have no evidence that the unauthorized user successfully removed your student’s information from the compromised BCPS email account, or is using it for a malicious purpose, we wanted to alert you to this matter. Out of an abundance of caution, we have also arranged the option for your student to receive free identity monitoring from Experian. As described below, the account contained a limited amount of health-related information such as your student’s physical condition or medical treatment. More information about the free identity monitoring services we are providing through Experian can be found in the attached Identity Theft and Protection Guide.

What Happened and What Information Was Involved

The incident occurred on or about June 20, 2023, when we were alerted that an unauthorized user gained access to a single BCPS business email account. Once we became aware of the unauthorized access, we conducted an extensive review of the email account to identify the information contained in the account and anyone who may have been impacted.

Based on this review, we have determined that the information in the email account may have included one or more of the following types of information: your student’s name coupled with a limited amount of health or medical diagnostic and treatment information, and/or address. Examples typical of medical information in the email account include immunization records, information that BCPS instructors use to facilitate a safe and productive learning environment for all students (e.g. notice of student allergies), and parents, students, and teachers reporting absences for doctor’s appointments or illness. Please note, the email account **did not** contain any information that could be leveraged to cause your student financial harm such as a Social Security number or the requisite information to access your student’s financial accounts.

What We Are Doing

Upon discovering the incident, we began an investigation and engaged leading outside cybersecurity experts who confirmed that the unauthorized user's access was limited to BCPS's email platform.

We have notified the Virginia State Police's Fusion Intelligence Center of this incident and intend to support any law enforcement investigation into this incident. We take our obligation to safeguard personal information very seriously and we are continuing to evaluate additional actions to strengthen our network security in the face of an ever-evolving cyber threat landscape.

What You Can Do

Please stay vigilant regarding your student's personal information and review the enclosed attached Identity Theft Protection Guide for additional information on how to protect against identity theft and fraud. You may also take advantage of the complimentary identity monitoring services being offered for your student through Experian. Information regarding the identity monitoring enrollment is included in the attached Identity Theft Protection Guide.

IDENTITY THEFT PROTECTION GUIDE AND INFORMATION

The following guide contains information regarding how to enroll your child in the free identity monitoring provided as well as additional resources on identity theft protection.

Details Regarding Enrollment with Experian

To help protect your minor dependent's identity, we are offering complimentary access to Experian IdentityWorksSM for twenty-four months.

If you believe there was fraudulent use of your minor dependent's information as a result of this incident and would like to discuss how you may be able to resolve those issues, please reach out to an Experian agent. If, after discussing your situation with an agent, it is determined that identity restoration support is needed then an Experian Identity Restoration agent is available to work with you to investigate and resolve each incident of fraud that occurred from the date of the incident (including, as appropriate, helping you with contacting credit grantors to dispute charges and close accounts; assisting you in placing a freeze on your credit file with the three major credit bureaus; and assisting you with contacting government agencies to help restore your identity to its proper condition).

Please note that Identity Restoration is available to you for twenty-four months from the date of this letter and does not require any action on your part at this time. The Terms and Conditions for this offer are located at www.ExperianIDWorks.com/restoration.

While identity restoration assistance is immediately available to you, we also encourage you to activate the fraud detection tools available through Experian IdentityWorks as a complimentary twenty-four-month membership. - **Social Security Number Trace:** Monitoring to determine whether enrolled minors in your household have an Experian credit report. Alerts of all names, aliases and addresses that become associated with your minor's Social Security number (SSN) on the Experian credit report.
- **Internet Surveillance:** Technology searches the web, chat rooms & bulletin boards 24/7 to identify trading or selling of your personal information on the Dark Web.
- **Identity Restoration:** Identity Restoration specialists are immediately available to help you address credit and non-credit related fraud.
- **Experian IdentityWorks ExtendCARE™:** You receive the same high-level of Identity Restoration support even after your Experian IdentityWorks membership has expired.

Monitor Your Accounts

We recommend that you regularly review statements from your accounts and periodically obtain your credit report from one or more of the national credit reporting companies. You may obtain a free copy of your credit report online at www.annualcreditreport.com, by calling toll-free 1-877-322-8228, or by mailing an Annual Credit Report Request Form (available at www.annualcreditreport.com) to Annual Credit Report Request Service, P.O. Box 105281, Atlanta GA, 30348-5281. You may also purchase a copy of your credit report by contacting one or more of the three national credit reporting agencies listed below.

When you receive your credit reports, review them carefully. Look for accounts or creditor inquiries that you did not initiate or do not recognize. Look for information, such as home address and Social Security number that is not accurate. If you see anything you do not understand, call the credit reporting agency at the telephone number on the report.

For Colorado, Georgia, Maine, Maryland, Massachusetts, New Jersey, Puerto Rico, and Vermont residents: You may obtain one or more (depending on the state) additional copies of your credit report, free of charge. You must contact each of the credit reporting agencies directly to obtain such additional report(s).

Credit Freeze

You have the right to put a security freeze, also known as a credit freeze, on your credit file, so that no new credit can be opened in your name without the use of a Personal Identification Number (PIN) that is issued to you when you initiate a freeze. A credit freeze is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to access your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. Should you wish to place a credit freeze, please contact all three major consumer reporting agencies listed below.

You must separately place a credit freeze on your credit file at each credit reporting agency. The following information should be included when requesting a credit freeze:

- 1) Full name, with middle initial and any suffixes;
- 2) Social Security number;
- 3) Date of birth (month, day, and year);
- 4) Current address and previous addresses for the past five (5) years;
- 5) Proof of current address, such as a current utility bill or telephone bill; and
- 6) Other personal information as required by the applicable credit reporting agency.

If you request a credit freeze online or by phone, then the credit reporting agencies have one (1) business day after receiving your request to place a credit freeze on your credit file report. If you request a lift of the credit freeze online or by phone, then the credit reporting agency must lift the freeze within one (1) hour. If you request a credit freeze or lift of a credit freeze by mail, then the credit agency must place or lift the credit freeze no later than three (3) business days after getting your request.

Fraud Alerts

You also have the right to place an initial or extended fraud alert on your file at no cost. An initial fraud alert lasts 1-year and is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting 7 years. Should you wish to place a fraud alert, please contact any one of the agencies listed below. The agency you contact will then contact the other two credit agencies.

Monitor Your Personal Health Information

If applicable to your situation, we recommend that you regularly review the explanation of benefits statement that you receive from your insurer. If you see any service that you believe you did not receive, please contact your insurer at the number on the statement. If you do not receive the regular explanation of benefits statements, contact your provider and request them to send such statements following the provision of services in your name or number.

You may want to order copies of your credit reports and check for any medical bills that you do not recognize. If you find anything suspicious, call the credit reporting agency at the phone number on the report. Keep a copy of this notice for your records in case of future problems with your medical records. You may also want to request a copy of your medical records from your provider, to serve as a baseline. If you are a California resident, we suggest that you visit the website of the California Office of Privacy Protection at www.privacy.ca.gov to find more information about your medical privacy.

Reporting of identity theft and obtaining a police report.
