Discord uses a third-party service provider to assist with addressing certain user requests and operational issues. Discord learned on March 29, 2023, that an unauthorized person gained access to the account of an agent of the third-party service provider and used the access to obtain a list of the items on which the agent had worked (service tickets). Discord immediately took steps to address the incident. A thorough investigation was conducted. On June 13, 2023, Discord completed the review of the support tickets involved and determined that one or more of those support tickets contained the personal information of one Maine resident including the individual's name and driver's license or state identification card number.

On August 21, 2023, Discord mailed a notification letter via First Class mail to the Maine resident involved in accordance with Me. Rev. Stat. Tit. 10, §1348. A copy of the notification letter is attached. Discord is providing the Maine resident a complimentary, one-year membership to credit monitoring and identity theft protection services. Discord has also established a dedicated, toll-free call center that individuals can call to obtain more information regarding the incident.

To prevent something like this from happening again, Discord has worked with the third-party customer service firm to further enhance its security measures.

Discord Inc. understands the importance of protecting the personal information we maintain. We are writing to notify you of an incident that may have involved some of your information. This notice explains the incident, measures we have taken, and some steps you may consider taking in response.

We use a third-party customer service provider to assist with addressing certain user requests. Discord learned that an unauthorized person gained access to the account of an agent of that service provider on March 29, 2023, and accessed some of the agent's support tickets. We immediately took steps to address the incident, including deactivating the compromised account and working with the provider to improve its practices to help prevent similar incidents. A thorough investigation was conducted. On June 13, 2023, we completed the review of the support tickets involved and determined that one of those support tickets contained an image of your driver's license or state identification card.

We wanted to make you aware of this incident and assure you that we take it seriously. We are offering you credit monitoring and identity protection services through IDX, a ZeroFox company, at no cost to you. These services include <<variable text>> of credit and CyberScan monitoring, a \$1,000,000 insurance reimbursement policy, and fully managed identity theft recovery services. ENROLLMENT INSTRUCTIONS

1. Website and Enrollment. Call 1-800-939-4170 or go to <https://app.idx.us/account-creation/protect> and follow the instructions for enrollment using your Enrollment Code provided at the top of the letter.

2. Activate the credit monitoring provided as part of your IDX identity protection membership. The monitoring included in the membership must be activated to be effective. Note: You must have established credit and access to a computer and the internet to use this service. If you need assistance, IDX will be able to assist you.

If you discover any suspicious items and have enrolled in IDX identity protection, notify IDX immediately by calling or by logging into the IDX website and filing a request for help.

If you file a request for help or report suspicious activity, you will be contacted by a member of our ID Care team who will help you determine the cause of the suspicious items. In the unlikely event that you fall victim to identity theft as a consequence of this incident, you will be assigned an ID Care Specialist who will work on your behalf to identify, stop and reverse the damage quickly.

ADDITIONAL STEPS YOU CAN TAKE

We remind you it is always advisable to be vigilant for incidents of fraud or identity theft by reviewing your account statements and free credit reports for any unauthorized activity over the next twelve to twenty-four months. You may obtain a copy of your credit report, free of charge, once every 12 months from each of the three nationwide credit reporting companies. If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your state. You can obtain information from these sources about steps an individual can take to avoid identity theft as well as information about fraud alerts and security freezes. You should also contact your local law enforcement authorities and file a police report. Obtain a copy of the police report in case you are asked to provide copies to creditors to correct your records. Contact information for the Federal Trade Commission is as follows:

Fraud Alerts and Credit or Security Freezes:

Fraud Alerts: There are two types of general fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years.

To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report.

For those in the military who want to protect their credit while deployed, an Active-Duty Military Fraud Alert lasts for one year and can be renewed for the length of your deployment. The credit bureaus will also take you off their marketing lists for pre-screened credit card offers for two years, unless you ask them not to.

Credit or Security Freezes: You have the right to put a credit freeze, also known as a security freeze, on your credit file, free of charge, which makes it more difficult for identity thieves to open new accounts in your name. That's because most creditors need to see your credit report before they approve a new account. If they can't see your report, they may not extend the credit.

How do I place a freeze on my credit reports? There is no fee to place or lift a security freeze. Unlike a fraud alert, you must separately place a security freeze on your credit file at each credit reporting company. You'll need to supply your name, address, date of birth, Social Security number and other personal information.

After receiving your freeze request, each credit bureau will provide you with a unique PIN (personal identification

number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze.

How do I lift a freeze? A freeze remains in place until you ask the credit bureau to temporarily lift it or remove it altogether. If the request is made online or by phone, a credit bureau must lift a freeze within one hour. If the request is made by mail, then the bureau must lift the freeze no later than three business days after getting your request.

If you opt for a temporary lift because you are applying for credit or a job, and you can find out which credit bureau the business will contact for your file, you can save some time by lifting the freeze only at that particular credit bureau. Otherwise, you need to make the request with all three credit bureaus.
