Notice to Maine Residents

Builders Mutual completed its review of its records to locate additional address information for potentially impacted individuals so that they can be provided with notice. On December 28, 2023, Builders Mutual mailed notice to an additional twenty-one (21) Maine residents. As such, thirty-seven (37) total potentially impacted Maine residents have been provided with notice. The information that could have been subject to unauthorized access includes name, Social Security number, and driver’s license number. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit BB*.

Other Steps Taken and To Be Taken

In addition to the steps taken, which were more fully discussed in the September 29 Notice, Builders Mutual is providing access to credit monitoring services for twelve (12) months, through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

While the forensic investigation into this matter has been completed, Builders Mutual Insurance Company (“Builders Mutual”) is currently investigating the scope of the incident and the individuals affected. We will supplement this notice if any new significant facts are learned subsequent to its submission. By providing this notice, Builders Mutual does not waive any rights or defenses regarding the applicability of Maine law, the applicability of the Maine data event notification statute, or personal jurisdiction.

Nature of the Data Event

On December 14, 2022, Builders Mutual discovered suspicious activity on certain computer systems. Builders Mutual immediately launched an investigation with the assistance of third-party specialists. The investigation determined there was unauthorized access to its network beginning on December 14, 2022, and certain files were copied on December 15, 2022. Builders Mutual undertook a comprehensive review of the files to determine whether these files contained any sensitive information. On August 1, 2023, Builders Mutual discovered the names and the affected data elements for each potentially affected individual, including employees, former employees, and claimants.

Builders Mutual then undertook a comprehensive review of its’ files and sought out the assistance of third-party vendors to gather address information to provide individual notice to as many individuals as possible. On September 18, 2023, the first search was completed and Builders Mutual took steps to provide notice to these individuals and regulators.

The information that could have been subject to unauthorized access includes name, Social Security number, medical information, health insurance information, and workers’ compensation information.

Notice to Maine Residents

On September 29, 2023, Builders Mutual began providing written notice of this incident to fifteen (15) Maine residents. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

Other Steps Taken and To Be Taken

Upon discovering the event, Builders Mutual moved quickly to investigate and respond to the incident, assess the security of Builders Mutual systems, and identify potentially affected individuals. Further, Builders Mutual notified federal law enforcement regarding the event. Builders Mutual is also working to implement additional safeguards and training to its employees. Builders Mutual is providing access to credit monitoring services for twelve (12) months, through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, Builders Mutual is providing impacted individuals with guidance on how to better protect against identity theft and fraud. Builders Mutual is providing individuals with information on how to place a fraud alert and security freeze on one’s credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

Builders Mutual is providing written notice of this incident to relevant state regulators, as necessary, and to the three major credit reporting agencies, Equifax, Experian, and TransUnion.
