

## Appendix

On July 14, 2021, Eastern New Mexico University (“ENMU”) learned that a spreadsheet containing student information was accidentally accessible on its public-facing website. Upon learning of the incident, ENMU immediately removed the spreadsheet from its website and launched an investigation to determine what information was involved. The investigation determined that the spreadsheet was originally posted to a private portion of the ENMU website, but then became publicly-accessible in July 2016 during a website migration project. ENMU determined that the spreadsheet was downloaded by unauthorized parties, but was unable to determine the identity of the parties or how often this occurred. ENMU reviewed the spreadsheet and, on July 26, 2021, determined that the spreadsheet contained the name and Social Security number of two Maine residents.

Beginning today, September 16, 2021, ENMU is providing written notice via United States Postal Service First Class mail to the Maine residents whose personal information was contained in the spreadsheet.<sup>1</sup> ENMU is offering the Maine residents a complimentary, one-year membership to credit monitoring and identity theft protection services through Experian. ENMU is encouraging all affected individuals to remain vigilant to the possibility of fraud by reviewing their financial account statements and credit reports for unauthorized activity. ENMU has also established a dedicated, toll-free phone number where all individuals may obtain more information regarding the incident.

To help prevent something like this from happening again, ENMU has implemented additional safeguards and technical security measures.

At Eastern New Mexico University, we understand the importance of protecting the information we maintain. I am writing to inform you of an incident that involved some of your information. This notice explains the incident, measures we have taken, and some steps that you may consider taking.

On July 14, 2021, we learned that a spreadsheet containing your information was accidentally accessible on our public-facing website. Upon learning of the incident, we immediately removed the spreadsheet from our website and launched an investigation to determine what information was involved. The investigation determined that the spreadsheet was originally posted to a private portion of our website, but then became publicly-accessible in July 2016 during a website migration project. We determined that the spreadsheet was downloaded by unauthorized parties, but we were unable to determine the identity of the parties or how often this occurred. We reviewed the spreadsheet and, on July 26, 2021, determined that the spreadsheet contained your information, including your name, Social Security number, and information contained in your ENMU student education record, including but not limited to, student identification number, credit hour information, high school grades and college entrance test scores, and demographic information.

While we have no indication that your information has been misused, we wanted to notify you of this incident and assure you that we take it very seriously. As an added precaution, we are offering you a complimentary one-year membership with Experian's® IdentityWorks<sup>SM</sup>. This product helps detect possible misuse of your personal information and provides you with identity protection support. For more information on IdentityWorks<sup>SM</sup>, including instructions on how to activate your complimentary one-year membership, as well as some additional steps you can take, please see the additional information provided in this letter.

Your confidence and trust are important to us, and we regret any inconvenience or concern this incident may cause. We have implemented additional safeguards and technical security measures. ## ADDITIONAL STEPS YOU CAN TAKE

We remind you it is always advisable to be vigilant for incidents of fraud or identity theft by reviewing your account statements and free credit reports for any unauthorized activity. You may obtain a copy of your credit report, free of charge, once every 12 months from each of the three nationwide credit reporting companies. If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your state. You can obtain information from these sources about steps an individual can take to avoid identity theft as well as information about fraud alerts and security freezes. You should also contact your local law enforcement authorities and file a police report. ### **Fraud Alerts and Credit or Security Freezes:**

***Fraud Alerts:*** There are two types of general fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years.

To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report.

For those in the military who want to protect their credit while deployed, an Active Duty Military Fraud Alert lasts for one year and can be renewed for the length of your deployment. The credit bureaus will also take you off their marketing lists for pre-screened credit card offers for two years, unless you ask them not to.

***Credit or Security Freezes:*** You have the right to put a credit freeze, also known as a security freeze, on your credit file, free of charge, which makes it more difficult for identity thieves to open new accounts in your name. That's because most creditors need to see your credit report before they approve a new account. If they can't see your report, they may not extend the credit.

*How do I place a freeze on my credit reports?* There is no fee to place or lift a security freeze. Unlike a fraud alert, you must separately place a security freeze on your credit file at each credit reporting company. You'll need to supply your name, address, date of birth, Social Security number and other personal information.

After receiving your freeze request, each credit bureau will provide you with a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze.

*How do I lift a freeze?* A freeze remains in place until you ask the credit bureau to temporarily lift it or remove it altogether. If the request is made online or by phone, a credit bureau must lift a freeze within one hour. If the request is made by mail, then the bureau must lift the freeze no later than three business days after getting your request.

If you opt for a temporary lift because you are applying for credit or a job, and you can find out which credit bureau the business will contact for your file, you can save some time by lifting the freeze only at that particular credit bureau. Otherwise, you need to make the request with all three credit bureaus.

**Summary of Your Rights Under the Fair Credit Reporting Act:** The federal Fair Credit Reporting Act (FCRA) promotes the accuracy, fairness, and privacy of information in the files of consumer reporting agencies. There are many types of consumer reporting agencies, including credit bureaus and specialty agencies (such as agencies that sell information about check writing histories, medical records, and rental history records). Your major rights under the FCRA are summarized below. - You must be told if information in your file has been used against you.
- You have the right to know what is in your file.
- You have the right to ask for a credit score.
- You have the right to dispute incomplete or inaccurate information.
- Consumer reporting agencies must correct or delete inaccurate, incomplete, or unverifiable information.
- Consumer reporting agencies may not report outdated negative information.
- Access to your file is limited.
- You must give your consent for reports to be provided to employers.
- You may limit “prescreened” offers of credit and insurance you get based on information in your credit report.
- You have a right to place a “security freeze” on your credit report, which will prohibit a consumer reporting agency from releasing information in your credit report without your express authorization.
- You may seek damages from violators.
- Identity theft victims and active duty military personnel have additional rights.
