Re: Supplemental Notice of Data Event

Dear Sir or Madam:

Our office represents USA Waste-Management Resources, LLC (“WM”) located at 800 Capitol Street, Suite 3000, Houston, Texas 77002. We write to supplement a May 28, 2021 notice to your office concerning an incident that may affect the privacy of personal information related to certain Maine residents. A copy of our prior notice is attached as *Exhibit A*.

Since WM’s previous notice, WM¹ continued its review of the files that may have been subject to unauthorized access and determined on June 21, 2021 that an additional approximate thirteen (13) Maine residents were potentially impacted. Therefore, five hundred eleven (511) total Maine residents were potentially impacted. The information related to these additional residents includes name, Social Security number, financial account number, passport number and medical history/treatment information. On August 11, 2021, WM provided notice to these individuals in substantially the same form as the letter attached as *Exhibit B*. WM’s investigation is now complete and all individuals potentially impacted have been notified.

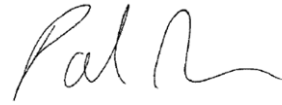

USA Waste-Management Resources, LLC located at 800 Capitol Street, Suite 3000, Houston, Texas 77002 is writing to notify your office of an incident that may affect the security of personal information related to Maine residents. The investigation of this matter is ongoing and this notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, WM¹ does not waive any rights or defenses regarding the applicability of Maine law, the applicability of the Maine data event notification statute, or personal jurisdiction.

Nature of the Data Event

On January 21, 2021, WM discovered suspicious activity on its network and immediately launched an investigation, with the assistance of third-party forensic specialists, to determine the nature and scope of the activity and contacted the FBI. The investigation determined that an unauthorized actor entered WM's environment between January 21 and 23, 2021, accessed certain files, and took a limited number of files. Therefore, WM conducted an extensive review process to analyze the contents of the files potentially accessed to determine what, if any, sensitive information was contained within them. On May 4, 2021 and in the weeks following, WM determined that the potentially compromised files contained the protected information of certain individuals. The information for Maine residents that could have been subject to unauthorized access includes name, Social Security number or National ID, date of birth and driver's license numbers. WM does not currently have evidence that the files containing personal information were actually taken by the unauthorized actor.

Notice to Maine Residents

On May 28, 2021, USA Waste-Management Resources, LLC began providing written notice of this incident to impacted individuals which includes four hundred ninety-eight (498) Maine residents. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

Other Steps Taken and To Be Taken

Upon discovering the event, WM moved quickly to investigate, assess the security of its systems, and notify impacted individuals. WM also worked to implement additional safeguards. WM is providing individuals whose personal information was potentially affected by this incident with access to one (1) year of credit monitoring services through Experian at no cost to the individuals.

WM also contacted a third-party, who assisted with identifying locations for the impacted individuals and who gathered relevant contact information into a consistent format for notification. This investigation was a time-consuming process, but WM believed it was necessary to ensure appropriate precautions and that next steps were taken.

Additionally, USA Waste-Management Resources, LLC is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank.

USA Waste-Management Resources, LLC is also providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud. Lastly, USA Waste-Management Resources, LLC is notifying regulators as required.

On May 4, 2021 and in the weeks following, we determined that the potentially accessed files contained sensitive information of certain individuals, including you. However, we do not currently have evidence that the files containing your personal information were actually taken by the unauthorized actor. Our investigation remains ongoing, but we wanted to notify you as soon as possible.

What Information Was Involved? We determined that the following information related to you may have been present in the files that were potentially accessed by the unauthorized actor: name, Social Security number or National ID, date of birth, and driver’s license number.

What We Are Doing. We take the confidentiality, privacy, and security of information in our care seriously. Upon discovery, we immediately commenced an investigation to confirm the nature and scope of the incident. While the investigation remains ongoing, we are taking steps now to implement additional safeguards and review policies and procedures relating to data privacy and security.

We are providing you with access to 12 months of credit monitoring and identity protection services through Experian at no cost to you. A description of services and instructions on how to enroll can be found within the enclosed Steps You Can Take to Protect Personal Information. Please note that you must complete the enrollment process yourself, as we are not permitted to enroll you in these services on your behalf.
