We are writing on behalf of our client, Ultralife Corporation, to notify your office concerning a data security incident.

Ultralife recently concluded an investigation of a data security incident which impacted the availability and functionality of its computer network. Upon discovering the incident, Ultralife immediately took measures to help secure its network, engaged cybersecurity advisors to assist in Ultralife's efforts, and began an investigation. Through Ultralife's investigation, it determined that on or about January 25, 2023, an unauthorized actor may have accessed and acquired certain files contained on its network. Ultralife conducted a thorough review of the involved files and on March 2, 2023, identified one or more file(s) containing the personal information of two Maine residents including individuals' names and Social Security numbers.

Beginning on March 24, 2023, Ultralife mailed notification letters to the Maine residents via First Class mail. A sample of the notification is enclosed. Ultralife is offering the individuals a complimentary membership to credit monitoring and identity theft protection services through Equifax. Ultralife has also established a dedicated, toll-free call center that individuals can call to obtain more information regarding the incident.

To reduce the risk of a similar incident from occurring in the future, Ultralife has implemented additional measures to enhance the security of its network and continues to provide data security training to its employees.

We are writing to let you know of a data security incident that likely involved some of your personal information. As you would expect, Ultralife Corporation recognizes the importance of protecting the personal information we maintain, and this notice explains the incident, measures we have taken, and some additional steps you may consider taking in response.

We recently concluded an investigation of a data security incident which impacted the availability and functionality of our computer network. Upon discovering the incident, our Information Security Committee swiftly convened, and as a Company, we immediately took measures to help secure our network, engaged professional and experienced external cybersecurity advisors to assist in our efforts, and began an investigation. Through our investigation, we determined that an unauthorized actor may have accessed and acquired certain files contained on our network at our Newark, N.Y. and Virginia Beach locations. We conducted a thorough review of those files and on March 2, 2023 identified one or more file(s) containing your name, <<Breached Elements>> as well as, in some cases, other demographic information.

As an added precaution beyond our efforts at the corporate level, we have secured the services of Equifax to offer individuals a complimentary membership to Equifax Complete™ Premier which includes credit monitoring and fraud protection. Enrolling in this program will not hurt your credit score. For more information on Equifax Complete™ Premier, including instructions on how to activate your complimentary membership, as well as some additional steps you can take in response to this incident, please see the pages that follow this letter.

We sincerely regret any inconvenience or concern this may cause you. To help prevent a similar incident from occurring in the future, we have implemented additional measures to enhance the security of our network and continue to provide data security training to our employees. We remind you it is always advisable to be vigilant for incidents of fraud or identity theft by reviewing your account statements and free credit reports for any unauthorized activity. You may obtain a copy of your credit report, free of charge, once every 12 months from each of the three nationwide credit reporting companies. If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your state. You can obtain information from these sources about steps an individual can take to avoid identity theft as well as information about fraud alerts and security freezes. You should also contact your local law enforcement authorities and file a police report. Fraud Alerts and Credit or Security Freezes:

Fraud Alerts: There are two types of general fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years.

To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report.

For those in the military who want to protect their credit while deployed, an Active Duty Military Fraud Alert lasts for one year and can be renewed for the length of your deployment. The credit bureaus will also take you off their marketing lists for pre-screened credit card offers for two years, unless you ask them not to.

Credit or Security Freezes: You have the right to put a credit freeze, also known as a security freeze, on your credit file, free of charge, which makes it more difficult for identity thieves to open new accounts in your name. That's because most creditors need to see your credit report before they approve a new account. If they can't see your report, they may not extend the credit.

How do I place a freeze on my credit reports? There is no fee to place or lift a security freeze. Unlike a fraud alert, you must separately place a security freeze on your credit file at each credit reporting company. You'll need to supply your name, address, date of birth, Social Security number and other personal information.

After receiving your freeze request, each credit bureau will provide you with a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze.

How do I lift a freeze? A freeze remains in place until you ask the credit bureau to temporarily lift it or remove it altogether. If the request is made online or by phone, a credit bureau must lift a freeze within one hour. If the request is made by mail, then the bureau must lift the freeze no later than three business days after getting your request.

If you opt for a temporary lift because you are applying for credit or a job, and you can find out which credit bureau the business will contact for your file, you can save some time by lifting the freeze only at that particular credit bureau. Otherwise, you need to make the request with all three credit bureaus.
