RE: NOTICE OF DATA BREACH

Mulkey Cardiology Consultants at Holy Name Medical Center PC values and respects the privacy of your information, which is why we are writing to advise you of a recent incident that may have involved some of your personal information.

**What Happened?** On September 5, 2023, we discovered that an unknown, unauthorized third party encrypted some of our files. Upon learning of the incident, we promptly contained the incident and rebuilt our systems from backups. We also notified law enforcement and worked with a forensic security firm to investigate and confirm the security of our computer systems. The forensic investigation recently concluded and determined that an unknown third party accessed our systems from September 1, 2023, through September 5, 2023 and acquired certain files from our systems during that time.

**What Information Was Involved?** On September 14, 2023, we learned that the acquired files contained some individuals' personal information. The files could have contained your name, address, date of birth, Social Security number, driver's license number or state ID, medical treatment information, and health insurance information, to the extent that the information was contained in our records.

**What We Are Doing.** In addition to the actions described above, we have taken steps to reduce the risk of this type of incident occurring in the future, including enhancing our technical security measures. Although we are not aware of any instances of fraud or identity theft involving your information, we are also offering a complimentary one-year membership of Experian IdentityWorks<sup>SM</sup> Credit 3B. This product helps detect possible misuse of your personal information and provides you with identity protection services focused on prompt identification and resolution of identity theft. IdentityWorks<sup>SM</sup> Credit 3B is completely free to you, and enrolling in this program will not hurt your credit score. **For more information on identity theft prevention and IdentityWorks<sup>SM</sup> Credit 3B, including instructions on how to activate your complimentary one-year membership, please see the additional information provided in this letter.**

**Fraud Alerts:** You may want to consider placing a fraud alert on your credit report. A fraud alert is free and will stay on your credit report for one (1) year. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any new accounts in your name. **Credit and Security Freezes:** You may have the right to place a credit freeze, also known as a security freeze, on your credit file, so that no new credit can be opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A credit freeze is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to get access to your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. Unlike a fraud alert, you must separately place a credit freeze on your credit file at each credit reporting company.
