We represent Big M Transportation, Inc. (“Big M”) located at 6341 Highway 15, Suite B, Blue Mountain, MS 38610, and are writing to notify your office of an incident that may affect the security of certain personal information relating to three (3) Maine residents. This notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, Big M does not waive any rights or defenses regarding the applicability of Maine law, the applicability of the Maine data event notification statute, or personal jurisdiction.

Nature of the Data Event

On March 18, 2022, Big M experienced a data security incident that impacted their computer systems and caused a temporary disruption to certain operations. Big M immediately responded and launched an investigation with outside experts to confirm the nature and scope of the incident and restore impacted computer systems to operability. Through the investigation, Big M learned that an unauthorized actor accessed their systems and may have viewed or acquired business data. On March 23, 2022, Big M learned that information related to certain individuals was included in the potentially impacted data set. Big M then undertook efforts to locate address information for the affected individuals, put resources in place to assist, and provide this direct notice. The information that could have been subject to unauthorized access includes name, and Social Security number.

Notice to Maine Residents

On or about June 1, 2022, Big M provided written notice of this incident to three (3) Maine residents. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

Other Steps Taken and To Be Taken

Upon discovering the event, Big M moved quickly to investigate and respond to the incident, assess the security of Big M systems, and identify potentially affected individuals. Further, Big M notified law enforcement regarding the event. Big M is also working to implement additional safeguards and training to its employees. Big M is providing access to credit monitoring services for one (1) year, through Experian IdentityWorks, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, Big M is providing impacted individuals with guidance on how to better protect against identity theft and fraud. Big M is providing individuals with information on how to place a fraud alert and security freeze on one’s credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

Dear Sample A. Sample:

Big M Transportation, Inc. (“Big M”) writes to make you aware of a recent incident that may impact the privacy of some of your information. We are providing you with notice of the incident, steps we have taken in response, and resources available to help you better protect your information, should you feel it is appropriate to do so. We are providing this notice out of an abundance of caution.

What Happened? On March 18, 2022, we experienced a data security incident that impacted our computer systems and caused a temporary disruption to certain operations. We immediately responded and launched an investigation with outside experts to confirm the nature and scope of the incident and restore impacted computer systems to operability. Through the investigation, we learned that an unauthorized actor accessed our systems and may have viewed or acquired business data. On March 23, 2022, we learned that information related to you was included in the potentially impacted data set. We undertook efforts to locate address information for the affected individuals, put resources in place to assist, and provide this direct notice.

What Information Was Involved? The information present in the files that may have been viewed or acquired as a result of this incident included your name, and Social Security number. We have received no indication that any personal information has been used to commit identify theft or fraud.

What We Are Doing. We treat our responsibility to safeguard the information entrusted to us as an utmost priority. As such, we responded immediately to this incident and have been working diligently to provide you with an accurate and complete notice of the incident. Our immediate response to this event also included prompt correspondence with federal law enforcement authorities. As part of our ongoing commitment to the privacy and security of information in our care, we have reviewed our existing policies and procedures relating to data protection and security and implemented enhanced security. We will continue to evaluate additional security measures to mitigate any potential risk associated with this incident and to better prevent similar incidents in the future.

As an added precaution, we are providing you with [Extra2] months of complimentary access to credit monitoring and identity restoration services through Experian, as well as guidance on how to better protect your information. Although we are covering the cost of these services, due to privacy restrictions, you will need to complete the activation process yourself using the enrollment instructions included within the enclosure to this letter.



Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order your free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a credit freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.

You may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act.
