On December 2, 2021, WellDyne became aware of suspicious activity related to a WellDyne email account. In response, WellDyne began an investigation of the activity with the assistance of third-party forensic investigators to determine the nature and scope of the incident. WellDyne determined that there was unauthorized access to the account between October 30, 2021, and November 17, 2021. Although there is no evidence that individually-identifiable information contained within the email account was accessed or taken by an unauthorized party, WellDyne could not rule out this possibility. In response, WellDyne undertook a comprehensive and time-consuming programmatic and manual review of the contents of the email account to determine the type of information stored therein, and to whom the information pertained. On March 11, 2022, WellDyne completed this extensive review process, and identified the scope of the information at risk and the population potentially impacted. WellDyne worked diligently since this time to confirm the contact information for the individuals who may be impacted and the types of information at issue for each individual, as well as to identify and notify applicable data-owner entities. WellDyne began providing notice of this incident on May 6, 2022, to the potentially impacted individuals for whom WellDyne was determined to be the data owner with respect to the impacted information. Since this time, WellDyne continued working to match the potentially impacted individuals back to its covered entity clients in order to make the appropriate notifications.

The information that may have been affected by this event includes the following: name, date of birth, Social Security number, driver’s license number, treatment information, health insurance information, contact information, prescription information, and other medical/health information.

At this time, WellDyne does not anticipate further notifications will be provided to any additional Maine residents.

Upon discovering the event, WellDyne moved quickly to investigate and respond to the incident, assess the security of its email tenant, and notify potentially affected individuals. WellDyne is also working to implement additional security to its network. WellDyne is providing access to credit monitoring services for one (1) year through Equifax, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, WellDyne is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. WellDyne is a third-party pharmacy benefit management company, and we received your information in connection with the services we provide to you, or to one of your benefit providers. We want to provide you with information about the incident, our response, and steps you may take to better protect against possible misuse of your personal information, should you feel it necessary to do so.

What Happened? On December 2, 2021, we became aware of suspicious activity related to a WellDyne email account. In response, we began an investigation of the activity with the assistance of third-party forensic investigators to determine the nature and scope of the incident. We determined that there was unauthorized access to the account between October 30, 2021, and November 17, 2021. Although there is no evidence that individually-identifiable information contained within the email account was accessed or taken by an unauthorized party, we cannot rule out this possibility. In response, WellDyne undertook a comprehensive and time-consuming programmatic and manual review of the contents of the email account to determine the type of information stored therein, and to whom the information pertained. On March 11, 2022, we completed this extensive review process, and identified that information pertaining to you was present in the accessed email account at the time of unauthorized access. While we are unaware of any actual or attempted misuse of your information as a result of this incident, we take the security of data we hold very seriously and are notifying you out of an abundance of caution.

What Information Was Involved? The investigation determined that your name, <<Breached Elements>> may have been affected by this event.

What We Are Doing. The confidentiality, privacy, and security of personal information within our care is among our highest priorities. Upon learning of the event, we secured the compromised account and investigated to identify any individuals that were affected. We have taken additional steps to improve security and better protect against similar incidents in the future. We are also notifying applicable regulators, including the Department of Health and Human Services.

Although we are unaware of any actual or attempted misuse of your personal information as a result of this event, out of an abundance of caution, we are offering you access to complimentary credit monitoring and identity theft protection services for <<CM Length>> months through Equifax. Monitor Your Accounts

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);

5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
