The Department will soon be contacting the Scarborough School Department to negotiate a contract. As provided in the RFA, the Notice of Conditional Contract Award is subject to execution of a written contract and, as a result, this Notice does NOT constitute the formation of a contract between the Department and the apparent successful applicant. The applicant shall not acquire any legal or equitable rights relative to the contract services until a contract containing terms and conditions acceptable to the Department is executed. The Scarborough School Department submitted a proposal requesting \$176,000 to establish a public Pre-K partnership classroom. The Sanford School Department's application was the only application received for RFA # 202405099. The scoring team met and reviewed the application against the established criteria. The scoring team determined that the application meets the established criteria for a fundable proposal.

The scoring team did recommend the following items be addressed during contract negotiations:

- A number of instructional programs are noted as part of the curriculum. Clarification is needed about which of these programs will be used.
- The program is noted to be 5 hours each day. Is wrap around care available through Shooting Starts if families pay for it?
- Clarification is sought about whether there will be 2 teachers staffing the classroom or 1 teacher and 1 Education Technician.
- Information was provided regarding the desire to mirror school system demographics in the selection of students. Clarification is sought about how the lottery system will work to achieve this.
- Student age at enrollment needs to be corrected from 2023 to 2024.
- Assurance about the use of Teaching Strategies Gold as part of the ongoing assessment process is needed.
- The proposed program evaluation is a good starting point. More technical assistance on this section may be helpful.
- Opportunities for professional development could be enhanced to make connections with the school system's kindergarten teachers or other pre-k teachers in the area.
- Clarification is sought about how the funding will flow to the partner.
