Award Justification Statement RFP# 202403077 Lawn Care Services for Regional Training Institute (RTI), Bangor, ME & Armed Forces Reserve Center (AFRC), Bangor, ME

I. Summary

The Department of Defense, Veterans and Emergency Management put out a Request for Proposals for Lawn Care Services for the Regional Training Institute (RTI) and Armed Forces Reserve Center (AFRC) in Bangor, ME. The proposal details the Department's lawn care needs for these two facilities.

II. Evaluation Process

The evaluation team met to discuss the proposals submitted for the RFP. Three proposals were received and reviewed by the team. The team was looking for submissions that showed they had familiarized themselves with scope and described how they would meet the scope of the RFP. There was a mandatory walk thru at the facilities and all of the vendors participated in the walk thru. All of the team members work in the maintenance section and are familiar with both facilities and any special areas of concern for the lawns at the facilities.

III. Qualifications & Experience

The vendors who submitted had been in the lawn care business for various lengths of time. They were all familiar with doing lawn care and the references provided showed that they had worked on projects similar to what was listed in the RFP. The team also looked at the organizational charts provided. The team also made note of any equipment listed in the proposal that would be used in completing tasks in the RFP. The team wanted to ensure that the firm chosen would have the necessary equipment and made note if the firm listed a mechanic on staff that would be able to repair the equipment. None of the firms listed subcontractors.

Proposed Services

The team looked at how the vendors planned on meeting the requirements of the RFP. The number of people they proposed having maintain the lawns, the equipment that the vendor listed and the schedule that the vendor provided in order to ensure our lawns look their best. The team took note of any mentions of the height of the lawn since that is a concern for us, picking up trash before mowing, references to the filter beds on the property were noted, reference to the track and the need to take special


care not to damage the track while moving equipment across the track were noted, etc.

IV. Cost Proposal

The cost proposals were scored as noted int the RFP proposal. The awarded bidder was the lowest bid. Our costs ranged from \$290,000 to \$102,000.

V. Conclusion

Each proposal was reviewed by the team separately. The team members took the time to point out any strengths and weaknesses in the proposals. The team reviewed the references provided by each vendor and noted services that were similar to what was requested in the RFP. Once each proposal was reviewed the team then went through each proposal and assigned their scores. JP's Seasonal Service received the highest total score for all sections with a total of 70 points. The team feels that they have the equipment needed to do the job, we feel that they understand what we are asking for and they provided a good description of how they plan on accomplishing the tasks listed in the RFP.
