This email is to notify you that the Office of Marijuana Policy, in addition to revoking Collin Popper's

caregiver Registry Identification Card (Collin Popper, CGR26382), as noted in the attached Notice of Revocation dated March 1, 2022, is also revoking Mr. Popper's registered caregiver assistant (employee) Registry Identification Card: Collin Popper CGE13176. The justifications and factual bases for revoking Mr. Popper's registered caregiver employee card are the same as stated in the attached Notice of Revocation. The revocation of Mr. Popper's registered caregiver employee Registry Identification Card is effective three (3) calendar days after the date of this notice.

The Department does not expect Mr. Popper to make another request for an informal hearing, and presumes he appeals this revocation. The Department requests the informal hearing for the revocation of Mr. Popper's registered caregiver employee Registry Identification Card be joined with the currently pending hearing set for April 11, 2022 at 10:30. We are ready to discuss this further at the pre-hearing conference set for this Thursday, March 17, at 8:30.
