Dear Mr. Draper:

The appellants/abutters request permission to supplement the record in the above referenced #L-28397-4E-A-N matter relating to a permit originally granted on March 13, 2020 issued to Jeffry Spinney of Alna.<sup>1</sup> The permit was later revised on June 2, 2020.

The events since closing of the record May 12, 2020 have been multiple and complex, and materially affect the original permit and the appellants' appeal of April 6, 2020. To understand the nature of the project proposed and the issues raised on appeal by the appellants, the Board needs to have information related to statements, activities and decisions that have taken place since the appeal was filed. We request permission to include testimony setting forth a chronology summarizing these subsequent statements, activities and decisions and documents related to those statements, activities, and decisions. Pursuant to appeal procedures (06-096, 24D), this information "could not, by the exercise of reasonable diligence, have been discovered in time to be presented earlier in the licensing process."<sup>2</sup>

This testimony and documents will show that Mr. Spinney described and advocated to DEP one project, a permanent geotextile and rock motorboat launch for use by his recently formed sportsmen's club of 25+ members, while describing and advocating to the Town of Alna a different project, a temporary boat ramp supported by "earthwork" for personal residential use. A permit for the DEP-approved ramp was denied by the town's planning board, the decision upheld by its board of appeals, and that ramp installed December 27.

Specifically, the documents we propose to add to the record relate to:

- 1. The Alna Board of Appeals' affirmation of the denials by the Alna Planning Board of the project for which Mr. Spinney received the March 2020 DEP permit.
- Multiple statements and legally binding documents regarding the existence and nature of the Golden Ridge Sportsmen's Club (GRSC) and the actual – as opposed to proposed – "shared" use of the project, which differs from the statements Mr. Spinney made to the DEP and which were relied upon by the DEP in issuing its permit.
- 3. The nature of the project subsequently orally approved December 10, 2020 by the Alna Planning Board, whether that project is a permanent structure as reflected in the DEP permit or temporary structure as reflected in the Alna permit and whether that latter project requires a new or modified DEP permit.

## 1. Chronology of Events regarding the DEP Permit granted March 13, 2020

6/18/19	Beginning discussions between applicant and DEP regarding the application.
8/20/10	DEP/NRPA application field.
3/13/20	DEP permit issued.
4/6/20	Abutters appeal DEP permit to BEP
5/12/20	Closing date for submission of evidence. Applicant's attorney's rebuttal of abutters. New Golden Ridge Sportsman's Club (GRSC) bylaws and land-use license.
5/29/20 6/18/29	Alna Planning Board (PB) public hearing on local permit application for project approved by DEP's 3/13/20 permit.
6/2/20	Applicant received revised permit from DEP.
6/10/20	Alna Town Attorney determines that the GRSC is "a couple of buddies."
6/23/20 6/29/20	Alna PB deliberations on Spinney proposal; application denied.
6/29/20	Applicant attempts to surrender approval of the dock from the DEP permit.
7/3/20	Applicant requests reconsideration of 6/29/20 Alna PB denial.
7/7/20	Applicant submits new application to Alna PB for roadwork above the HAT line.
7/27/20	Applicant withdraws 7/7/20 permit application for roadwork above the HAT line.
7/27/20	After reconsideration, Alna PB affirms application denial of 6/29/20.

8/11/20	Applicant requests 60-day continuance of BEP appeal to work out with the DEP the possibility of a temporary ramp surface in place of the permanent one approved. Appellants do not object to continuance.
8/20/20	Applicant appeals PB decisions of $6/29/20$ and $7/27/20$ to the Alna Board of Appeals (BOA).
10/12/20	Applicant requests a second 60-day continuance pending action by the Alna BOA on his appeal of $8/20/20$ . Appellants do not object.
10/16/20	Alna BOA upholds PB $6/29/20$ and $7/27/20$ decisions rejecting application for project approved by the DEP permit of $3/13/20$ (formally voted $10/23/20$ ).
10/23/20	Alna SB appoints three new members of the PB, two of them alternates.
10/26/20	Applicant applies to Alna PB for a temporary roll-out mat and supporting earthwork.
12/10/20	Alna PB orally approves the $10/26/20$ permit for earthwork and mat, conditional upon DEP and other approvals.
12/16/20	Town, applicant, and abutters begin mediation to forestall applicant's appeal to Superior Court of $10/16/20$ Alna BOA judgment.
12/17/20	Without legal authority, Alna CEO issues applicant a permit for the project approved orally and on conditions by the PB $12/10/20$ .
12/27/20	Applicant constructs the stone on geotextile fabric boat launch described in the March 13, 2020 DEP permit, a project different from that approved by the PB December 10 (cobble and gravel on existing substrate below excavations, without geotextile fabric).

12/28/20	Alna PB issues written approval for $10/26/20$ project (later rescinded and reissued $1/5/21$ ).

1/5/21	Alna PB issues formal findings of fact and written approval, with conditions, for the temporary rollout mat and ramp.
