I am writing to express my concern over the construction of a proposed concrete boat launch and large dock/ramp/float that would be built in Alna on the Sheepscot River.
My husband and I, long time year round Alna residents, own riverfront property north of the proposed site. We have a conservation easement with Midcoast Conservancy and have supported its predecessor organization to protect and preserve the Sheepscot. Because of our location we would not be as impacted as others closer to the site.
Alna's zoning ordinances have thus far prohibited permanent structures from being built by the river and the shoreline has been protected with set back limits for construction. The gains from this strategy can be seen in the river as it exists today, largely unspoiled and free from development. The stewardship of Midcoast Conservancy along with effective regulation has allowed everyone to enjoy the rare distinction given to the Sheepscot as a wild and scenic river.
Traditional uses of boating, canoeing, kayaking, swimming, and fishing were and are, currently enjoyed in such a way that the character and health of the river has been kept intact. That <i>character</i> is a feature which has attracted residents and visitors -whether they use the river or not. That character can't be quantified, and yet – scenic, historic, full of plan animal and marine life, it affects us all.
Building a dock is of course reasonable, but I feel in this location the scale of the project and proposed construction methods would forever change the river and possibly jeopardize what decades of stewardship have earned for us all.
