I am writing to voice my opposition to the application by Jeff Spinney of 126 Golden Ridge Road, Alna, ME, for a "Permanent Boat Launch and Separate Dock/Ramp/Float with Permanent Support Piling" on the Sheepscot River.

I am a landowner and river abutter in North Newcastle at what is commonly known as "The Bend". My property is also under a conservation easement with the Midcoast Conservancy (formerly the SVCA, "Sheepscot Valley Conservation Association"). To date this portion of the river has not seen major boating traffic since pre-colonial and colonial times. It is pristine and home to a variety of protected or endangered plant and animal species. There are a variety of existing locations on this section of the river - the section from Sheepscot Village to Head Tide - that support launching of human-powered watercraft. Such boats do little to no harm to the river and adjacent surroundings; they are also more suited to the generally shallow nature of the river in this region. Powered craft of any sort will pose risks due to inevitable fuel and emissions leaks, high-velocity travel around delicate plant and marine life, and introduce excessive noise in the area.
