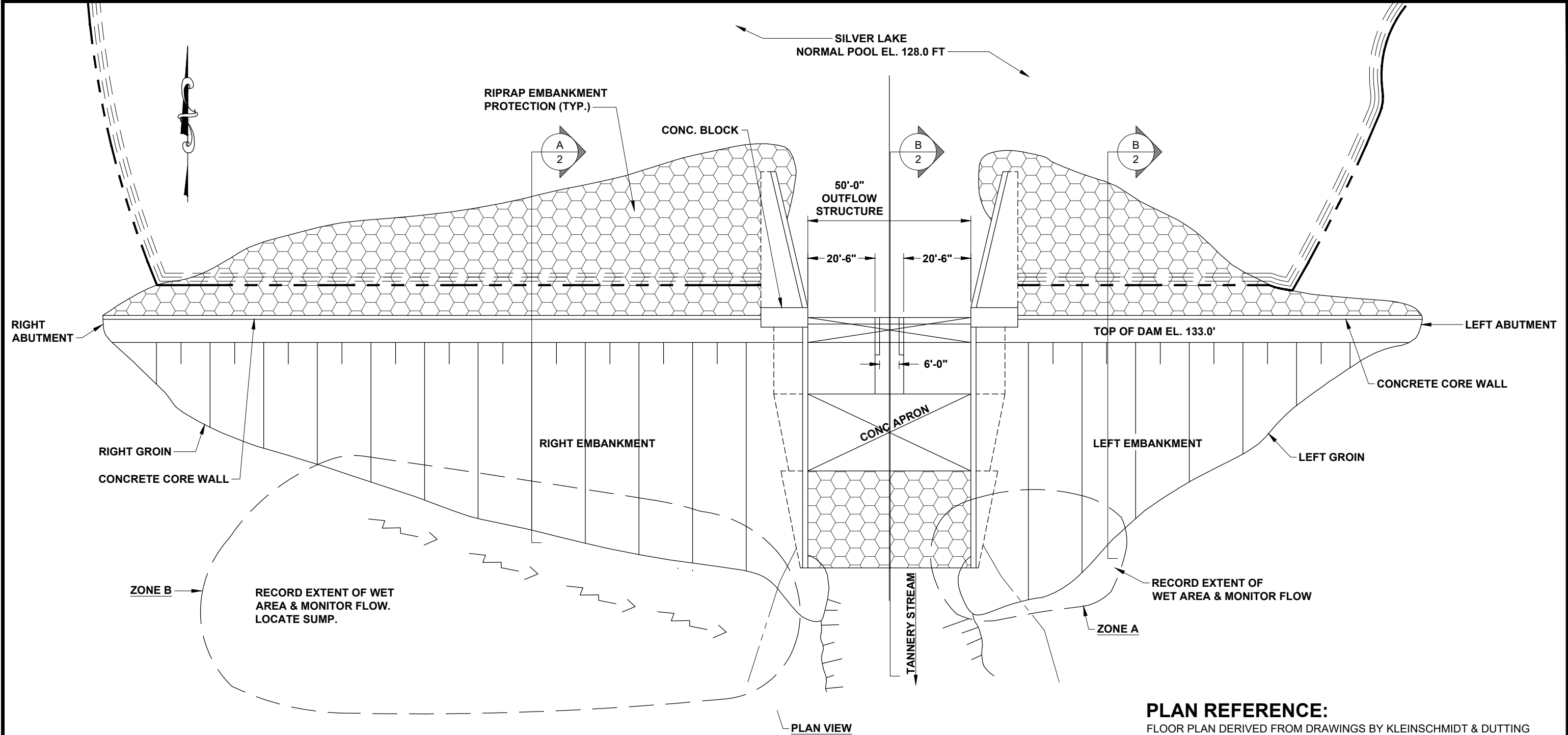

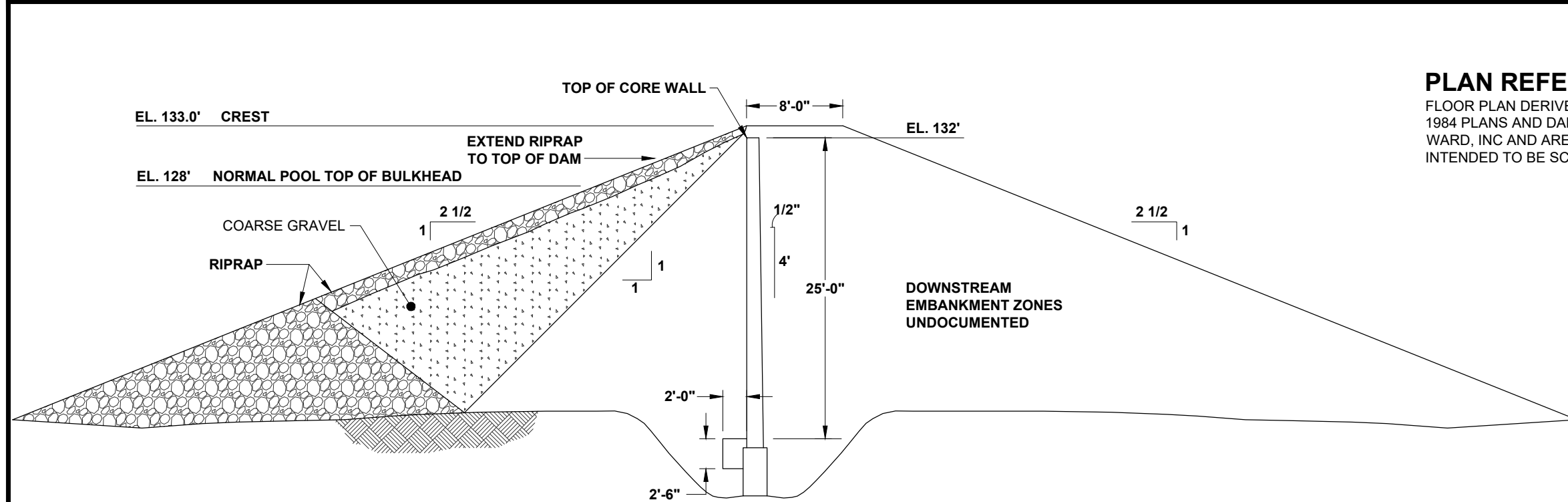

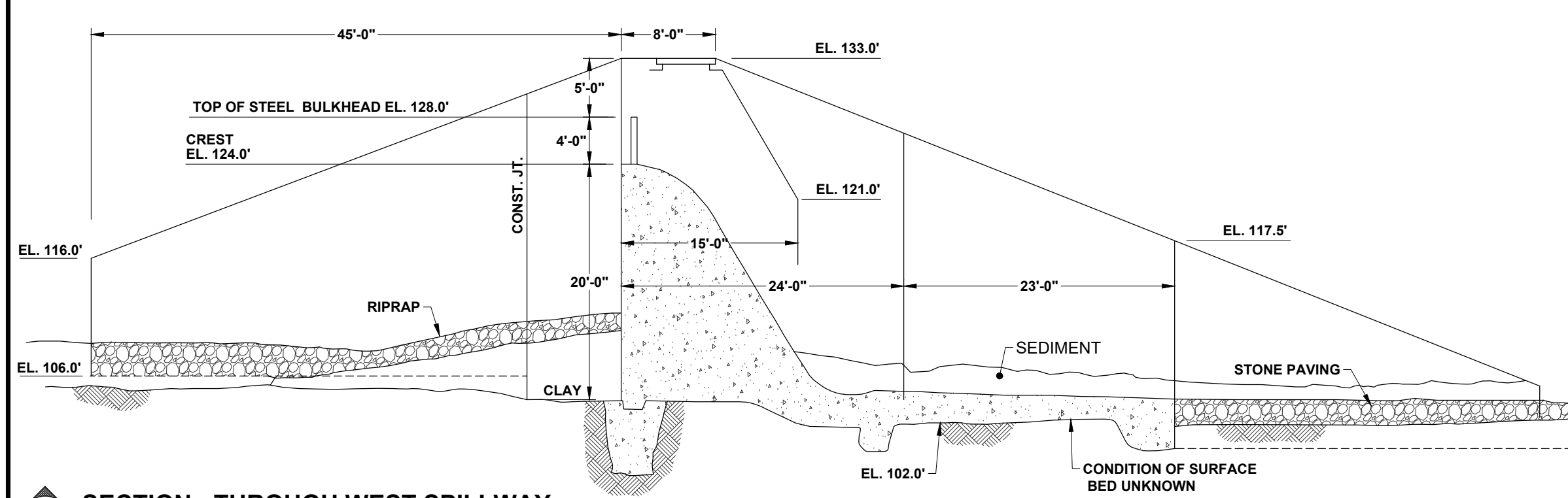

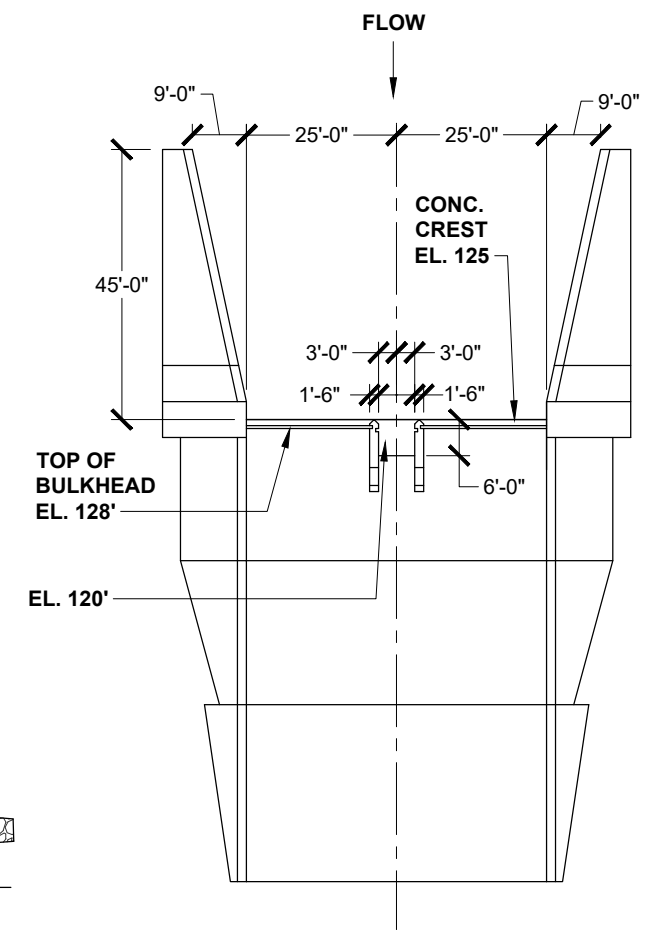

DESCRIPTION OF DAMS AND OPERATIONS

Provide a description of the physical condition of the dam and how the dam has been operated over the past five or more years.

A. Alamoosook Lake

Alamoosook Lake dam is a 93-year-old, 18-foot-high, significant hazard, concrete mass gravity structure, located in the Town of Orland, Hancock County Maine. The dam is part of the old Champion Lake Water System. The right abutment fishway, pumphouse & gate structure are accessed from Soper Road. The left abutment is accessed from Carrier Road through forest. There is no walkway across the dam. The dam's gate structure is fenced, gated and locked. Alamoosook Lake is primarily recreational.

(Credit – Hazard and Condition Report dated October 12, 2021)

Since acquisition by Bucksport Mill LLC in January of 2015, Alamoosook Lake has been operated by personnel originally employed by Verso Paper and subsequently by Bucksport Mill LLC or its then affiliated company, Bucksport Generation LLC. In November of 2019, ownership of the power plant (Bucksport Generation LLC) was sold. At the time of the sale, Bucksport Mill LLC entered into an agreement with Bucksport Generation LLC to continue to operate the water system. That agreement remains in place as of today. The system has continued to be operated in accordance with policies and procedures originally developed by the previous owner, Verso Paper Company.

Bucksport Generation LLC personnel, operating on behalf of Bucksport Mill LLC and pursuant to the aforementioned agreement, monitors the water level maintenance requirements at Alamoosook Lake. The Alamoosook dam gate is operated by personnel to maintain lake water level to prescribed guidelines outlined in the operations and maintenance manual. Dam and lake maintenance needs are reported as identified to Bucksport Mill LLC who reviews, approves and funds any necessary maintenance. Bucksport Mill LLC and operating personnel work collaboratively with 3rd party contractors to accomplish required maintenance and repairs.

B. Silver Lake

Silver Lake dam is a 30-foot-high, 450-foot-long, high hazard, composite mass gravity/earth dam, located on Tannery Brook, upstream of downtown Bucksport. The dam was designed by the New England Public Services Company for St. Regis Paper Co., to supply water to its paper mill as well as to the Town of Bucksport. It was built in 1930 and extensively rehabilitated in 1984, 54 years after construction. The dam is 93 years old.

(Credit – Hazard and Condition Report dated October 12, 2021)

Silver Lake is the primary impoundment servicing the Bucksport Mill site including the Maine Maritimes Academy building and Bucksport Generation power plant as well as the municipal water supply for the Town of Bucksport. There are no other end users of water supplied by Silver Lake.

Since acquisition by Bucksport Mill LLC in January of 2015, Silver Lake has been operated by personnel originally employed by Verso Paper and subsequently by Bucksport Mill LLC or its then affiliated company, Bucksport Generation LLC. In November of 2019, ownership of the power plant (Bucksport Generation LLC) was sold. At the time of the sale, Bucksport Mill LLC

entered into an agreement with Bucksport Generation LLC to continue to operate the water system. That agreement remains in place as of today. The system has continued to be operated in accordance with policies and procedures originally developed by the previous owner, Verso Paper Company.

Bucksport Generation LLC personnel, operating on behalf of Bucksport Mill LLC and pursuant to the aforementioned agreement, monitors the water level maintenance requirements at Silver Lake. Dam and lake maintenance needs are reported as identified to Bucksport Mill LLC who reviews, approves and funds any necessary maintenance. Bucksport Mill LLC and operating personnel work collaboratively with 3rd party contractors to accomplish required maintenance and repairs.

C. Toddy Pond

Toddy Pond Dam is a 102-year-old, significant hazard dam, located in the Town of Orland, Hancock County, Maine. The dam is 14-foot-high, 196-foot-long, composite mass gravity/earth dam structure fitted with a concrete fishway. The dam was built in 1921 as a mill dam to store water to supply downstream mills along the downstream Marramissic River. After the mills were closed, the dam continued to supply Alamoosook Lake, from which water was pumped across the watershed into Silver Lake for use by the Town of Bucksport. Since closure of the Bucksport paper mill, the lake is used primarily for recreation. The dam's last major repair was in 1947. The dam raises Toddy Pond, a glacial lake, by about 8' – storing a substantial volume of water.

(Credit – Hazard and Condition Report dated October 12, 2021)

Since acquisition by Bucksport Mill LLC in January of 2015, Toddy Pond has been operated by personnel originally employed by Verso Paper and subsequently by Bucksport Mill LLC or its then affiliated company, Bucksport Generation LLC. In November of 2019, ownership of the power plant (Bucksport Generation LLC) was sold. At the time of the sale, Bucksport Mill LLC entered into an agreement with Bucksport Generation LLC to continue to operate the water system. That agreement remains in place as of today. The system has continued to be operated in accordance with policies and procedures originally developed by the previous owner, Verso Paper Company.

Bucksport Generation LLC personnel, operating on behalf of Bucksport Mill LLC and pursuant to the aforementioned agreement, monitors the water level maintenance requirements at Toddy Pond. The Toddy Pond dam gate is operated by personnel to maintain lake water level to prescribed guidelines outlined in the operations and maintenance manual. Dam and pond maintenance needs are reported as identified to Bucksport Mill LLC who reviews, approves and funds any necessary maintenance. Bucksport Mill LLC and operating personnel work collaboratively with 3rd party contractors to accomplish required maintenance and repairs.

CONSULTATION

Please note that Petitioner has notified via certified mail local, regional and statewide private organizations whose interests may be affected by each dam. Those organizations who have been notified via certified mail are Atlantic Salmon Federation, Great Pond Mountain Conservation Trust, Frenchman Bay Conservancy, Trout Unlimited, Conservation Law Foundation and Natural Resources Council of Maine. A copy of the certified mail receipts, which includes these organizations as well as those required to receive certified mailings pursuant to Application 7.C, has been included at the end of this Petition as an Attachment to the Public Notice.

Please note that the Petitioner has also sent notice to all abutting property owners via US first class mail pursuant to 38 MRS Section 901.3, and, pursuant to 38 MRS Section 902.4-A, will file a report confirming all consultation details in compliance with Sections 902.1 and 902.3 in the coming weeks.

Please take notice that AIM Demolition USA LLC of PO BOX 1874, Bucksport, ME 04416 and Bucksport Mill, LLC of 30 Generation Lane, Bucksport, ME 04416 are intending to file a petition with the Maine Department of Environmental Protection for release from dam ownership or water level maintenance under the provisions of Title 38, Maine Revised Statutes Annotated, Sections 901 to 908.

This petition pertains to the dams impounding:

- A. Alamoosook Lake, located at 31 Soper Road in the town of Orland in Hancock County;
- B. Silver Lake, located off Central Street in the town of Bucksport in Hancock County; and
- C. Toddy Pond, located off Toddy Dam Road (identified as Tax Map 039, Lot 2) in the town of Orland in Hancock County.

The petition will be filed on or around July 12, 2024 and will be available for public inspection at the DEP's offices in Augusta during normal working hours.

In the event that a new owner is not found for the dam, the DEP will issue an order requiring the dam owner to release the water from the dam.

A dam owner is not prohibited from requesting compensation for the transfer of the dam to a new owner. However, the DEP will not issue a water release order to a dam owner who has refused to transfer the dam to a person willing to assume ownership because that person refused to compensate the dam owner for the property.
