

## SECTION 25 NOTICES

The Applicant has provided all necessary public notices to abutting property owners, the local municipality office, and to a newspaper, which is circulated in the area where the Project is located.

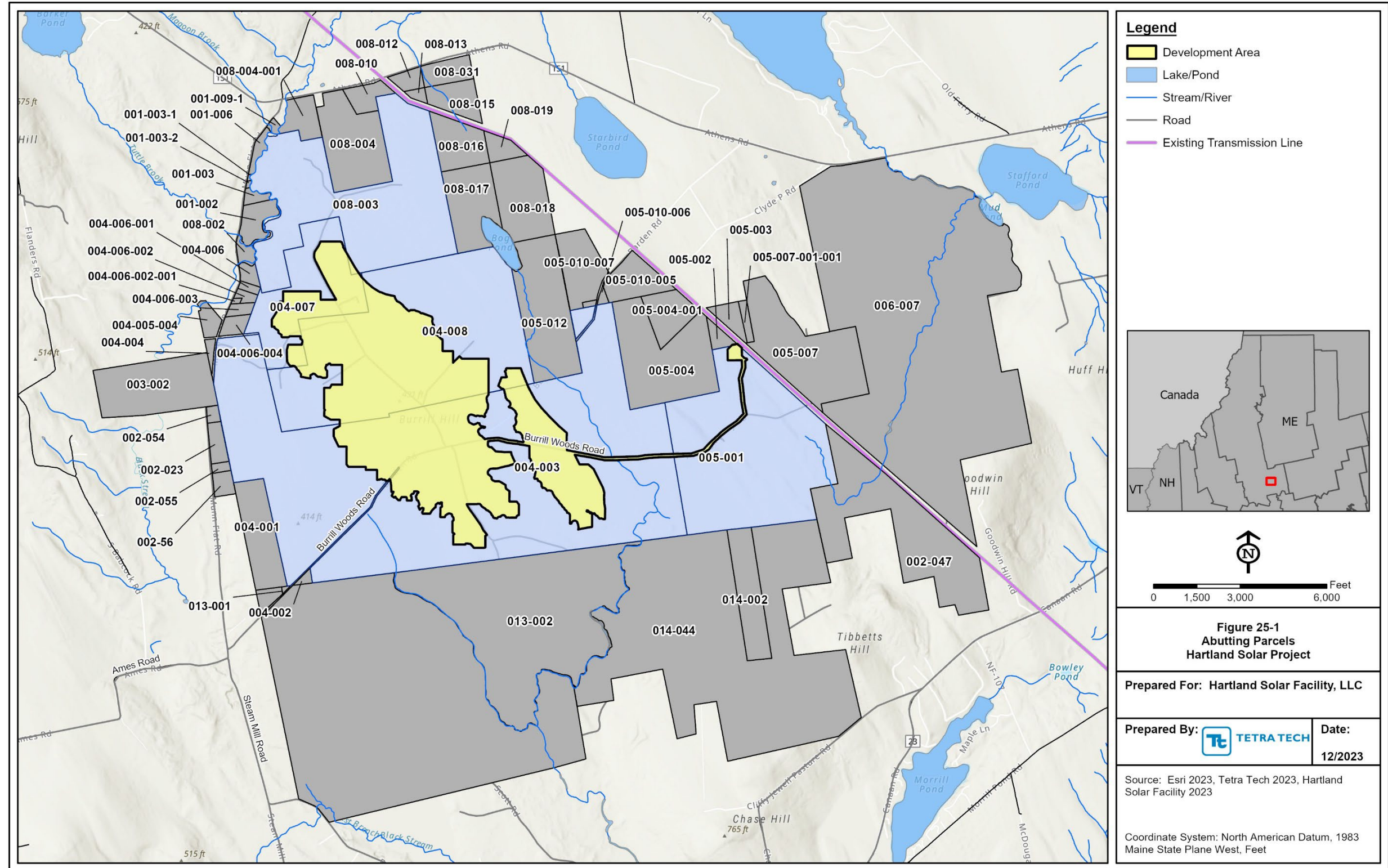


Figure 25-1 Abutting Parcels.

On November 3, 2023, a Public Informational Meeting (PIM) notice (Exhibit 25-1) was sent to all abutting property owners and the Town of Hartland (local municipality, Town). A list of the abutting property owners is provided in Table 25-1 and the relative location of each abutting parcel is depicted in Figure 25-1. United States Postal Service Certified Mail Receipts are provided in Exhibit 25-2. The public notice also was published in the *Morning Sentinel* newspaper that is distributed in the area where the Project is located on November 4, 2023 (Exhibit 25-3), and provided to the Town, to be posted on the community bulletin board available in the Town office and on the Town's website.

A PIM was held on November 16, 2023, in accordance with MDEP rules (06-096 CMR 2). Twenty-five members of the public, Town of Hartland, or State agencies attended the public meeting. The Applicant presented information summarizing the Project civil design and location, the avoidance and minimization of environmental impacts, permits that will be obtained prior to Project construction, permitting and construction schedule and the MDEP public participation and the MDEP public participation process as described in the MDEP fact sheet. The meeting sign-in sheet and certification form (Form C) are provided in Exhibit 25-4.

On January 22, 2024, a Notice of Intent to file (Exhibit 25-5) was sent to abutters and to the local municipality. United States Postal Service Certified Mail Receipts are provided in Exhibit 25-6. A public Notice of Intent to file was circulated in the *Morning Sentinel* newspaper, on January 23, 2024 (Exhibit 25-7). A copy of the Notice of Intent to file also was provided to the Town to be posted on the community bulletin board available at the Town Office and on the Town's website.

In addition to the required notices described above, the Applicant and/or its representatives met with the Hartland selectmen with members of the public in attendance on the following dates:

- June 6, 2022,

- July 17, 2023

The purpose of these meetings was to inform the selectmen and Hartland residents of the possibility of a solar project in their town, and to commit to transparency and information sharing throughout the feasibility and site exploration phase. As the project progressed, the Applicant and/or its representatives provided updates at selectmen's meetings and responded to questions and suggestions. A PowerPoint presentation was made on August 2, 2021, and again on July 17, 2023, followed by questions and answers.

On October 5, 2023, Teichos Energy hosted an Open House meeting. Notice of the meeting was mailed to the project abutters and all residents and P.O. box holders in Hartland. The first half of the two-hour forum consisted of a poster session with subject matter experts followed by a PowerPoint presentation and Q&A session.

You are receiving this letter because your property abuts a proposed solar project in the town of Hartland, Maine. This letter is to notify you that Hartland Solar Facility, LLC (the Applicant), a wholly owned subsidiary of Teichos Energy, plans to file a Site Location of Development Act permit application and a Natural Resources Protection Act permit application with the Maine Department of Environmental Protection, pursuant to the provisions outlined in Maine Revised Statutes (M.R.S.) Title 38, §§ 481-490, and Title 38 M.R.S. §§ 480-A – 480-BB.

The application is to allow for construction and operation of the Hartland Solar Project in the Town of Hartland, in Somerset County, Maine. The proposed project will consist of solar arrays capable of generating up to 140 megawatts of alternating electric current. The project also includes the following infrastructure among the solar arrays: new access ways; a 34.5-kV electrical collector; a collector substation adjacent to Burrill Woods Road; a 2.5 mile 115-kV transmission line and new interconnection substation located adjacent to the existing Central Maine Power, Section 82 transmission line.

**The Applicant will hold a Public Informational Meeting with further details about the Project.**

You are receiving this letter because your property abuts a proposed solar project in the Town of Hartland, Maine. This letter is to notify you that Hartland Solar Facility, LLC (the Applicant), a wholly owned subsidiary of Teichos Energy, plans to file a Site Location of Development Act permit application, Natural Resources Protection Act permit application, and Solar Decommissioning application with the Maine Department of Environmental Protection, pursuant to the provisions outlined in Maine Revised Statutes (M.R.S.) Title 38, §§ 481-490, Title 38 M.R.S. §§ 480-A – 480-BB, and Title 35-A § 3494.

The application is to allow for construction and operation of the Hartland Solar Project in the Town of Hartland, in Somerset County, Maine. The proposed project will consist of solar arrays capable of generating up to 140 megawatts of alternating electric current. The project also includes the following infrastructure among the solar arrays: new access ways; a 34.5-kV electrical collector; a collector substation adjacent to Burrill Woods Road; a 2.5 mile 115-kV transmission line and new interconnection substation located adjacent to the existing Central Maine Power, Section 82 transmission line.

A request for a public hearing or a request that the Board of Environmental Protection assume jurisdiction over this application must be received by the Department in writing, no later than 20 days after the application is found by the Department to be complete and is accepted for processing. A public hearing may or may not be held at the discretion of the Commissioner or Board of Environmental Protection. Public comment on the application will be accepted throughout the processing of the application.

The application will be filed for public inspection at the Department of Environmental Protection's office in Bangor during normal working hours. A copy of the application may also be seen at the municipal offices in Hartland, Maine. Written public comments may be sent to the regional office in Bangor where the application is filed for public inspection: MDEP, Eastern Maine Regional Office, 106 Hogan Road, Bangor, Maine 04401.
