the receipt whereof I do hereby acknowledge, do hereby give, grant,
bargain, sell and convey, unto the said

Its Successors, Heirs and Assigns forever,

A certain lot or parcel of land in the town of Greene, Androscoggin
County, Maine, lying between the new State Road and the old dis-
continued County Road, said land fronting on said new State Road
