

KNOW ALL MEN BY THESE PRESENTS

That CENTRAL SERVICES CORPORATION, a corporation duly organized and existing under and by virtue of the laws of the State of Maine and having its office and principal place of business at Augusta, in the County of Kennebec, said State, acting in pursuance of a vote passed by its stockholders at a meeting duly called and held, in consideration of One Dollar and other valuable consideration paid by CENTRAL MAINE POWER COMPANY, a corporation duly organized and existing under and by virtue of the laws of the State of Maine and having its office and principal place of business at said Augusta, the receipt whereof is hereby acknowledged, does hereby GIVE, GRANT, BARGAIN, SELL and CONVEY unto the said Central Maine Power Company, its successors and assigns forever, all its plants, property, rights, privileges, locations, permits and franchises (except its franchise to be a corporation), including all tangible property, real estate, rights of way, water power rights, flowage and riparian rights and also all dam sites, privileges, franchises, contracts, machinery, generators, poles, wires, transmission towers, fixtures, supplies, apparatus, appliances, rights and credits, and all other property, real, personal and mixed, of whatever kind and wherever situated and all

appurtenances thereof now held and owned by said Central Securities Corporation.

Without limiting or restricting in any way the generality of the foregoing grant, there is also included in this conveyance, and the grantor does hereby give, grant, bargain, sell and convey unto the said grantee, its successors and assigns, all real estate and rights and interests in real estate, including all water rights, flowage and riparian rights, all easements and other rights of way, as were conveyed to this grantor by the following instruments dated and recorded as in each case indicated, to which deeds reference may be had for a more particular description of the property hereby conveyed:
