## KNOW ALL MEN BY THESE PRESENTS,

A strip of land 200 feet in width extending from land now or formerly of Chauncey D. Turner southerly to land now or formerly of Eva W. Callahan. Said strip being bounded northerly by said Turner lot at the Sheepscot River; easterly by a line parallel with and 75 feet easterly of the survey line now staked out across this lot, the Turner lot and the Callahan lot; westorly by a line parallel with and 125 feet westerly of the survey line above described.
