The sidelines of said 270-foot strip of land being 85 feet distant easterly and 185 feet distant westerly measured at right angles from the Grantee's survey base line, and its projection at both ends, as now staked across the parcel here in conveyed for the purpose of establishing a center line for the proposed construction of the Grantee's 345 KV transmission line extending from Wiscasset to Orrington and presently designated as Section 392.
