Section 25. Notices

25.1 State Standards

Pursuant to the State's Chapter 2, Applicant was required to host a Public Informational Meeting prior to submitting its application. In addition, Applicant was required to provide notice to abutters, via certified mail and published in a newspaper with local circulation, prior to the PIM and the application filing.

25.2 Narrative

Throughout the development process, the Applicant has conducted direct and indirect outreach to residents in Rumford and Roxbury. This has included coordinating with both Towns to connect with specific residents who live in vicinity to the Project and presentations at public meetings in Rumford.

The Applicant has presented in public session of the Town of Rumford's Planning Board on August 4, 2021, and December 7, 2022. The Applicant anticipates attending a public meeting in the Town of Roxbury on December 5, 2023 and in the Town of Rumford on December 6, 2023. A public hearing hosted by the Town of Rumford's Planning Board is expected within 60 days of such board deeming the Applicant's application complete.

25.3 Public Informational Meeting

The Applicant hosted a Public Informational Meeting ("PIM") on October 26, 2023, in the Town of Rumford. The PIM was held at 6 PM at the Town Hall. Notice for the PIM was sent via certified mail to 42 abutters and other interested parties as well as published in the Rumford Falls Times on October 18, 2023.

The list of recipients of the certified mailing is Exhibit 25-1.¹ The receipts from the certified mail are also included in Exhibit 25-1.

¹ Notice was sent to the host towns, abutters (as defined by the Department), and to residents that had previously connected with the development team.



A copy of the notice sent via mail to the recipients listed in Exhibit 25-1 is included in Exhibit 25-2. In addition, a screenshot of the posting from the Rumford Falls Times is included in Exhibit 25.2.

At the PIM, the Project team, including Steve Thompson from Viewshed, were available to members of the public. The Applicant presented on the history of the Project, the studies conducted, the permitting process, and described the displays available that evening. Large format displays were available depicting flicker, sound, and viewshed analysis, wetland and watercourse delineations, and civil plans. Two members of the public attended the meeting, along with the Town of Rumford's Economic Development Director.

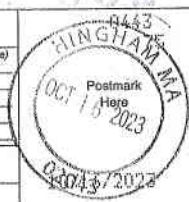

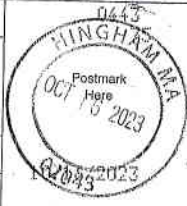
