- IX. Draft of Best practices guide FYI: <u>Commercial Fishing Industry Vessels Best Practice Safety Practices Guide.pdf</u> (uscg.mil) (April 2024 version, draft)
 - A. Safety practices to reinforce include.
 - 1. Section II. Lifesaving equipment: recovery equipment, reboarding ladder, PLB
 - 2. Section III. Communication Equipment: PLB, GPS-enabled EPIRB, Mayday placard
 - 3. Section IV. Deck Safety Equipment: Slip-reduction materials, PFD worn, PLB, hazard guards, hard hat when under overhead equipment
 - 4. Section V. Fire Safety: insulation not saturated with oil, proper storage and ventilation of flammables, smoke detectors in regularly manned spaces and in accommodation spaces, CO detectors in accommodation spaces adjacent to engines and exhaust stacks.
 - 5. Section VI: Machinery and Electrical Safety: exhaust systems free of leaks, requirements for wiring, cabling, and hard-wired permanent electrical equipment.
 - 6. Section VII: Material Condition: weathertight/watertight closures, shut-off valves for through-hull fittings, surveys by a qualified marine surveyor at least every three years or as required by insurance underwriter.
 - 7. Section VIII: Flooding Prevention: damage control kit, portable dewatering pump (conditions apply), policy re watertight/weathertight closures maintenance/integrity, pre-departure check.
 - 8. Section IX: Periodic Testing of Equipment and Systems: alarms, generators, pumps, and detectors.
