 Describe the type and amount of aquaculture to be conducted during the new lease term:

The lease will continue as it has with both surface and bottom culture year round.

Bottom culture consists of 400,000-650,000 oysters harvested per year

Surface culture consists of nursery culture of 1,500,000 oysters per year

2. Describe the amount of aquaculture conducted on the lease site during the previous lease term, including but not limited to seeding, cultivation or harvest of organisms:

Bottom culture consists of planting 1-1.5 million oysters per year. This in turn harvests 450,000-650,000 oysters harvested per year

Surface culture consists of growing oysters on the surface nursery for 1-2 years. The maximum number grown in this phase was 1,500,000.

3. Suspended culture gear can attract birds that roost on the gear and defecate, potentially creating a pollution source impacting shellfish held within gear. 
Suspended gear has physical deterents built into the gear (Cable ties)
