

## Notice of Agency Rule-making Proposal

CHAPTER NUMBER AND TITLE: Chapter 26 Sea Urchin 2022-2023 Season

PROPOSED RULE NUMBER (*leave blank; to be assigned by Secretary of State*):

**BRIEF SUMMARY:** This regulation would establish open harvest days and tote limits for the taking of sea urchins by divers, rakers, trappers, and draggers in Zones 1 and 2 for the 2022-2023 season. For Zone 1, seasons are proposed for divers, trappers, rakers and draggers in 2022-2023, from which harvesters may only fish up to 15 days of their choosing, the same number of days allowed during the 2021-2022 season. For Zone 1, the daily tote limit is nine (9), the same as in the 2021-2022 season. For Zone 2, 40-day seasons are proposed for divers, trappers, rakers and draggers in 2022-2023, from which harvesters may only fish up to 30 days of their choosing. This proposal has the same number of fishing days and opportunity days as the 2021-2022 season. For the Whiting & Dennys Bays Limited Access Area in Zone 2, a 15-day season is proposed for Zone 2 divers, trappers, rakers and draggers in 2022-2023. For Zone 2, the daily tote limit is six (6), the same as in the 2021-2022 season.

The Blue Hill Bay Limited Access Area designation sunset on April 1, 2022 and that language has been removed from the regulation.

**26.07 Sea Urchin Harvesting Season 2022-2023 ~~2021-2022~~ pursuant to 12 M.R.S. §6749.**

Harvesters may choose 15 of the available days in Zone 1 and 30 of the potential 40 available days in Zone 2.

1. Zone 1 [as defined by 12 M.R.S. §6749-N(1)]. Harvesters may choose 15 of the available fishing days.

- A. Early season for divers, trappers and rakers

The Zone 1 season for divers, trappers and rakers who have certified the early season on forms provided by the Commissioner, is open Mondays, Tuesdays, Wednesdays, Thursdays and Fridays in September and October, 2022 ~~2021~~. Divers, trappers, and rakers may fish no more than 15 of these days.

- B. Late season for divers, trappers and rakers

The Zone 1 season for divers, trappers and rakers who have certified the late season on forms provided by the Commissioner, is open Mondays, Tuesdays, Wednesdays, Thursdays and Fridays in December, 2022 ~~2021~~; and January and February 2023 ~~2022~~. Divers, trappers, and rakers may fish no more than 15 of these days.

- C. Season for draggers [in accordance with 12 M.R.S. §6749-V]

The Zone 1 season for draggers is open Mondays, Tuesdays, Wednesdays, Thursdays and Fridays in December, 2022 ~~2020~~; and January and February 2023 ~~2021~~; ~~except Friday, December 25, 2020 and Friday, January 1, 2021 which shall be closed.~~ Draggers may fish no more than 15 of these days.

2. Zone 2 [as defined by 12 M.R.S. §6749-N(2)]. Harvesters may choose 30 of the potential 40 days.

- A. Early season for divers, trappers and rakers

The Zone 2 season for divers, trappers and rakers who have certified the early season on forms provided by the Commissioner, is open September 27 and 28, 2022; Tuesdays, Wednesdays and Thursdays in October, 2022; November 1, 2, 3, 8, 9, 10, 15, 16, 17, 21, 22, 23 and 30, 2022; and, December 1, 6, 7, 8, 12, 13, 14, 15, 19, 20, 21, 27 and 28, 2022. ~~21, 22, 23, 28, and 29, 2021; and, October 5, 6, 7, 12, 13, 14, 19, 20, 21, 26, 27, and 28, 2021; and, November 2, 3, 4, 9, 10, 11, 16, 17, 18, 22, 23, and 24, 2021; and, December 1, 2, 7, 8, 14, 15, 16, 21, 22, 28, and 29, 2021~~ Divers, trappers, and rakers may fish no more than 30 of these days.

B. Late season for divers, trappers and rakers

The Zone 2 season for divers, trappers and rakers who have certified the late season on forms provided by the Commissioner, is open Tuesdays, Wednesdays and Thursdays in December 2022, except for December 1, 2022 which shall be closed; Tuesdays, Wednesdays and Thursdays in January 2023 and February 2023, except February 21, 22 and 23, 2023 which shall be closed; and March 1, 2, 7, 8, 14 and 15, 2023. ~~December 7, 8, 9, 14, 15, 16, 21, 22, 23, 28, 29, and 30, 2021; and January 4, 5, 6, 11, 12, 13, 18, 19, 20, 25, and 26, 2022; and February 1, 2, 3, 8, 9, 10, 15, 16, 22, 23 and 24, 2022; and March 1, 2, 8, 9, 15 and 16, 2022.~~ Divers, trappers, and rakers may fish no more than 30 of these days.

C. Early season for draggers

The Zone 2 season for draggers who have certified the early season on forms provided by the Commissioner, is open Tuesdays, Wednesdays, and Thursdays in October ~~2022~~ ~~2021~~; ~~and~~ November 2, 3, 8, 9, 10, 16, 17, 22, 23, 29, 30, 2022; Thursdays and Fridays in December 2022 and also Wednesday, December 21, 2022; and January 5, 6, 12, 13, 19, and 20, 2023. ~~3, 4, 9, 10, 11, 17, 18, 22, 23, 24, and 30, 2021; and December 2, 7, 8, 9, 15, 16, 21, 22, 23, 29, and 30, 2021; and January 5, 6, 12, 13, 19, and 20, 2022.~~ Draggers may fish no more than 30 of these days.

D. Late season for draggers

The Zone 2 season for draggers who have certified the late season on forms provided by the Commissioner, is open November 30, 2022; Wednesdays, ~~and~~ Thursdays and Fridays in December 2022 ~~2021~~; Wednesdays, ~~and~~ Thursdays and Fridays in January and February 2023; and, January 24, 2023. ~~, 2022 and on Tuesday January 25, 2022; and Wednesdays and Thursdays in February 2022 and on Tuesday February 15 and Tuesday February 22, 2022; and on Tuesdays, Wednesdays and Thursdays in March 2022 except for March 24, 29, 30 and 31, 2022.~~ Draggers may fish no more than 30 of these days.

## 26.19 Limited Access Areas

### Transiting exception:

Any vessel possessing urchins onboard, may transit the Limited Access Area, only if the vessel has all fishing gear (dredges, drags, regulators, buoyancy compensators, fins, tanks, weight belts) securely stowed. Securely stowed shall mean the main wire shall not be shackled or connected to the dredges or drags, and the towing swivel will be at the block or on the winch for draggers, while

regulators, buoyancy compensators and tanks should be disconnected with fins and weight belts removed for divers.

1. Whiting and Denny's Bay Area (Zone 2). Harvesters may choose up to 15 days of the following applicable season open days for the Whiting and Denny's Bay limited access area to fish within their 30 days available for harvest.

- A. Early season for divers, trappers and rakers

It shall be unlawful to fish for, take, or possess urchins west of a line starting at the western end of Mahar Point, Pembroke, due south to the nearest point of land on Crow Neck, Trescott, to include all of Whiting and Denny's Bay except by divers, trappers, and rakers who have certified the early season on forms provided by the Commissioner, on September 27 and 28, 2022 ~~28 and 29, 2021~~; Wednesdays in October and November 2022; October 18 and 25, 2022; and December 7 and 14, 2022. ~~December 2022; and October 6, 13, 19, 20, 26, and 27, 2021; and Wednesdays in November 2021; and Wednesdays in December 2021 except for December 22 and 29, 2021.~~

- B. Late season for divers, trappers and rakers

It shall be unlawful to fish for, take, or possess urchins west of a line starting at the western end of Mahar Point, Pembroke, due south to the nearest point of land on Crow Neck, Trescott, to include all of Whiting and Denny's Bay except by divers, trappers and rakers who have certified the late season on forms provided by the Commissioner on Tuesdays ~~Wednesdays~~ in December 2022 ~~2021~~, ~~except for December 1, 2021~~; and Tuesdays ~~Wednesdays~~ in January and February 2023 ~~2022~~, except Tuesday, February 21, 2023, which shall be closed; ~~and~~ Wednesday, February 15, 2023 and March 7, and 14, 2023. ~~2, 9, and 16, 2022.~~

- C. Early season for draggers

It shall be unlawful to fish for, take, or possess urchins west of a line starting at the western end of Mahar Point, Pembroke, due south to the nearest point of land on Crow Neck, Trescott, to include all of Whiting and Denny's Bay except by draggers who have certified the early season on forms provided by the Commissioner, on Thursdays in October, November and December 2022 ~~2021~~, except November 24, 2022 ~~25~~, which shall be closed; and January 5, 12, and 19, 2023. ~~6, 13 and 20, 2022.~~

- D. Late season for draggers

(+) It shall be unlawful to fish for, take, or possess urchins west of a line starting at the western end of Mahar Point, Pembroke, due south to the nearest point of land on Crow Neck, Trescott, to include all of Whiting and Denny's Bay except by draggers who have certified the late season on forms provided by the Commissioner, on Thursdays in December, 2022 ~~2021~~ ~~except for December 2, 2021~~; and Thursdays in January, and

February ~~2023~~ 2022; and January 4, 2023 and February 1, 2023. ~~March 3, and 10, and 17, 2022.~~

- (2) ~~Blue Hill Bay Area (Zone 2). Harvesters may fish in the Blue Hill Bay limited access area only in accordance with the following provision:~~

~~It shall be unlawful to fish for, take, or possess urchins in Blue Hill Bay, north of a line starting at southernmost tip of Lopaus Point to the northern most point of Black Island; continuing from the westernmost tip of Black Island to the northern most tip of Swans Island Head; continuing to the most southeastern point of Naskeag Point, Brooklin except by draggers, divers, trappers, and rakers who possess aboard their fishing boat, a Global Positioning System (GPS) tracking unit provided by the Department. The spatial tracker must be turned on and continuously recording data for the entire duration of each season, chosen by the harvester. This limited access area will sunset April 1, 2022.~~

CHAPTER NUMBER AND RULE: Chapter 26 Sea Urchin 2022-2023 Season

STATUTORY AUTHORITY: 12 MRS §6749

PRINCIPAL REASON(S) OR PURPOSE FOR PROPOSING THIS RULE: [*see* §8057-A(1)(A)&(C)]

This regulation would establish open harvest days and tote limits for the taking of sea urchins by divers, rakers, trappers, and draggers in Zones 1 and 2 for the 2022-2023 season. For Zone 1, seasons are proposed for divers, trappers, rakers and draggers in 2022-2023, from which harvesters may only fish up to 15 days of their choosing, the same number of days allowed during the 2021-2022 season. For Zone 1, the daily tote limit is nine (9), the same as in the 2021-2022 season. For Zone 2, 40-day seasons are proposed for divers, trappers, rakers and draggers in 2022-2023, from which harvesters may only fish up to 30 days of their choosing. This proposal has the same number of fishing days and opportunity days as the 2021-2022 season. For the Whiting & Dennys Bays Limited Access Area in Zone 2, a 15-day season is proposed for Zone 2 divers, trappers, rakers and draggers in 2022-2023. For Zone 2, the daily tote limit is six (6), the same as in the 2021-2022 season.

The Blue Hill Bay Limited Access Area designation sunset on April 1, 2022 and that language has been removed from the regulation.
