

NARRATIVE FOR DEPUTY GREGORY PEALATERE

On 10/25/2023, at approximately 1857 hours, I Deputy Greg Pealatere was on duty in the Poland area and requested to respond to 24 Mollison Way in Lewiston for a report of a active shooter at the location. ASO dispatch advised the business is Spare Time bowling facility and serious injuries have been reported. I responded to the location with emergency lights and siren and upon arrival I parked my patrol vehicle in front of fire and ambulance vehicle's. I exited my patrol vehicle with my patrol rifle and prepared to advance towards the facility.

At approximately 1919 hours, I overheard on ASO radio frequency that a second active shooter incident was now taking place at 545 Lincoln Street in Lewiston and that all ASO patrol units need to respond to that location. The Lincoln Street location was identified as Schmengees Bar and Grill Restaurant.

I responded to the Lincoln Street location and stopped on the roadway just east of the Restaurant. Various fire and police vehicles and already arrived prior to my arrival. I exited my patrol vehicle and met up with Deputy Joseph Tripp of which we tactically worked are way along a steel fence line towards the parking lot of Schmengees Restaurant.

At this point various Maine State Police and Lewiston

Police Officer were on scene

maintained parking lot security at this time.

At approximately 2012 hours, ASO dispatch advised they have another report of an active shooter at the Walmart Distribution Center in Lewiston which is approximately 1 mile east of Schmengees of Lincoln Street. MSP units at Schmengees advised if anyone has a patrol vehicle to leave and respond to the Walmart Distribution Center.

I ran back to my patrol vehicle and a unknown Lewiston PD officer wearing range clothing jumped in my patrol vehicle with myself and we responded to the location. ASO dispatch advised to enter through the truck loading area as well.

Upon arrival, large box trailers blocked some of the entrance which kept responded units from driving all the way up to the building. Upon exit of my patrol vehicle, ASO dispatch first advised a active shooter was inside the structure, then updated with two subject outside were only brandishing a weapon and all the employees had locked themselves into the dry storage area.

Other responding unit made entry through the main entrance of the Walmart facility and were able to escort the occupants out safely.

ASO patrol unit were advised by dispatch to respond back to Lewiston Police Department so assignments could made. I responded back to LPD and was advised by ASO Major Mark Cornelio to patrol the area and remain central until additional information develops.

After a period of time, ASO dispatch advised the shooting suspect is a Robert Card who is operating white 2013

Subaru Outback

At approximately 2157 hours, ASO dispatch the suspect vehicle was located in Lisbon near a boat launch. Multiple LEO units responded to Lisbon and located the involved vehicle which was parked just off Route 196. I responded to the Lisbon area from Center Street in Auburn and stopped on Route 196 to assist ASO Cpl. Williams with traffic control.

After a short period of time, I cleared the area which ended my involvement. My Watch Guard video recording was saved in the system under this report case number.

On 10/25/2023 at approximately 1856 hours, I was investigating a crash in the area of 383 College Rd in Greene. Detective Mejia was also on scene. We were conversing at my cruiser when we heard officers from the Lewiston Police Department being dispatched to a report of a male actively shooting people inside the bowling alley on Mollison Way in Lewiston.

I asked Sergeant Jon Guay via radio if he was aware of the incident, and he advised he was responding. Deputy Devon Bohacik was on a traffic stop and had not heard the radio traffic. I advised him of the incident and both he and Deputy Joseph Tripp advised they were responding. Dispatch provided us with a description of the suspect which was a male with black hair carrying a rifle.

Deputy Tripp was the first member of the Sheriff's Office to arrive on scene at Just-In-Time Recreation on Mollison Way and reported the male suspect ran outside with a rifle. Deputy Tripp provided a description of a white male with a beard wearing a black sweatshirt and carrying a rifle.

Detective Mejia and I responded to Mollison Way and arrived on scene at approximately 1903 hours. I acquired my county issued patrol rifle from the trunk of my cruiser and made my way to a door at the back of the bowling alley.

Detective Mejia and I then walked in between the machines and made our way up the bowling lanes into bowling alley.

We were still working in the bowling alley when I heard Lewiston PD being dispatched to Schemengee's in Lewiston for a report of an active shooter at approximately 1909 hours. Detective Mejia and I ran out the front door and had to run around the building to get back to our cruisers. I acquired my spare rifle magazine from the trunk of my cruiser then responded to Schemengee's. Detective Mejia and I arrived at Schemengee's at approximately 1918 hours.

I acquired my medical bag from the trunk of my cruiser and entered the building through the front door. It was

treatment plant.

dark inside with the exception emergency lights on the walls. I searched for light switches and located a row of them behind the bar, but discovered they were already turned on. It appeared the power to the building had been shut off.

I then went outside and moved to the back of the parking lot to attempt to locate Deputy Tripp. Deputy Tripp had previously reported someone was seen running through the woods behind the building towards the water

It was

then reported that the suspect may have crashed his vehicle near exit 80 on the Turnpike.

I began to respond to exit 80, but before I arrived on scene it was determined the crash was not related.

The decision was made to close down the area bars and restaurants to eliminate potential targets for the suspect. I went back to Lewiston PD with other officers where were we going to be given assignments. While waiting for assignments, Chief Deputy William Gagne provided me with a picture of the suspect from the bowling alley, which matched the description previously provided via radio. Before receiving an assignment, a report of an active shooter came in at Walmart Distribution Center on Alfred Plourde Parkway Lewiston.

I responded to the distribution center with numerous other officers. We cleared the building and evacuated employees. Through interviews with employees and review of security camera video, we determined the suspect was never there. There was a suspicious vehicle and person at the distribution center, but it was not believed to be the suspect.

The suspect was eventually identified as Robert Card , and the suspect's vehicle was identified as a white 2013 Subaru Outback after 2100 hours.

After leaving the distribution center I went to the Colisée in Lewiston to meet with numerous other law enforcement officers from surrounding agencies and counties. While waiting for assignments, Lisbon PD located the suspect vehicle at the boat launch on Lisbon St in Lisbon. I responded to the area of the boat launch where I observed a white vehicle parked in the parking lot by the Papermill Trail. I cleared from there a short time later to assist Lisbon PD with looking for a suspicious person on Frost Hill Ave which is the road the boat launch is on. By the time I made it around to the other end of Frost Hill Ave it was determined the suspicious person was not the suspect and was involved in an earlier complaint Lisbon PD had been dealing with.

I spent some time on the perimeter at the Ridge Rd end of Frost Hill Ave, then eventually relocated to the intersection of Lisbon St and Village St in Lisbon where I diverted traffic with Deputy Bohacik until we were

On 10/25/23 I was on duty as the Sheriff's Office Patrol Supervisor and was currently in the town of Poland. I was scanning all the police radio frequencies in the county as part of a normal routine. Most of the police agencies in Androscoggin County share the same records management system and likewise can see what each officer is responding to at any given time. Listening to each other's radio traffic is a common practice as well.

At 6:56 p.m. I heard radio traffic from the Lewiston/Auburn Communications Center indicating multiple callers were reporting shots fired at Just-In-Time Recreation (formerly and best known as Sparetime) located at 24 Mollison Way in Lewiston. Further radio traffic advised that there were multiple victims and that this was an active shooter scenario.

Corporal Nadeau radioed me asking if I had heard the Lewiston Police's dispatch traffic as he and Detective Mejia were enroute. I advised Corporal Nadeau that I too was responding. Deputy Tripp radioed to us that he was on Main St in Lewiston and responding with several Lewiston Police Units. Given the seriousness of the incident, I requested that Deputy Pealetere as well as the Mechanic Falls Police Units proceed to Sparetime as well. Deputy Bohacik, who had previously been on an unrelated traffic stop, cleared that stop and headed directly to Sparetime in addition.

At approximately 6:59 p.m. Deputy Tripp was first to arrive at Sparetime along with the Lewiston Police Units he had been responding with. A description of the active shooter was given out over the radio as a male with black hair and a hooded sweatshirt with what appeared to be a rifle.

Deputy Tripp entered the building and attempted to radio to our responding units that the male had already left and had run out the back towards the parking lot. His radio traffic was difficult to hear as he was broadcasting from inside a large building.

At approximately 7:02 p.m. Deputy Tripp gave out the description of the shooter indicating he was a white male approximately six feet tall with a beard, wearing a black sweatshirt and glasses, and carrying an "AR" (AR-15) that ran out the back.

At 7:08 p.m. I was driving on Court St in Auburn when I passed at least two Auburn Police cruisers, one of which was stationary, that had not yet responded to the active shooter scene across the bridge in Lewiston for reasons unknown. (APD would eventually respond to the second active shooter scene, but not until at least 7:17 p.m.)

Also at 7:08 p.m. Deputy Bohacik radioed to our dispatch that he had evacuated

I radioed to Deputy Bohacik if there was a known location on the shooter. He responded in telling me that he didn't have a good location for him at that time.

At 7:10 the Lewiston Auburn Communications Center radioed to all units that they were taking multiple calls for another active shooter at Schemengees located at 545 Lincoln St in Lewiston. I then radioed our dispatch to divert all remaining County units to Schemengees to assist with that scene. At 7:13 p.m. I arrived at Schemengees. Androscoggin County Dispatch radioed me that description for the shooter was possibly male with a black sweatshirt headed towards the water treatment plant. I was met and joined by other Lewiston Police Officers including Officer's Simmoneau, Zawistowski, and Caouette, who were in plain clothes and had just responded from training at their firearms range on River Rd. when they heard the call.

At approximately 7:18 p.m. I spoke with an unknown male witness who told me that shooter left in a

white four door hatchback car. He couldn't tell me what type of car it was other than what he described. He said that car drove off on Lincoln St, then on to South Ave, and towards Lisbon St. I notified dispatch as to the description of the vehicle and last known location.

At 7:19 p.m. it was determined that there was active shooter on the loose and

requested dispatch consult with Chief Deputy Gagne to do a mass callout for any available Deputies to respond to Schemengees.

At 7:40 p.m. I coordinated with Lewiston Police Sergeant Joey Brown as well as Lieutenant Derrick St. Laurent in shutting down the city's bars and nightclubs. There was tremendous concern that another soft location was going to get attacked as the shooter's whereabouts were still unknown. This was the time that information had surfaced from the Sparetime location that the shooter was armed with an AR10 which shoots 7.62x51mm ammo (commonly referred to as .308 ammunition). I then had all available Deputy Sheriffs at

Schemengees regroup at the Lewiston Police Department for assignments in shutting down the city.

At 7:43 p.m. I received a call from Deputy Marshall Ryan Guay of the U.S. Marshall Service based out of Portland, ME. He had heard reports of an active shooter in Lewiston. I spoke with him, advised that there were two locations with multiple fatalities and injuries. I requested he activate his team and assist in the manhunt. That request was granted and soon U.S. Marshalls from all over the state and New England began arriving.

At 7:45 p.m. a vehicle crash was reported near the on ramp to the Turnpike off exit 80 in Lewiston. One of the vehicles reported involved was a white hatch back sedan previously described as the shooter's getaway car. Nearly a dozen Sheriff, State Police, and Lewiston cruisers responded to the on ramp however it was quickly determined that the car involved was not our suspect.

At 7:52 p.m. most of the available Sheriff units started arriving at the Lewiston Police Department for orders and assignments. There were reports of a possible active shooter at Davinci's Restaurant on Mill St in Lewiston, but that was quickly debunked as a false report. I then had Deputy Rider, Deputy Philips, Deputy Chaloux and Deputy Westleigh start visiting the local bars in Lewiston with instructions of them to shut down and/or shelter in place.

At 7:53 p.m. I received a photograph of the suspect in the mass shootings at both Sparetime and Schemengees. Officers inside Sparetime Recreation were able to review video footage and captured a still image of the active shooter. That picture was widely distributed to area law enforcement and ultimately to the public on social media pages. A second photograph was also sent out portraying the car used in the escape. It was a white Subaru with a different colored front bumper than the rear.

At approximately 8:12 p.m. reports started to come in of an active shooter at the Walmart Distribution Center in Lewiston on Goddard Rd in Lewiston. Once again, all Sheriff Units were directed towards that location. We arrived about three minutes later but saw no activity out-front or could hear anything inside. All the doors were secured and there was no one to meet us at the front entrance. There was confusion at the Distribution Center as we were hearing employees were taking shelter as there was a possible active shooter inside.

At approximately 8:20 p.m. entry was made into the facility. Detective Mejia, two Maine State Police Tac Team Units and I then started to clear the entire dry side of the facility as other officers began searching the refrigerated side. The WalMart D.C. is a very large facility covering the equivalent of 8-10 football fields. While searching Walmart D.C., we came across several employees who had hid themselves and were escorted to safety.

The entire search of the Walmart Distribution Center took nearly an hour to complete. All employees were found safe and unharmed. It was later determined that while a suspicious vehicle may have shown up outside the distribution center, there was never an active shooter.

At 9:16 p.m. a mass t	ext was sent out from the Androscoggin Communications Center which identified
Robert Card	as the potential suspect in the mass shootings. It was said he was

operating a white 2013 Subaru Outback.
At 9:25 p.m. all Sheriff's units were assigned to assemble at the Colisee parking lot in Lewiston. This would be the staging area for all incoming units to assist in the manhunt. Teams from Sheriff Offices, local police departments, and federal agencies all gathered and began waiting for instructions and assignments.
At approximately 10:07 p.m. we began hearing reports that the car in question was located by Lisbon Police Units on Frost Hill Ave in Lisbon by the boat launch from where the Sabattus River and the Androscoggin River meet.
This would be the last time I had any formal communication or direct knowledge as to wher the investigation into Robert Card was headed.
Sometime after midnight on 10/26/23 the Lisbon Police Department started to get calls of suspicious persons walking in the area or random gunshots heard. Sheriff units were dispatched to assist Lisbon in investigating those calls which mostly determined to be unfounded. I assisted Lisbon PD with checking at lea two possible addresses for Robert Card
and he was not found at either location.
At approximately 1:20 a.m. on 10/26/23 rumors began to circulate that a possible boat or jet ski may ha
been used in Card's attempt to escape. Those searches didn't produce any results or
clues.
I was advised that at 2:00 a.m. a Chief's briefing would be taken place at the command post. Several members of law enforcement on the bridge in Lisbon inquired about what was found in the car and that information was never shared with us. For the remaining three hours of my shift, I canvassed the area by vehi looking for Card and worried that there would be another target the following day. At approximately 4:00 a.m information began to leak out that Card's former employment was through Maine Recycling located at 61 Capital Ave in Lisbon. This location is less than a mile from where his vehicle was found at the boat launch, approximately 5:00 a.m. a representative from Maine Recycling arrived at the roadblock on Lisbon St at Graziano Square where some of my deputies were stationed. This gentleman was allowed through as a v.i.p.

On 10/26/23 at approximately 12:00 p.m. I went back on duty and learned that more units and tactical

teams were responding to Lewiston to assist in the search.

At approximately 2:00 p.m. I learned that Deputy Matt Noyes had a wealth of information to share regarding Robert Card. Deputy Noyes had served with him in the Army and had taken him into protective custody in New York as a commanding officer. Deputy Noyes had knowledge of Cards current and previous employers (Maine Recycling in Lisbon) as well as friends and relatives. Deputy Noyes attempted to relay this information in person at the command post the previous night but was rebuffed and not interview until after Card's body was eventually found.

Card's body was eventually found.
Sometime in the afternoon of 10/26/23 A bolo was put out on area mobile data terminals to locate and stop him. He was eventually found by Lewiston police on Unknown what his involvement was or who requested he'd be located.
De localed.
At approximately 5:00 p.m. I learned via Fox News that a residence on in Bowdoin was the scene of a large police response and sounds of explosions.
At approximately 8:00 p.m. I was asked to call a Border Patrol Agent for a special request and was given a phone number.
I thanked them for their involvement.
Throughout the next ten hours Deputies responded to several calls of gunshots and suspicious incident reports in Durham and surrounding communities as residents sheltered in place and businesses in Androscoggin County were closed. Opening day for deer hunting in Maine was on 10/28/23 and most of the gunshot calls
could be attributed to hunters sighting in their rifles.
Many of the suspicious vehicle reports were resolved as unmarked law enforcement cars with out of state plates conducting their own investigations and searches.
Various wooded areas and banks of rivers were searched again without success.
On 10/27/23 at 11:56 a.m. I was off duty and received a call from a

They found the person who had mistakenly

called 911 and cleared without incident.

On 10/27/23 at approximately 12:15 p.m. information was starting to leak that Card's .308 rifle, along with at least one magazine, and some other personal effects were found in the Subaru a couple nights before. This information gave rise to theory that Card was somewhere close to his vehicle. The fact that he had not surfaced in the preceding days also gave rise to the suspicion that he might have committed suicide.

On 10/27/23 at 7:42 p.m. a mass text was sent out to available Deputies for help in conducting a line search at the boat launch the following day. Deputies were asked to assemble at the Lewiston High School command post the following morning at 7:30 a.m.

At 9:22 p.m. a mass text was sent to Sheriff Deputies that Robert Card had been found deceased. He had apparently been found in a shipping container near his previous employer at Maine Recycling and within a mile of his abandoned Subaru Outback.

This ends my involvement with this case.

On 10/25/23, at approximately 1919 hours, I received a text message from our dispatch center advising of an active shooter at Schmengees in Lewiston. All available units were requested to respond. At approximately 1925 hours, I signed on and went to Schmengees.

I proceeded into the

I began to

check the far side of the building where I found a closed door. I opened the door which led to a galley area, connecting to a back storage room and the kitchen area. No viable victims were located.

While inside the structure I noted that the lights had been shut off. I recall someone asking to have the lights turned on and someone said they weren't working. I had to use my flashlight to make my way around the inside of the building.

I was asked by a Lewiston supervisor at that time to have all ASO units secure the building and not allow anyone else in. I placed Deputy Chaloux at the door. I went back to my vehicle and grabbed some crime scene tape. I taped off all entrances to the building. Lewiston units were working on taping off the perimeter.

I was then asked by Lewiston PD Spencer Simoneau to go around the parking lot and write down plate numbers for Maine State Police. Lewiston PD Parker Simoneau assisted me. These plate numbers were turned over to Detective Mike Chavez of the Maine State police.

Shortly after, a State Trooper came running up to the scene reporting that a white sedan, similar to the one seen leaving the scene, crashed at Exit 80 and units were being requested to respond. I responded to the area and was advised on my arrival that the incident was not connected to the active shooter.

I arrived back at Schmengees to offer further assistance. While at the scene, dispatch advised there was a reported active shooter at the Walmart Distribution Center in Lewiston. I responded to that scene and was the second unit to arrive. Deputy Jason Chaloux was at the employee entrance. As more units began to arrive, dispatched advised they received another call that there was an active shooter in the building. Deputy Chaloux entered the lobby and smashed the window out of a locked door so we could gain entry. I entered the building with several other officers.

Deputy Devon Bohacik and I split off from the group to clear a separate portion of the building. We determined the space was too large and we needed more units. No active shots were being heard or had been heard at this time. After acquiring more manpower, we began to systematically clear the distribution center. Upon entering

the cold storage area, we encountered several employees in an office to our right. We asked them about the shooter, and they described something similar to our initial call. They were ordered to shelter in place. We continued clearing the building and encountered another group of employees. They were all patted down for weapons. Nothing was found. They advised there was approximately 30 more employees on the third floor. We asked them to call them all down to the first floor so they could be cleared out of the building. They came down one by one and were also patted down for weapons.

We decided to evacuate them from the building at this point. We walked all the employees to the front entrance, including the ones sheltered in the office. While on our way out, Sgt. Jon Guay advised they had reviewed the video footage and there was no active shooter in the building, just some confusion and miss communication amongst the callers.

We were ordered to go to the Colisee in Lewiston as a staging point. While at the Colisee we received word that the suspect vehicle had been located at the Miller Park boat launch in Lisbon. ASO units decided to partner up in vehicles and respond to the area. Deputy Chris Miller and I partnered up and proceeded to the Lisbon Community School where the walking trail from that boat ramp comes out.

This concludes my involvement in this case.

On October 25, 2023, at 7:11 PM all Androscoggin Deputies received a text from dispatch notifying us of an active shooter situation in Lewiston. I was off duty and soon left my residence en route to assist. I heard officers being told to head to Lewiston PD to stage for more information. Officers had just responded to an additional active shooter call at Divinci's Eatery that turned out to be unfounded.

While heading to Lewiston PD, I heard Deputy Dylan Rider being sent to Sabattus Street to shut down the liquor establishments. I was right in the area and assisted. We first went to the Blue Goose on Sabattus Street in Lewiston. The doors were already locked but people were inside. We made contact with people inside and told them to shut down for fear of an active shooter on the loose. They stated they heard the news and would be leaving shortly.

Deputy Rider and I went up Sabattus Street to Little Joe's Bar, also in Lewiston. We got there and found no one there. We went further up the road to Mixer's Lounge in Sabattus. We pulled into the parking lot and found the business to be closed. We decided to head back into Lewiston. On our way we heard officers out on Stetson Road in Lewiston with something suspicious. Deputy Rider and I followed a Lewiston PD officer off Russell Street down College Street. We soon heard of an armed confrontation at the Walmart Distribution Center.

We all turned around and headed towards Walmart Distribution Center. I took up a permiter position on Alfred Plourde Parkway by the intersection of Gendron Drive. I was soon met by a trooper MSP 812, Sgt. Tim Kachnovich, and Oxford Deputy William Nelson.

We monitored the building and area until the distribution center was entered by police, cleared, and all employees were allowed to exit. All officers soon cleared the area as the incident was not deeded to be related to the active shooter incidents that were previously called in. Everyone cleared and headed to stage at Lewiston PD. That directive was soon corrected to the Collisee parking lot as there were many police agencies in the area and we needed a larger staging area for all the cruisers.

While we were there some calls were coming in over Lewiston PD's radio frequency of suspicious incidents, men with a gun, and other stuff. Officers did respond and found them not related.

We later heard that Lisbon PD found a white Subaru car and confirmed the registration matched for the suspect Robert Card's vehicle. The car was parked in the area of the walking path/boat launch by the entrance to the Sabattus River. Many of the staged police responded to the area.

I went as far as the bridge on Lisbon Road, by the intersection of River Road in Lisbon where I stopped. Before the bridge on both sides of the road is a guardrail that showed fresh damage on both sides to include skids and broken glass. I assumed the suspect vehicle became disabled and limped to the parking spot it was left in. I contacted a manager of Crafts Auto Sales as they have an annex where a few of their cars are stored is right across the road from where the suspect's vehicle was found. I got a list of all the vehicles that should be in that annex lot. I sent the vehicle list to Lisbon Chief Ryan McGee just incase any were missing/stolen by the suspect. I also notified him of the evidence of a crash scene just prior to the boat launch.

I backed up the road assuming someone shut down Lisbon Road at the intersection of Mill Street. I closed the

road a bit closer to the scene as cars were still coming through. I parked on Lisbon Road at the entrance of Two Rivers Dentistry. I remained there until I was relieved by Deputy Devon Bohacik just prior to 1:30 AM. I went off duty shortly after.

The next morning just after 5:15 AM I returned to the area now at the intersection of Lisbon Road and Village Street/Webster Road shutting down Lisbon Road. Later in the day around noon time I was cleared of this duty by Deputy Gary Moulton.

I began patrolling and later went to Cedar Pond Road in Durham and looked at the riverbanks with binoculars. I went further up the road down private road James Place, which leads right across the Androscoggin River from where the suspect vehicle was found. I went to the third residence on the road which is empty and under construction. The house was empty. I walked to the shore line and viewed the riverbanks and found nothing of noting.

I went to the area of the Durham/Lisbon bridge and viewed the dam and rocky area looking for any evidence and didn't find any. I cleared the area and soon went off duty. I had no further involvement in this case.

began to get my uniform on and turned on my radio when I began to hear radio traffic indicating this was in fact an active shooter situation. I called into dispatch and informed them that I was ready to respond if a K9 team was needed. Dispatcher Alec Douquette told me to start heading toward Schemgee's Bar and Grill as they were starting to take reports of another active shooter incident at that location.

I got in my vehicle and responded to Schmengee's. Upon my arrival I observed many Police Officers from various agencies gathered in a circle in the parking lot. It appeared to me these units were developing a plan with the limited information they had. I stood by for a second to listen when I realized the suspects whereabouts were unknown and some had reported the male fleeing the scene into the woods. I feared there was a possibility we would be ambushed and instructed a Lewiston Firefighter that was nearby to get me a ladder to the roof of the building. I looked around and saw Sgt. Andrew Levesque and Officer Jeffrey Williams with the Lisbon Police Department on scene armed with rifles.

At some point I overheard radio traffic indicating the shooter was at the WalMart Distribution Center which is only a short distance away. Several Officers and I made the decision to respond to the WalMart DC as we were in close proximity to the location.

I arrived at the Wal Mart DC location and observed Deputy Jason Chaloux and Chief Eric Baker at the front door. Deputy Chaloux informed me the door was locked and they were unable to get anyone to let them in. I instructed him to break the glass in the door so we could make entry. I made this decision given the information we had at the time. It was reported there was an active shooter at this location, the doors were locked, and I could not see anyone inside the building which indicated the employees were hiding. Numerous other Officers from various area agencies had arrived at this point and we split up into small groups and began to clear sections of the building. It became apparent that this report of an active shooter at this location was likely not accurate and we regrouped at the entrance a short time later. Several groups of employees were escorted out of the building during this time. It was determined that this report was not accurate and we were instructed to assemble at the Collisee in Lewiston to receive further assignments.

responded to the Collisee with other Deputies from this agency. While at the Collisee it was decided that doubling up in cruisers and providing assistance in the Lisbon area was where we would be the most useful. Sgt. Travis Lovering and I partnered up in my cruiser and responded to the Lisbon area where the suspect vehicle had been located. Sgt. Lovering and I patrolled the Lisbon area for quite some time before taking up a position behind the Lisbon High School near the football field. I am familiar with the area and knew the walking trial the suspect was thought to have traveled was in close proximity to this location.

Upon my arrival I met up with Dep. James Phillips who stated that there was nothing more we could do. Dep Phillips advised we were being directed to respond to LPD for further assignments. I walked back to my cruiser and made my way back to LPD where Dep Phillips and I teamed up in one car.

We were assigned to make sure Fast Breaks bar and Gridiron were closed and all the patrons were escorted out safely. While clearing Gridiron a call for an active shooter came in for the Walmart distribution center. Dep. Phillips and I responded to the Alfond Plourde parkway side of the building. Upon arrival, we assisted in clearing and moving occupants out of the building and into safety.

Dep. Phillips and I cleared Walmart and responded back to Gridiron where Dep. Phillips picked up his vehicle. Both Units responded to the Colisee where we waited until we responded to the town of Lisbon. In Lisbon at the bridge before the boat launch, I was doubled up with Cpl. Nadeau. While on the bridge a call came in about a suspicious black pick up truck with flashers on. The vehicle was pulled to the side of the road and parked. Cpl. Nadeau and I made contact with the operator and his passenger.

I was cleared from the area and the call approximately midnight.

October 25, 2023, at approximately 1920 I, Deputy Christopher Miller was alerted of an active shooter situation
that was occurring in the city of Lewiston. I was told there was a scene at Schmengees and "Just in time
recreation". I was also told there was a text to all members of patrol from the Androscoggin County Sheriff's
Office, asking for anyone to respond to both incidents. I decided to respond but needed to wait for someone to
come to my house to watch my children.

- 2. At about 1930 I was able to leave my house and respond. I operated my vehicle with my lights and sirens activated on Route 196 in the town of Lisbon, headed towards Lewiston. My first destination was supposed to be Schmengees, as that was the closest location to me. While I was approaching the intersection of Pleasant Street and Lisbon Street, Corporal Morin advised over the radio that there was a crash on Alfred Plourde Parkway, and the Maine State Police advised it could potentially be the shooter's vehicle. I quickly changed my destination to the crash.
- 3. When I arrived at the crash, there was already multiple police vehicles on scene. I heard over the radio that the vehicle was not the shooter's vehicle. I cleared the crash. I was then told that all available units were needed to respond to the Lewiston Police Department and to await orders. While I was at the Lewiston Police Department, I was shown a picture of the shooter. I was also shown a picture of the vehicle that the shooter was using (white Subaru with a black front bumper).
- 4. Once I was at the Lewiston Police Department, I was advised that there was an active shooter at the Walmart Distribution facility. I responded to the location. I went to the front door with multiple other police officers. I could hear no gun shots coming from the business. The front door to the facility was locked. The front door was then broken by police, and we made entry. I walked through the front office area and made my way to the warehouse part. I held that position while other police officers searched and cleared the building. Employees of the business were taken to safety and brought to a secure part of the building. While units were clearing the building it became evident that the shooter was not at this business, and that this was a false report. Once the distribution center was cleared, we were told to go to the Lewiston Colisee to stage and wait for assignments.
- 5. I cleared the distribution center and started to make my way to the Colisee. While I was operating my vehicle on Lisbon Street, in the area of Golden Nozzle car wash I observed an individual walking on the sidewalk. The male was wearing clothing that matched the description given of the shooter. The male also had a backpack on and had a beard. I turned around and notified dispatch that I was out with a pedestrian matching the description of the shooter. I got out of my vehicle and had the male walk backwards towards me. The male instantly put his hands in the air and told me that he was just trying to get back to where he was staying. Corporal Barr and a Game warden arrived to assist. We searched the male for weapons, and nothing was found. I properly identified the male using his State of Maine identification. I then put the male in my police vehicle and brought him to an area motel where he was staying for the night. I then went to the Colisee.
- 6. While I was at the Colisee, I heard radio traffic from the Lisbon Police Department stating that they found a vehicle that matched the description given for the vehicle belonging to the shooter. The vehicle was parked in a parking lot at "Miller Park". That park has a small parking lot and there is a paved walking path. The walking path leaves from both ends of the parking lot, and the path goes two different directions. I am very familiar with this park as I have spent a lot of time there off duty. I awaited confirmation that the vehicle was the vehicle used in the shootings. A short time later, it was confirmed that this was the vehicle that was used. It was not clear if the vehicle was occupied or not.

I was then diverted to the Walmart Distribution Center in Lewiston with a reported sighting of the shooter. I responded to the Walmart Distribution Center with other units from the Sheriff's Office and cleared the building, evacuation several employees. I then cleared from this location and was directed to go to the Colisee in Lewiston to re-group.

Once at the Colisee, it was decided that we would pair up in a cruiser and go back out. I teamed up with Sgt. Tim Kachnovich and proceeded to Lisbon, where now we had been advised that the suspect's vehicle had been located. I remained in Lisbon with Sgt. Kachnovich until we were requested to respond to a warehouse off Rt. 196 for a suspicious condition.

8. Once this task was completed, I brought Sgt. Kachnovich to Cpl. Randy Williams, who both were going off-duty. I then took Cpl. William's position on Rt. 196 and conducted traffic control, not allowing any vehicle by my location. Cpl. Darian Nadeau then arrived and assisted me with this task until we were relieved by Cpl. Prior to responding, I called into dispatch to confirm that the text message was intended to be sent and factual. Dispatcher Letourneau confirmed that there was a report of two active shooters with multiple casualties. I quickly dressed in full uniform and left my residence in my fully marked patrol cruiser.

As I entered the City of Lewiston, I overheard radio traffic for all available units to respond to the command post at Lewiston Police Department for assignments as the location of the assailant was unknown. It was at the Lewiston Police Department I was showed a picture of the assailant, his vehicle and informed of his identity, Robert Card. While there, I partnered up with Livermore Falls Officer Maverick Real in my patrol cruiser. We than quickly drove around and shut down local establishments; Blue Goose, Little Joe's and Mixers. The only business with patrons was Blue Goose.

Throughout the evening, early morning hours, we would respond to a vary of calls which all would be determined to not hold any value of leads for the assailant Card. I overheard radio traffic of Lisbon Police Department finding Card's vehicle at their local boat launch off from Route 196.

I left the scene at their request. We drove around the vicinity, looking for anyone matching the description.

At 7:24 pm, I signed 10-8 (in route). Dispatch advised to respond to Schmengee's in Lewiston as they need units at that location. I activated my emergency lights and siren.

At approximately 7:35 pm, I arrived in the area of Schmengee's. Due to the number of emergency vehicles in the area, I had to park down the road approximately 800 feet. I exited my vehicle and I secured and charged my long rifle. I was requested to make my way to the parking lot of Schmengee's

Once at the parking lot, I made contact with Deputy Bohacik, Deputy Tripp, Cpl. Morin, Cpl. Nadeau, and Sgt. Guay. Shortly after arriving, Sgt. Guay advised that we were going to respond to the Lewiston Police Department and reorganize our efforts as needed. Sgt. Brown of the Lewiston Police Department asked that we split up and start responding to local dining establishments and bars to have them shut down for the night and to safely return to their residences.

We responded to the Lewiston Police Department. While staged at this location, Deputy Westleigh and I joined forces, and we took her vehicle #127. We responded to Fast Breaks and the Gridiron Restaurant and Pub. Both locations had already been notified to close for the evening and to return to their residences.

At this time, we cleared, and we started making our way back to the Lewiston Police Department. While in route, we received notices of a reported active shooter at the Wal-Mart Distribution Center on Alfred Plourde Parkway in Lewiston. We immediately responded to that location.

Upon arrival to the Walmart Distribution Center, we made our way to the main entrance. Once at the main entrance, we entered the building. Dep. Westleigh and I stayed at the main entrance, and we secured all employees that made their way safely to us.

Once the building was cleared, we responded back to the Lewiston Police Department.

At this time, we returned to the Lewiston Police Department. We were asked to respond to the parking lot of the Lewiston Colisee, as they are establishing a staging point. I took my vehicle #113 to the Colisee. Once at the Colisee all Androscoggin County units met up, along with several others from smaller departments. We received notification from our command staff that the suspect has been identified. The suspect being a Robert Card and he is operating a white 2013 Subaru Outback, with a black front bumper,

While at the Colisee, we heard the Lisbon Police Department report that they had located the suspects' vehicle at the boat launch on Frost Hill Avenue and Lisbon Street.

Upon arrival to the town of Lisbon, we patrolled the northwest portion of the town as a walking path goes north

At this time I was not sure if this was a hoaxed text or if it was real and I attempted to call the Androscoggin County Communication's Center. The phone just kept ringing and ringing I then hung up the phone and called Director Martin Fournier direct on his cell phone. I asked him "is this was real?" He replied yes and respond immediately I then grabbed my Androscoggin County Polo put it on and put on my vest over that and grabbed my rifle and left the house. When I signed 10-8 (in service) I was informed to respond to Schemengees Bar & Grill at 551 Lincoln St Lewiston. As I turned onto Lincoln Street I noticed many police cars, fire engines, and various other emergency vehicles all with lights on all down Lincoln Street, I arrived on scene at about 1925.

I had to stop about 200 feet from the building due to all the emergency vehicles. I exited my vehicle with my rifle and proceeded to run down to the entrance of the building. At this time I saw people running all over the place to include in and out of the building. I asked who was in charge and got no answer.

At this time we had the male explain to us again were he turned off the power he then told us that he could show us. I believe it was Corporal Jeremy Somma from Lewiston Police Department who asked if he was the owner or worker of Schemengees. He stated that he was not and only a customer who was there when the shooting started and that he hide in that closet and noticed the power box and cut the power to the building. He explained where it was one more time to Corporal Somma and I and we then went back into the building to look for the power switch. This time we were able to locate the closet that was off of the private dining area. The power was turned back on and we exited the building. When I got back to the door Corporal Somma continued down the stairs and I stood by Corporal Kavanagh. I noticed at this time that the male was now gone. A few moments later a male that was at the rear of the building in the tree line yelled out to turn the power back off. I do not know who this male is or who he worked for but I went back into the building and turned the power back off once again and exited the building. A few minutes went by and I was standing back next to Corporal Kavanagh and a dispatch call came in that there was an active shooter at Davinci's restaurant which is only down the road from our location. I noticed numerous police vehicles take off in that direction and I decided to stay back at this time. We also heard that there was also State Police in the area as well and they are responding. Moments later another call came in from dispatch that there is an active shooter at the Wal-Mart Distribution Center which is also right up the road from us. At this time I noticed only 1 police vehicle responding to that location. I asked Corporal Kavanagh if he was all set and that I would respond to that location as we only saw one police vehicle responding. Corporal Kavanagh stated go and I'm good here. I then ran to my vehicle and followed the other cruiser up Lincoln Street, I did not noticed what agency it was from but it continued on to the right on River Road. I took a left onto Goddard Road and followed that to Alfred

Plourde Parkway where I took a right and went into the employee's entrance of the Wal-Mart Distribution Center.
I could see down the hallway and observed no movement or anyone in the area. I radioed into the
Androscoggin County Communications that I was the only person at this location and that I'll be waiting for back up. I

Deputies were standing and it was decided that we would pair up in vehicles and go drive around the city looking for the suspect's vehicle. I teamed up with Deputy Robert Murphy in his vehicle and we exited the Colisee. A few minutes after we left the parking lot we got alerted that the suspect vehicle was located at the Lisbon Falls boat launch on Route 196.

Robert Card did not appear to be in the vehicle. A short while later Lisbon Communications was getting numerous calls of suspicious persons/vehicles all over the area where the vehicle was located. Deputy Murphy and I were dispatched to Springworks Farm for a person in the building. Springworks Farm is only about a mile from where the suspect vehicle was located. Deputy Murphy and I arrived on scene and secured the front of the building. The owner of the building came over and spoke to Deputy Murphy as I walked a little further down to secure the back side of the building as well. I later learned that the owner heard that there was a mass shooting in Lewiston and that the suspect vehicle was located a short distance away. He stated that he opened all the doors in the building so if a door shut he would know someone was in it as he is the only one working. While he was working he heard a door slam and noticed that the bathroom door was now shut. He stated that he then call Lisbon Dispatch and exited the building. A few minutes later Chief Ryan Mogee arrived on scene as well as Sergeant Timothy Kachnovich and Deputy Devon Bohacik.

I returned to my vehicle that was parked at the Colisee and informed to help Lewiston Police Department clear up some pending calls they had. I had no other interaction involving this case on this day.

Dispatch was notified by Cpl. Nadeau who had also heard the radio traffic from Lewiston. As I was on my way to the location, there were two Lewiston PD units in front of me.

On 10/25/2023 at approximately 1911hrs, I received a text message on my cell phone from the Sheriff's Office. It was an automated message, "units required for road; 2 active shooter situations in Lewiston". I got dressed into my department uniform and immediately responded. Just after letting dispatch know, I was enroute, Deputy Gregory Mailhot called me on my cell phone. He advised that he was on vacation and therefor didn't have his cruiser, so asked if I could pick him up on my way to the active shooter incident. I picked Deputy Mailhot up in Minot moments after speaking with him on the phone.

The active shooter incidents took place at Just in Time Bowley Alley and Schmengees' Pool Hall. As Deputy Mailhot and I responded, dispatch had advised any available units to respond to Schmengees', as the scene had been secured at the bowling alley.

While responding to Schmengees', dispatch reported that anyone not currently at a scene, respond to the Stetson Rd. in Lewiston, for a possible sighting of the shooter. I immediately responded to the Stetson Rd. in Lewiston, where I met with a group of other officers, Before beginning any search, dispatch then reported that they were taking reports that the active shooter was now in the Walmart Distribution Center in Lewiston. Deputy Mailhot and I, along with several other officers, left the Stetson Rd. and responded to the Wal-Mart distribution center on Alfred A. Plourde Pkwy, In Lewiston.

Upon arrival, there was already a team of officers that had entered the distribution center to clear it. While speaking with other officers outside the distribution center, another report came in that there could be another active shooter at 10 Wakefield Street in Lewiston. Deputy Mailhot and I began to respond to that scene as the report came in. Before we could arrive at Wakefield Street, another officer had cleared the area advising it was in fact not another scene.

By this time, enough of the public was aware of the active shooter, and now other reports were coming in of possible suspects and locations.

Deputy Mailhot and I responded to the Olive Garden restaurant in Auburn, after dispatch had reported the restaurant had called in a man outside with a bullet proof vest on. We arrived on scene and had noted an Auburn Police car just leaving the area. We did not observe anyone outside of the restaurant at that time.

Deputy Mailhot and I started to head toward the Lewiston Police Department to make contact with the command post and get further assignments. While on the way to the command post, dispatch put out that the shooter had been identified as Robert Card and added that he was possibly operating a white Subaru Outback station wagon with a different colored front bumper.

Once I arrived at the command post, I met with Major Cornelio who asked me to identify Card's vehicle from security camera footage
Shortly after providing information to the Maine State Police, Sheriff Eric Samson, Deputy Mailhot, and I all left the command post in my cruiser.
We checked Card's most recent employer's parking lot to see if we could locate his vehicle there. The vehicle was not in the parking lot. As soon as we left the parking lot, dispatch reported that they were receiving a call that someone was live streaming the active shooter at the Rusty Lantern Convenience store in Sabattus. We immediately began responding to the store with lights and siren activated. Before being able to get to the store, other officers had cleared the area, and advised there was not active shooter event at that location.
Immediately after discontinuing the response to the Rusty Lantern store, dispatch advised that Card's vehicle had been located at the boat launch at the intersection of Rt. 196 and Frost Hill Ave. in Lisbon.
I went home at 0200hrs per the direction of our representative at the command post and was available for call out from there.


- 1. On 10/25/2023 at approximately 1911hrs I was contacted by Dispatch via a page to my cellphone informing me on an active shooter incident in Lewiston. I was at a local restaurant with my family and had to return home to get my cruiser and gear.
- 2. I signed on at approximately 1930hrs and was told by dispatch to report to Schmengees Bar and Grill.
- 3. Just prior to arriving at Schmengees I was told that all units could clear that location, the resources on scene were adequate. I was told to return to the Lewiston Police Department to re-group and come up with a plan. Prior, to returning to the Lewiston Police Department, at approximately 1945hrs, dispatch notified units about a car crash at exit 80 on Alfred A. Plourde Parkway.
- 4. It was initially reported that the crash near exit 80 was the suspect vehicle from the shootings however, just as I arrived on scene, I learned that the crash was unrelated.
- 5. As I began to return to the Lewiston Police Department, at approximately 1950hrs, I was told by dispatch that there was report of another active shooter at DaVinci's Eatery on Mill Street in Lewiston.
- 6. I arrived on scene at DaVinci's Eatery along with several Auburn Police Department units and Trooper Jason Wing. It did not appear that there was any disturbance at DaVinci's Eatery however, it was decided that we would clear the building to confirm that there was no threat.

- 8. I arrived at the Animal Hospital on Stetson Road and just as I prepared to deploy, I was informed that there was a possible active shooter at the Wal-Mart Distribution Center on Alfred A. Plourde Parkway in Lewiston.
- 9. At approximately 2010hrs, I responded to the area of Goddard Road with several other officers and set up near Northeast Charter. 

On 10/25/2023, at approximately 1857 hours, I Deputy Greg Pealatere was on duty in the Poland area and requested to respond to 24 Mollison Way in Lewiston for a report of a active shooter at the location. ASO dispatch advised the business is Spare Time bowling facility and serious injuries have been reported. I responded to the location with emergency lights and siren and upon arrival I parked my patrol vehicle in front of fire and ambulance vehicle's. I exited my patrol vehicle with my patrol rifle and prepared to advance towards the facility.

I observed various subjects walking or running away from the location and various police vehicles were already on scene prior to my arrival. At approximately 1919 hours, I overheard on ASO radio frequency that a second active shooter incident was now taking place at 545 Lincoln Street in Lewiston and that all ASO patrol units need to respond to that location. The Lincoln Street location was identified as Schmengees Bar and Grill Restaurant.

I responded to the Lincoln Street location and stopped on the roadway just east of the Restaurant. Various fire and police vehicles and already arrived prior to my arrival. I exited my patrol vehicle and met up with Deputy Joseph Tripp of which we tactically worked are way along a steel fence line towards the parking lot of Schmengees Restaurant.

At approximately 2012 hours, ASO dispatch advised they have another report of an active shooter at the Walmart Distribution Center in Lewiston which is approximately 1 mile east of Schmengees of Lincoln Street. MSP units at Schmengees advised if anyone has a patrol vehicle to leave and respond to the Walmart Distribution Center.

I ran back to my patrol vehicle and a unknown Lewiston PD officer wearing range clothing jumped in my patrol vehicle with myself and we responded to the location. ASO dispatch advised to enter through the truck loading area as well.

Upon arrival, large box trailers blocked some of the entrance which kept responded units from driving all the way up to the building. Upon exit of my patrol vehicle, ASO dispatch first advised a active shooter was inside the structure, then updated with two subject outside were only brandishing a weapon and all the employees had locked themselves into the dry storage area.

Other responding unit made entry through the main entrance of the Walmart facility and were able to escort the occupants out safely.

ASO patrol unit were advised by dispatch to respond back to Lewiston Police Department so assignments could made. I responded back to LPD and was advised by ASO Major Mark Cornelio to patrol the area and remain central until additional information develops.

After a period of time, ASO dispatch advised the shooting suspect is a Robert Card who is operating white 2013

I asked Sergeant Jon Guay via radio if he was aware of the incident, and he advised he was responding. Deputy Devon Bohacik was on a traffic stop and had not heard the radio traffic. I advised him of the incident and both he and Deputy Joseph Tripp advised they were responding. Dispatch provided us with a description of the suspect which was a male with black hair carrying a rifle.

Deputy Tripp was the first member of the Sheriff's Office to arrive on scene at Just-In-Time Recreation on Mollison Way and reported the male suspect ran outside with a rifle. Deputy Tripp provided a description of a white male with a beard wearing a black sweatshirt and carrying a rifle.

Detective Mejia and I responded to Mollison Way and arrived on scene at approximately 1903 hours. I acquired my county issued patrol rifle from the trunk of my cruiser and made my way to a door at the back of the bowling alley.

Detective Mejia and I then walked in between the machines and made our way up the bowling lanes into bowling alley. In this area

We were still working in the bowling alley when I heard Lewiston PD being dispatched to Schemengee's in Lewiston for a report of an active shooter at approximately 1909 hours. Detective Mejia and I ran out the front door and had to run around the building to get back to our cruisers. I acquired my spare rifle magazine from the trunk of my cruiser then responded to Schemengee's. Detective Mejia and I arrived at Schemengee's at approximately 1918 hours.

I acquired my medical bag from the trunk of my cruiser and entered the building through the front door. It was

then reported that the suspect may have crashed his vehicle near exit 80 on the Tumpike.

I began to respond to exit 80, but before I arrived on scene it was determined the crash was not related.

The decision was made to close down the area bars and restaurants to eliminate potential targets for the suspect. I went back to Lewiston PD with other officers where were we going to be given assignments. While waiting for assignments, Chief Deputy William Gagne provided me with a picture of the suspect from the bowling alley, which matched the description previously provided via radio. Before receiving an assignment, a report of an active shooter came in at Walmart Distribution Center on Alfred Plourde Parkway Lewiston.

I responded to the distribution center with numerous other officers. We cleared the building and evacuated employees. Through interviews with employees and review of security camera video, we determined the suspect was never there. There was a suspicious vehicle and person at the distribution center, but it was not believed to be the suspect.

The suspect was eventually identified as Robert Card, and the suspect's vehicle was identified as a white 2013 Subaru Outback. I received this information after 2100 hours.

After leaving the distribution center I went to the Colisée in Lewiston to meet with numerous other law enforcement officers from surrounding agencies and counties. While waiting for assignments, Lisbon PD located the suspect vehicle at the boat launch on Lisbon St in Lisbon. I responded to the area of the boat launch where I observed a white vehicle parked in the parking lot by the Papermill Trail. I cleared from there a short time later to assist Lisbon PD with looking for a suspicious person on Frost Hill Ave which is the road the boat launch is on. By the time I made it around to the other end of Frost Hill Ave it was determined the suspicious person was not the suspect and was involved in an earlier complaint Lisbon PD had been dealing with.

I spent some time on the perimeter at the Ridge Rd end of Frost Hill Ave, then eventually relocated to the intersection of Lisbon St and Village St in Lisbon where I diverted traffic with Deputy Bohacik until we were

On 10/25/23 I was on duty as the Sheriff's Office Patrol Supervisor and was currently in the town of Poland. I was scanning all the police radio frequencies in the county as part of a normal routine. Most of the police agencies in Androscoggin County share the same records management system and likewise can see what each officer is responding to at any given time. Listening to each other's radio traffic is a common practice as well.

At 6:56 p.m. I heard radio traffic from the Lewiston/Auburn Communications Center indicating multiple callers were reporting shots fired at Just-In-Time Recreation (formerly and best known as Sparetime) located at 24 Mollison Way in Lewiston. Further radio traffic advised that there were multiple victims and that this was an active shooter scenario.

Corporal Nadeau radioed me asking if I had heard the Lewiston Police's dispatch traffic as he and Detective Mejia were enroute. I advised Corporal Nadeau that I too was responding. Deputy Tripp radioed to us that he was on Main St in Lewiston and responding with several Lewiston Police Units. Given the seriousness of the incident, I requested that Deputy Pealetere as well as the Mechanic Falls Police Units proceed to Sparetime as well. Deputy Bohacik, who had previously been on an unrelated traffic stop, cleared that stop and headed directly to Sparetime in addition.

At approximately 6:59 p.m. Deputy Tripp was first to arrive at Sparetime along with the Lewiston Police Units he had been responding with. A description of the active shooter was given out over the radio as a male with black hair and a hooded sweatshirt with what appeared to be a rifle.

Deputy Tripp entered the building and attempted to radio to our responding units that the male had already left and had run out the back towards the parking lot. His radio traffic was difficult to hear as he was broadcasting from inside a large building. At approximately 7:01 p.m. I heard a Lewiston Police Officer

At approximately 7:02 p.m. Deputy Tripp gave out the description of the shooter indicating he was a white male approximately six feet tall with a beard, wearing a black sweatshirt and glasses, and carrying an "AR" (AR-15) that ran out the back.

A request was also made to alert area hospitals for a mass casualty event. At 7:06 p.m. I requested the Androscoggin County Dispatch Center notify Chief Deputy Gagne and Major Cornelio of the incident as our units were going to be tied up with the active shooter incident for quite some time.

At 7:08 p.m. I was driving on Court St in Auburn when I passed at least two Auburn Police cruisers, one of which was stationary, that had not yet responded to the active shooter scene across the bridge in Lewiston for reasons unknown. (APD would eventually respond to the second active shooter scene, but not until at least 7:17 p.m.)

Also at 7:08 p.m. Deputy Bohacik radioed to our dispatch



I then radioed our dispatch to divert all remaining County units to Schemengees to assist with that scene. At 7:13 p.m. I arrived at Schemengees. Androscoggin County Dispatch radioed me that description for the shooter was possibly male with a black sweatshirt headed towards the water treatment plant. I was met and joined by other Lewiston Police Officers including Officer's Simmoneau, Zawistowski, and Caouette, who were in plain clothes and had just responded from training at their firearms range on River Rd. when they heard the call.



At approximately 7:18 p.m. I spoke with an unknown male witness who told me that shooter left in a white four door hatchback car. He couldn't tell me what type of car it was other than what he described. He said that car drove off on Lincoln St, then on to South Ave, and towards Lisbon St. I notified dispatch as to the description of the vehicle and last known location.

At 7:19 p.m. it was determined that there was active shooter on the loose and we had multiple victims inside Schemengees that needed urgent medical attention without many ambulances left to transport them. I requested dispatch consult with Chief Deputy Gagne to do a mass callout for any available Deputies to respond to Schemengees.

At 7:40 p.m. I coordinated with Lewiston Police Sergeant Joey Brown as well as Lieutenant Derrick St. Laurent in shutting down the city's bars and nightclubs. There was tremendous concern that another soft location was going to get attacked as the shooter's whereabouts were still unknown. This was the time that information had surfaced from the Sparetime location that the shooter was armed with an AR10 which shoots 7.62x51mm ammo (commonly referred to as .308 ammunition). I then had all available Deputy Sheriffs at

Schemengees regroup at the Lewiston Police Department for assignments in shutting down the city.

At 7:43 p.m. I received a call from Deputy Marshall Ryan Guay of the U.S. Marshall Service based out of Portland, ME. He had heard reports of an active shooter in Lewiston. I spoke with him, advised that there were two locations with multiple fatalities and injuries. I requested he activate his team and assist in the manhunt. That request was granted and soon U.S. Marshalls from all over the state and New England began arriving.

At 7:45 p.m. a vehicle crash was reported near the on ramp to the Turnpike off exit 80 in Lewiston. One of the vehicles reported involved was a white hatch back sedan previously described as the shooter's getaway car. Nearly a dozen Sheriff, State Police, and Lewiston cruisers responded to the on ramp however it was quickly determined that the car involved was not our suspect.

At 7:52 p.m. most of the available Sheriff units started arriving at the Lewiston Police Department for orders and assignments. There were reports of a possible active shooter at Davinci's Restaurant on Mill St in Lewiston, but that was quickly debunked as a false report. I then had Deputy Rider, Deputy Philips, Deputy Chaloux and Deputy Westleigh start visiting the local bars in Lewiston with instructions of them to shut down and/or shelter in place.

At 7:53 p.m. I received a photograph of the suspect in the mass shootings at both Sparetime and Schemengees. Officers inside Sparetime Recreation were able to review video footage and captured a still image of the active shooter. That picture was widely distributed to area law enforcement and ultimately to the public on social media pages. A second photograph was also sent out portraying the car used in the escape. It was a white Subaru with a different colored front bumper than the rear.

At approximately 8:12 p.m. reports started to come in of an active shooter at the Walmart Distribution Center in Lewiston on Goddard Rd in Lewiston. Once again, all Sheriff Units were directed towards that location. We arrived about three minutes later but saw no activity out-front or could hear anything inside. All the doors were secured and there was no one to meet us at the front entrance. There was confusion at the Distribution Center as we were hearing employees were taking shelter as there was a possible active shooter inside.

At approximately 8:20 n.m. entry was made into the facility

The entire search of the Walmart Distribution Center took nearly an hour to complete. All employees were found safe and unharmed. It was later determined that while a suspicious vehicle may have shown up outside the distribution center, there was never an active shooter.

At 9:16 p.m. a mass text was sent out from the Androscoggin Communications Center which identified Robert Card with a date of birth of the sent as the potential suspect in the mass shootings. It was said he was

operating - a white 2013 Subaru Outback.
At 9:25 p.m. all Sheriff's units were assigned to assemble at the Colisee parking lot in Lewiston. This would be the staging area for all incoming units to assist in the manhunt. Teams from Sheriff Offices, local police departments, and federal agencies all gathered and began waiting for instructions and assignments.
At approximately 10:07 p.m. we began hearing reports that the car in question was located by Lisbon Police Units on Frost Hill Ave in Lisbon by the boat launch from where the Sabattus River and the
Androscoggin River meet.
For the next two hours, myself and members of the U.S. Marshall's, along with other units would remain on the bridge on Route 196 in Lisbon overlooking the boat launch We were never told what was found in the vehicle to include a body, additional firearms, or other personal effects. I stayed on the bridge until a tow truck arrived on scene to impound the car. This would be the last time I had any formal communication or direct knowledge as to where the investigation into Robert Card was headed.
Sometime after midnight on 10/26/23 the Lisbon Police Department started to get calls of suspicious persons walking in the area or random gunshots heard. Sheriff units were dispatched to assist Lisbon in investigating those calls which mostly determined to be unfounded. I assisted Lisbon PD with checking at least two possible addresses for Robert Card on
At approximately 1:20 a.m. on 10/26/23 rumors began to circulate that a possible boat or jet ski may have been used in Card's attempt to escape.
I was advised that at 2:00 a.m. a Chief's briefing would be taken place at the command post. Several members of law enforcement on the bridge in Lisbon inquired about what was found in the car and that information was never shared with us. For the remaining three hours of my shift, I canvassed the area by vehicle looking for Card and worried that there would be another target the following day. At approximately 4:00 a.m. information began to leak out that Card's former employment was through Maine Recycling located at 61 Capital Ave in Lisbon. This location is less than a mile from where his vehicle was found at the boat launch. At approximately 5:00 a.m. a representative from Maine Recycling arrived at the roadblock on Lisbon St at

On 10/26/23 at approximately 12:00 p.m. I went back on duty and learned that more units and tactical teams were responding to Lewiston to assist in the search.

On 10/25/23, at approximately 1919 hours, I received a text message from our dispatch center advising of an active shooter at Schmengees in Lewiston. All available units were requested to respond. At approximately 1925 hours, I signed on and went to Schmengees.
While inside the structure I noted that the lights had been shut off. I recall someone asking to have the lights turned on and someone said they weren't working. I had to use my flashlight to make my way around the inside of the building.
I was asked by a Lewiston supervisor at that time to have all ASO units secure the building and not allow anyone else in. I placed Deputy Chaloux at the door. I went back to my vehicle and grabbed some crime scene tape. I taped off all entrances to the building. Lewiston units were working on taping off the perimeter.
I was then asked by Lewiston PD Spencer Simoneau to go around the parking lot and write down plate numbers for Maine State Police. Lewiston PD Parker Simoneau assisted me. These plate numbers were turned over to Detective Mike Chavez of the Maine State police.
Shortly after, a State Trooper came running up to the scene reporting that a white sedan, similar to the one seen leaving the scene, crashed at Exit 80 and units were being requested to respond. I responded to the area and was advised on my arrival that the incident was not connected to the active shooter.
I arrived back at Schmengees to offer further assistance. While at the scene, dispatch advised there was a reported active shooter at the Walmart Distribution Center in Lewiston. I responded to that scene and was the second unit to arrive. Deputy Jason Chaloux was at the employee entrance. As more units began to arrive, dispatched advised they received another call that there was an active shooter in the building. Deputy Chaloux entered the lobby and smashed the window out of a locked door so we could gain entry. I entered the building with several other officers.
While in route to the Walmart DC the suspect was identified as Robert Card . He is known to be operating a white 2013 Subaru Outback as a photo of the suspect and his vehicle was circulated to patrol.
Deputy Devon Bohacik and I split off from the group to clear a separate portion of the building. We determined the space was too large and we needed more units. No active shots were being heard or had been heard at this time. Upon entering

the cold storage area, we encountered several employees in an office to our right. We asked them about the shooter, and they described something similar to our initial call. They advised there was approximately 30 more employees on the third floor. We asked them to call them all down to the first floor so they could be cleared out of the building. They came down one by one and were also patted down for weapons.

We decided to evacuate them from the building at this point. We walked all the employees to the front entrance, including the ones sheltered in the office. While on our way out, Sgt. Jon Guay advised they had reviewed the video footage and there was no active shooter in the building, just some confusion and miss communication amongst the callers.

We were ordered to go to the Colisee in Lewiston as a staging point. While at the Colisee we received word that the suspect vehicle had been located at the Miller Park boat launch in Lisbon. ASO units decided to partner up in vehicles and respond to the area. Deputy Chris Miller and I partnered up

At approximately 0300 hours we signed off at home.

On October 25, 2023, at 7:11 PM all Androscoggin Deputies received a text from dispatch notifying us of an active shooter situation in Lewiston. I was off duty and soon left my residence en route to assist. I heard officers being told to head to Lewiston PD to stage for more information. Officers had just responded to an additional active shooter call at Divinci's Eatery that turned out to be unfounded.

While heading to Lewiston PD, I heard Deputy Dylan Rider being sent to Sabattus Street to shut down the liquor establishments. I was right in the area and assisted. We first went to the Blue Goose on Sabattus Street in Lewiston. The doors were already locked but people were inside. We made contact with people inside and told them to shut down for fear of an active shooter on the loose. They stated they heard the news and would be leaving shortly.

Deputy Rider and I went up Sabattus Street to Little Joe's Bar, also in Lewiston. We got there and found no one there. We went further up the road to Mixer's Lounge in Sabattus. We pulled into the parking lot and found the business to be closed. We decided to head back into Lewiston. On our way we heard officers out on Stetson Road in Lewiston with something suspicious. Deputy Rider and I followed a Lewiston PD officer off Russell Street down College Street. We soon heard of an armed confrontation at the Walmart Distribution Center.

We all turned around and headed towards Walmart Distribution Center. I took up a permiter position on Alfred Plourde Parkway by the intersection of Gendron Drive. I was soon met by a trooper MSP 812, Sgt. Tim Kachnovich, and Oxford Deputy William Nelson.

We monitored the building and area until the distribution center was entered by police, cleared, and all employees were allowed to exit. All officers soon cleared the area as the incident was not deeded to be related to the active shooter incidents that were previously called in. Everyone cleared and headed to stage at Lewiston PD. That directive was soon corrected to the Collisee parking lot as there were many police agencies in the area and we needed a larger staging area for all the cruisers.

While we were there some calls were coming in over Lewiston PD's radio frequency of suspicious incidents, men with a gun, and other stuff. Officers did respond and found them not related.

We later heard that Lisbon PD found a white Subaru car and confirmed the registration matched for the suspect Robert Card's vehicle. The car was parked in the area of the walking path/boat launch by the entrance to the Sabattus River. Many of the staged police responded to the area.

I went as far as the bridge on Lisbon Road, by the intersection of River Road in Lisbon where I stopped. Before the bridge on both sides of the road is a guardrail that showed fresh damage on both sides to include skids and broken glass. I assumed the suspect vehicle became disabled and limped to the parking spot it was left in. I contacted a manager of Crafts Auto Sales as they have an annex where a few of their cars are stored is right across the road from where the suspect's vehicle was found. I got a list of all the vehicles that should be in that annex lot. I sent the vehicle list to Lisbon Chief Ryan McGee just incase any were missing/stolen by the suspect. I also notified him of the evidence of a crash scene just prior to the boat launch.

I backed up the road assuming someone shut down Lisbon Road at the intersection of Mill Street. I closed the

road a bit closer to the scene as cars were still coming through. I parked on Lisbon Road at the entrance of Two Rivers Dentistry. I remained there until I was relieved by Deputy Devon Bohacik just prior to 1:30 AM. I went off duty shortly after.

The next morning just after 5:15 AM I returned to the area now at the intersection of Lisbon Road and Village Street/Webster Road shutting down Lisbon Road. Later in the day around noon time I was cleared of this duty by Deputy Gary Moulton.

I began patrolling and later went to Cedar Pond Road in Durham and looked at the riverbanks with binoculars. I went further up the road down private road James Place, which leads right across the Androscoggin River from where the suspect vehicle was found. I went to the third residence on the road which is empty and under construction. The house was empty. I walked to the shore line and viewed the riverbanks and found nothing of noting.

I went to the area of the Durham/Lisbon bridge and viewed the dam and rocky area looking for any evidence and didn't find any. I cleared the area and soon went off duty. I had no further involvement in this case.

On October 25 th , 2023, I was off duty at home when I received a call from a friend informing me of what he described as an "active shooter" at the bowling alley in the City of Lewiston. The friend who called me is identified as I have known on a personal level for many years. I began to ask questions as to what was going on as I could tell something was very wrong.
began to get my uniform on and turned on my radio when I began to hear radio traffic indicating this was in fact an
active shooter situation. I called into dispatch and informed them that I was ready to respond if a K9 team was needed. Dispatcher Alec Douquette told me to start heading toward Schemgee's Bar and Grill as they were starting to take reports of another active shooter incident at that location.
I got in my vehicle and responded to Schmengee's. Upon my arrival I observed many Police Officers from various agencies gathered in a circle in the parking lot. It appeared to me these units were developing a plan with the limited information they had. I stood by for a second to listen when I realized the suspects whereabouts were unknown and some had reported the male fleeing the scene into the woods. I feared there was a possibility we would be ambushed and instructed a Lewiston Firefighter that was nearby to get me a ladder to the roof of the building. I looked around and saw Sgt. Andrew Levesque and Officer Jeffrey Williams with the Lisbon Police Department on scene armed with rifles.
I arrived at the Wal Mart DC location and observed Deputy Jason Chaloux and Chief Eric Baker at the front door. Deputy Chaloux informed me the door was locked and they were unable to get anyone to let them in. I instructed him to break the glass in the door so we could make entry. I made this decision given the information we had at the time. It was reported there was an active shooter at this location, the doors were locked, and I could not see anyone inside the building which indicated the employees were hiding. Numerous other Officers from various area agencies had arrived at this point and we split up into small groups and began to clear sections of the building. It became apparent that this

responded to the Collisee with other Deputies from this agency. While at the Collisee it was decided that doubling up in cruisers and providing assistance in the Lisbon area was where we would be the most useful. Sgt. Travis Lovering and I partnered up in my cruiser and responded to the Lisbon area where the suspect vehicle had been located. Sgt. Lovering and I patrolled the Lisbon area for quite some time before taking up a position behind the Lisbon High School near the football field. I am familiar with the area and knew the walking trial the suspect was thought to have traveled was in close proximity to this location.

report of an active shooter at this location was likely not accurate and we regrouped at the entrance a short time later. Several groups of employees were escorted out of the building during this time. It was determined that this report was

On 10/25/2023 I was at home when I received a 911 page at 1911. An active shooter was reported in Lewiston and all units were required to respond in. I responded and was directed by dispatch to respond to Schemengees Bar and Grille in Lewiston.

Upon my arrival I met up with Dep. James Phillips who stated that there was nothing more we could do. Dep Phillips advised we were being directed to respond to LPD for further assignments. I walked back to my cruiser and made my way back to LPD where Dep Phillips and I teamed up in one car.

We were assigned to make sure Fast Breaks bar and Gridiron were closed and all the patrons were escorted out safely. While clearing Gridiron a call for an active shooter came in for the Walmart distribution center. Dep. Phillips and I responded to the Alfond Plourde parkway side of the building. Upon arrival, we assisted in clearing and moving occupants out of the building and into safety.

Dep. Phillips and I cleared Walmart and responded back to Gridiron where Dep. Phillips picked up his vehicle. Both Units responded to the Colisee where we waited until we responded to the town of Lisbon. In Lisbon at the bridge before the boat launch, I was doubled up with Cpl. Nadeau. While on the bridge a call came in about a suspicious black pick up truck with flashers on. The vehicle was pulled to the side of the road and parked Cpl. Nadeau and I made contact with the operator and his passenger.

I advised him to leave the area as she was sheltered in place and was already in a safe place. I advised him I needed him to be in a safe place as well. The operator allowed up to check his vehicle for weapons. He was turned around and sent on his way.

I was cleared from the area and the call approximately midnight.

- October 25, 2023, at approximately 1920 I, Deputy Christopher Miller was alerted of an active shooter situation
 that was occurring in the city of Lewiston. I was told there was a scene at Schmengees and "Just in time
 recreation". I was also told there was a text to all members of patrol from the Androscoggin County Sheriff's
 Office, asking for anyone to respond to both incidents. I decided to respond but needed to wait for someone to
 come to my house to watch my children.
- 2. At about 1930 I was able to leave my house and respond. I operated my vehicle with my lights and sirens activated on Route 196 in the town of Lisbon, headed towards Lewiston. My first destination was supposed to be Schmengees, as that was the closest location to me. While I was approaching the intersection of Pleasant Street and Lisbon Street, Corporal Morin advised over the radio that there was a crash on Alfred Plourde Parkway, and the Maine State Police advised it could potentially be the shooter's vehicle. I quickly changed my destination to the crash.
- 3. When I arrived at the crash, there was already multiple police vehicles on scene. I heard over the radio that the vehicle was not the shooter's vehicle. I cleared the crash. I was then told that all available units were needed to respond to the Lewiston Police Department and to await orders. While I was at the Lewiston Police Department, I was shown a picture of the shooter. I was also shown a picture of the vehicle that the shooter was using (white Subaru with a black front bumper).
- 4. Once I was at the Lewiston Police Department, I was advised that there was an active shooter at the Walmart Distribution facility. I responded to the location. I went to the front door with multiple other police officers. I could hear no gun shots coming from the business. The front door to the facility was locked. The front door was then broken by police, and we made entry. I walked through the front office area and made my way to the warehouse part. I held that position while other police officers searched and cleared the building. Employees of the business were taken to safety and brought to a secure part of the building. While units were clearing the building it became evident that the shooter was not at this business, and that this was a false report. Once the distribution center was cleared, we were told to go to the Lewiston Colisee to stage and wait for assignments.
- 5. I cleared the distribution center and started to make my way to the Colisee. While I was operating my vehicle on Lisbon Street, in the area of Golden Nozzle car wash I observed an individual walking on the sidewalk. The male was wearing clothing that matched the description given of the shooter. The male also had a backpack on and had a beard. I turned around and notified dispatch that I was out with a pedestrian matching the description of the shooter. I got out of my vehicle and had the male walk backwards towards me. The male instantly put his hands in the air and told me that he was just trying to get back to where he was staying. Corporal Barr and a Game warden arrived to assist. We searched the male for weapons, and nothing was found. I properly identified the male using his State of Maine identification. I then put the male in my police vehicle and brought him to an area motel where he was staying for the night. I then went to the Colisee.
- 6. While I was at the Colisee, I heard radio traffic from the Lisbon Police Department stating that they found a vehicle that matched the description given for the vehicle belonging to the shooter. The vehicle was parked in a parking lot at "Miller Park". That park has a small parking lot and there is a paved walking path. The walking path leaves from both ends of the parking lot, and the path goes two different directions. I am very familiar with this park as I have spent a lot of time there off duty. I awaited confirmation that the vehicle was the vehicle used in the shootings. A short time later, it was confirmed that this was the vehicle that was used. It was not clear if the vehicle was occupied or not. Corporal Morin got into to my vehicle, and we responded to Lisbon.

On October 25, 2023, I was off duty and advised via 9-1-1 page of an active shooter situation at two locations in the City of Lewiston. I responded from my residence at approximately 1925 hours. Before arriving at Schemengees Bar and Grill I was diverted to the Lewiston Police Department where I met with Sgt. Jon Guay who advised we needed to start clearing out local bars.

I went to Fishbone Bar and Grill where I met a couple of off duty Lewiston Police Officer's and the bar was cleared out. They advised me they were told of a subject walking along the train tracks behind the Just in Time shooting site and they needed units over there. I responded with the LPD units and we were diverted from there to the Walmart Distribution center. I arrived as the building was being cleared by other units and did not make entry.

We were then advised to meet at the Colisee. After we were told the suspect's vehicle was located in Lisbon I went to the area of the Lisbon Community School that was the end of a walking path from the suspects vehicle with Sgt. Schroeder. At approximately 2345 hours I was cleared by Major Cornelio due to having to work patrol the following day.

This concluded my involvement with this incident.

1. On 10/25/2023 at approximately 1857hrs. I, Deputy Devon A. Bohacik with the Androscoggin County Sheriff's Office was conducting a traffic stop on Turner Road in Auburn when I heard, via radio, that there was an active shooter at Spare Time Recreation in Lewiston. I cleared from the traffic stop and responded to Spare Time Recreation.

While responding, I was monitoring Lewiston Police Department radio traffic and learned that there were several civilians that had been shot. I arrived on scene at 1900hrs. and observed several civilians and law enforcement personnel outside of the establishment. I deployed my patrol rifle and teamed up with Cpl. Darian Nadeau and Det. Michael Mejia (both of the Androscoggin County Sheriff's Office.)

Once we were in the building, we came to a barricaded door.

Once back at Spare Time Recreation, I heard via radio that there was an active shooter at

Schemengees Bar and Grille. I then proceeded to that location and upon arriving I observed several civilians and law enforcement personnel. I assisted in putting up caution tape outside of the business and clearing out the back seat of my cruiser so I could transport people to the hospital if need be. While doing so, I then heard that DaVinci's Eatery now had an active shooter incident. I responded to this location and learned that there was no shooter at DaVinci's.

- 6. On my way back to Schemengee's Bar and Grille, I then heard via radio that the suspect vehicle had crashed near Exit 80 in Lewiston but was then advised that the crash was unrelated to this incident. I was then diverted to the Walmart Distribution Center in Lewiston with a reported sighting of the shooter. I responded to the Walmart Distribution Center with other units from the Sheriff's Office and cleared the building, evacuation several employees. I then cleared from this location and was directed to go to the Colisee in Lewiston to re-group.
- 7. Once at the Colisee, it was decided that we would pair up in a cruiser and go back out. I teamed up with Sgt. Tim Kachnovich and proceeded to Lisbon, where now we had been advised that the suspect's vehicle had been located. I remained in Lisbon with Sgt. Kachnovich until we were requested to respond to a warehouse off Rt. 196 for a suspicious condition. Sgt. Kachnovich and I responded to this warehouse and held the perimeter as a tactical team cleared the building. Once this warehouse was deemed clear, Sgt. Kachnovich and I proceeded back to Lisbon to assist in checking residences there.
- 8. Once this task was completed, I brought Sgt. Kachnovich to Cpl. Randy Williams, who both were going off-duty. I then took Cpl. William's position on Rt. 196 and conducted traffic control, not allowing any vehicle by my location. Cpl. Darian Nadeau then arrived and assisted me with this task until we were relieved by Cpl. Williams on 10/26/2023 at 0600hrs.

On 10/25/2023 I was not scheduled to work this specific day/night. At approximately 1911 hours, I received an automated text message from my dispatch center reporting there was an active shooter in the City of Lewiston and requesting any available units to respond to Sparetime and Schmengees. Prior to responding, I called into dispatch to confirm that the text message was intended to be sent and factual. Dispatcher Letourneau confirmed that there was a report of two active shooters with multiple casualties. I quickly dressed in full uniform and left my residence in my fully marked patrol cruiser.

I expedited my travel with lights and sirens. While enroute, I asked dispatch if there was any available descriptions that I could be on the lookout for with my travel time. I was advised there was no available description and directed to respond to Schemengee's. With the limited information and radio traffic, I was under the impression that the assailant was still at Schemengee's.

As I entered the City of Lewiston, I overheard radio traffic for all available units to respond to the command post at Lewiston Police Department for assignments as the location of the assailant was unknown. It was at the Lewiston Police Department I was showed a picture of the assailant, his vehicle and informed of his identity, Robert Card. While there, I partnered up with Livermore Falls Officer Maverick Real in my patrol cruiser. We than quickly drove around and shut down local establishments; Blue Goose, Little Joe's and Mixers. The only business with patrons was Blue Goose.

Throughout the evening, early morning hours, we would respond to a vary of calls which all would be determined to not hold any value of leads for the assailant Card. I overheard radio traffic of Lisbon Police Department finding Card's vehicle at their local boat launch off from Route 196.

*I did not respond to either scene of Schemengee's nor Just-In-Time.

I heard over the radio that Deputy Noyes was responding so I called him and asked him if he was able to pick me up at the Minot Post Office on Minot Avenue, he stated he would.

After being picked up by Deputy Noyes we responded to Lewiston to assist. We responded to several calls for service about possible locations and suspicious conditions. Eventually a name was distributed to all units and we were on the lookout for Robert Card. I learned from Deputy Noyes that Robert Card had been confirmed as the shooter and we were to actively look for him and his vehicle. His vehicle was later located in Lisbon at the boat launch, so we responded.

Shortly after being cleared from the boat launch we were cleared to go home by the Sheriff. As previously stated I was on vacation during the time of this call so my body camera had not been charged and was not activated during this incident.

On 10/25/23 at approximately 7:21 pm, I Deputy James P. Phillips received notification from the Androscoggin County Communications Center of an active shooter in the city of Lewiston, I received multiple notifications of an active shooter at Spare time Recreation and Schmengee's. I was off duty at my residence. Having received the notifications, I suited up and headed out.

At 7:24 pm, I signed 10-8 (in route). Dispatch advised to respond to Schmengee's in Lewiston as they need units at that location. I activated my emergency lights and siren.

At approximately 7:35 pm, I arrived in the area of Schmengee's. Due to the number of emergency vehicles in the area, I had to park down the road approximately 800 feet. I exited my vehicle and I secured and charged my long rifle.

Once at the parking lot, I made contact with Deputy Bohacik, Deputy Tripp, Cpl. Morin, Cpl. Nadeau, and Sgt. Guay. Shortly after arriving, Sgt. Guay advised that we were going to respond to the Lewiston Police Department and reorganize our efforts as needed. Sgt. Brown of the Lewiston Police Department asked that we split up and start responding to local dining establishments and bars to have them shut down for the night and to safely return to their residences.

We responded to the Lewiston Police Department. While staged at this location, Deputy Westleigh and I joined forces, and we took her vehicle #127. We responded to Fast Breaks and the Gridiron Restaurant and Pub. Both locations had already been notified to close for the evening and to return to their residences.

At this time, we cleared, and we started making our way back to the Lewiston Police Department. While in route, we received notices of a reported active shooter at the Wal-Mart Distribution Center on Alfred Plourde Parkway in Lewiston. We immediately responded to that location.

Upon arrival to the Walmart Distribution Center, we made our way to the main entrance. Once at the main entrance, we entered the building. Dep. Westleigh and I stayed at the main entrance, and we secured all employees that made their way safely to us.

Once the building was cleared, we responded back to the Lewiston Police Department.

At this time, we returned to the Lewiston Police Department. We were asked to respond to the parking lot of the Lewiston Colisee, as they are establishing a staging point. I took my vehicle #113 to the Colisee. Once at the Colisee all Androscoggin County units met up, along with several others from smaller departments. We received notification from our command staff that the suspect has been identified. The suspect being a Robert Card and he is operating a white 2013 Subaru Outback, with a black front bumper.

While at the Colisee, we heard the Lisbon Police Department report that they had located the suspects' vehicle at the boat launch on Frost Hill Avenue and Lisbon Street.

Upon arrival to the town of Lisbon, we patrolled the northwest portion of the town as a walking path goes north



I Deputy Jason was working for the Androscoggin County Sheriff's Office, I was in a Sheriff's Office polo with my bullet proof vest over that and driving an unmarked cruiser vehicle.

At 1911 on 10/25/23 I was at my residence when I received a 911 page text message stating "units required for road; 2 active shooter situations in Lewiston; any available units respond; Sparetime and Schemengees". At this time I was not sure if this was a hoaxed text or if it was real and I attempted to call the Androscoggin County Communication's Center. The phone just kept ringing and ringing I then hung up the phone and called Director Martin Fournier direct on his cell phone. I asked him "is this was real?" He replied yes and respond immediately! I then grabbed my Androscoggin County Polo put it on and put on my vest over that and grabbed my rifle and left the house. When I signed 10-8 (in service) I was informed to respond to Schemengees Bar & Grill at 551 Lincoln St Lewiston. As I turned onto Lincoln Street I noticed many police cars, fire engines, and various other emergency vehicles all with lights on all down. .incoln Street, I arrived on scene at about 1925.

I had to stop about 200 feet from the building due to all the emergency vehicles. I exited my vehicle with my rifle and proceeded to run down to the entrance of the building. At this time I saw people running all over the place to include in and out of the building. I asked who was in charge and got no answer. I then asked what was needed for me to do and I was informed to go help get the wounded out of the building.

the box but we could not locate it and then went back outside. At this time we had the male explain to us again were he turned off the power he then told us that he could show us. I believe it was Corporal Jeremy Somma from Lewiston Police Department who asked if he was the owner or worker of Schemengees. He stated that he was not and only a customer who was there when the shooting started and that he hide in that closet and noticed the power box and cut the power to the building. He explained where it was one more time to Corporal Somma and I and we then went back into the building to look for the power switch. This time we were able to locate the closet that was off of the private dining area. The power was turned back on and we exited the building. When I got back to the door Corporal Somma continued down the stairs and I stood by Corporal Kavanagh. I noticed at this time that the male was now gone. A few moments later a male that was at the rear of the building in the tree line yelled out to turn the power back off. I do not know who this male is or who he worked for but I went back into the building and turned the power back off once again and exited the building. A few minutes went by and I was standing back next to Corporal Kavanagh and a dispatch call came in that there was an active shooter at Davinci's restaurant which is only down the road from our location. I noticed numerous police vehicles take off in that direction and I decided to stay back at this time. We also heard that there was also State Police in the area as well and they are responding. Moments later another call came in from dispatch that there is an active shooter at the Wal-Mart Distribution Center which is also right up the road from us. At this time I noticed only 1 police vehicle responding to that location. I asked Corporal Kavanagh if he was all set and that I would respond to that location as we only saw one police vehicle responding. Corporal Kavanagh stated go and I'm good here. I then ran to my vehicle and followed the other cruiser up Lincoln Street, I did not noticed what agency it was from but it continued on to the right on River Road. I took a left onto Goddard Road and followed that to Alfred Plourde Parkway where I took a right and went into the employee's entrance of the Wal-Mart Distribution Center.

At this time I pulled up to the front of the door and took cover behind my vehicle as I was the first person on scene at this location. I could see down the hallway and observed no movement or anyone in the area. I radioed into the Androscoggin County Communications that I was the only person at this location and that I'll be waiting for back up. I held this position for a few moments and Sergeant Jon Guay and Corporal Morin arrived to back me up. We went through the first set of sliding glass doors as they opened and on the second set of sliding glass doors they were locked and did not open. I retrieved an ASP that I had in my vehicle and was instructed by Corporal Morin to break the door to gain entry. At this time I hit the door about three times and the door window smashed. I then cleaned the glass off of the frame so no one would cut themselves as they entered the building. I was first into the building followed by Chief Michael Baker of Sabattus Police Department.

A short while later we started receiving pictures of the active shooter from Just in Time bowling alley. This male was later identified as Robert Card As employees were being discovered and coming out of there hiding place I patted them down for weapons and to be sure they were not the suspect we were looking for. I was at the Wal-Mart Distribution Center for about an hour before Sergeant Guay informed me to go to the Colisee in Lewiston on Birch Street for a meeting place and to get our next assignment. I then drove the Colisee and met up with other Deputies from the Androscoggin County Sheriff's Office.

At the Colisee I received a phone call from who I was in the Army Reserves with and he informed me that he knows Robert Card. At this time Robert was all over social media and the news as he was an active shooter and wanted.

I stated that I would pass the information on up the proper channels.

After hanging up the phone I noticed what appeared to be a Maine State Police Tact Team member standing in a group with other Maine State Police members. I asked if he was part of the Tact Team and he stated yes and I then stated what I had just heard. He acknowledge me but did not really talk to me and I walked off with no further contact with the members. I went back where other Deputies were standing and it was decided that we would pair up in vehicles and go drive around the city looking for the suspect's vehicle. I teamed up with Deputy Robert Murphy in his vehicle and we exited the Colisee. A few minutes after we left the parking lot we got alerted that the suspect vehicle was located at the Lisbon Falls boat launch on Route 196.

A short while later Lisbon

Communications was getting numerous calls of suspicious persons/vehicles all over the area where the vehicle was located. Deputy Murphy and I were dispatched to Springworks Farm for a person in the building. Springworks Farm is only about a mile from where the suspect vehicle was located. Deputy Murphy and I arrived on scene and secured the front of the building. The owner of the building came over and spoke to Deputy Murphy as I walked a little further down to secure the back side of the building as well. I later learned that the owner heard that there was a mass shooting in Lewiston and that the suspect vehicle was located a short distance away. He stated that he opened all the doors in the building so if a door shut he would know someone was in it as he is the only one working. While he was working he heard a door slam and noticed that the bathroom door was now shut. He stated that he then call Lisbon Dispatch and exited the building. A few minutes later Chief Ryan Mcgee arrived on scene as well as Sergeant Timothy Kachnovich and Deputy Devon Bohacik. Chief Mcgee sent two of his officers to the back of the building and Sergeant Kachnovich and Deputy Bohacik moved to the side of the building on the wood line side, Deputy Murphy and I stayed in the front of the building securing the front door.

I returned to my vehicle that was parked at the Colisee and informed to help Lewiston Police Department clear up some pending calls they had. I had no other interaction involving this case on this day.

I activated my blue emergency lights and started to the location. Dispatch was notified by Cpl. Nadeau who had also heard the radio traffic from Lewiston. As I was on my way to the location, there were two Lewiston PD units in front of me. Once out on scene, I deployed my rifle, met with Officer Parker Simoneau of Lewiston PD at the entrance to the bowling alley. Once we got to the corner of the building, we saw other Lewiston PD units approaching from the opposite side of the building, also heading toward the main entrance. Officer Simoneau and I made our way into the building through the main entry doors. We were not able to get inside the bowling alley due to the doors being locked. Other Lewiston PD units arrived on scene. I told one of them to come with me and we cleared the kitchen. Once the kitchen was clear, I moved to the walk-in freezer. Once outside, we cleared the vehicles in the parking lot. I moved my cruiser to the entrance to the plant. Officer Pealatere stopped by my cruiser. I told him what I learned and that we were going to clear the area and work our way back up to Schmengee's. Once the area was cleared, we made our way into the parking lot of Schmengee's. I started clearing vehicles. There were several people out in the parking lot near vehicles. Some on their phones, others talking to each other. There was one that was backed out of a parking space with nobody inside it. On 10/25/2023 at approximately 1911hrs, I received a text message on my cell phone from the Sheriff's Office. It was an automated message, "units required for road; 2 active shooter situations in Lewiston". I got dressed into my department uniform and immediately responded. Just after letting dispatch know, I was enroute, Deputy Gregory Mailhot called me on my cell phone. He advised that he was on vacation and therefor didn't have his cruiser, so asked if I could pick him up on my way to the active shooter incident. I picked Deputy Mailhot up in Minot moments after speaking with him on the phone.

The active shooter incidents took place at Just in Time Bowley Alley and Schmengees' Pool Hall. As Deputy Mailhot and I responded, dispatch had advised any available units to respond to Schmengees', as the scene had been secured at the bowling alley.

While responding to Schmengees', dispatch reported that anyone not currently at a scene, respond to the Stetson Rd. in Lewiston, for a possible sighting of the shooter. I immediately responded to the Stetson Rd. in Lewiston, where I met with a group of other officers, developing a plan to search the area of the railroad tracks. Before beginning any search, dispatch then reported that they were taking reports that the active shooter was now in the Walmart Distribution Center in Lewiston. Deputy Mailhot and I, along with several other officers, left the Stetson Rd. and responded to the Wal-Mart distribution center on Alfred A. Plourde Pkwy, in Lewiston.

Upon arrival, there was already a team of officers that had entered the distribution center to clear it. While speaking with other officers outside the distribution center, another report came in that there could be another active shooter at 10 Wakefield Street in Lewiston. Deputy Mailhot and I began to respond to that scene as the report came in. Before we could arrive at Wakefield Street, another officer had cleared the area advising it was in fact not another scene.

By this time, enough of the public was aware of the active shooter, and now other reports were coming in of possible suspects and locations.

Deputy Mailhot and I responded to the Olive Garden restaurant in Auburn, after dispatch had reported the restaurant had called in a man outside with a bullet proof vest on. We arrived on scene and had noted an Auburn Police car just leaving the area. We did not observe anyone outside of the restaurant at that time.

Deputy Mailhot and I started to head toward the Lewiston Police Department to make contact with the command post and get further assignments. While on the way to the command post, dispatch put out that the shooter had been identified as Robert Card and added that he was possibly operating a white Subaru Outback station wagon with a different colored front bumper.

Once I arrived at the command post, I met with Major Cornelio who asked me to identify Card's vehicle from security camera footage.
Shortly after providing information to the Maine State Police, Sheriff Eric Samson, Deputy Mailhot, and I all left the command post in my cruiser.
We checked Card's most recent employer's parking lot to see if we could locate his vehicle there. The vehicle was not in the parking lot. As soon as we left the parking lot, dispatch reported that they were receiving a call that someone was live streaming the active shooter at the Rusty Lantern Convenience store in Sabattus. We immediately began responding to the store with lights and siren activated. Before being able to get to the store, other officers had cleared the area, and advised there was not active shooter event at that location.
Immediately after discontinuing the response to the Rusty Lantern store, dispatch advised that Card's vehicle had been located at the boat launch at the intersection of Rt. 196 and Frost Hill Ave. in Lisbon.
I went home at 0200hrs per the direction of our representative at the command post and was available for call out from there.


Details:

- 1. On 10/25/2023 at approximately 1911hrs I was contacted by Dispatch via a page to my cellphone informing me on an active shooter incident in Lewiston. I was the state of at a local restaurant with my family and had to return home to get my cruiser and gear.
- 2. I signed on at approximately 1930hrs and was told by dispatch to report to Schmengees Bar and Grill.
- 3. Just prior to arriving at Schmengees I was told that all units could clear that location, the resources on scene were adequate. I was told to return to the Lewiston Police Department to re-group and come up with a plan. Prior, to returning to the Lewiston Police Department, at approximately 1945hrs, dispatch notified units about a car crash at exit 80 on Alfred A. Plourde Parkway.
- 4. It was initially reported that the crash near exit 80 was the suspect vehicle from the shootings however, just as I arrived on scene, I learned that the crash was unrelated.
- 5. As I began to return to the Lewiston Police Department, at approximately 1950hrs, I was told by dispatch that there was report of another active shooter at DaVinci's Eatery on Mill Street in Lewiston.
- 6. I arrived on scene at DaVinci's Eatery along with several Auburn Police Department units and Trooper Jason Wing. It did not appear that there was any disturbance at DaVinci's Eatery however, it was decided that we would clear the building to confirm that there was no threat.

On Wednesday, October 25, 2023, I, Deputy Zachary West was off duty when I received an alert of an active shooter in Lewiston via 911 text. I put myself on duty and went to Lewiston. Upon arriving in Lewiston a photograph of the suspect and vehicle description had been sent out via email. I checked the surrounding area and towns for the suspect and vehicle. At approximately 10:00 p.m. information was received that the suspect's vehicle was located in the town of Lisbon. I responded to the town of Lisbon and was instructed to shut the intersection down at Frost Hill Ave and Sunset Ave while a perimeter was being set up. I remained at Sunset Ave and Frost Hill until 2:00 a.m. when I was relieved. This was the end of my involvement with the case.

On the above date and approximate time, I was assisting Cpl. Darian Nadeau on College Road in the Town of Greene at a car vs deer motor vehicle crash when suddenly a call for an active shooter in Lewiston was dispatched. Dispatch radio traffic indicated that there was multiple 911 calls reporting someone at the Lewiston bowling alley shooting people. Cpl. Nadeau and I responded to the scene. Upon arrival at the bowling alley, I equipped myself with my department-issued body armor and rifle and responded to a point of entry at the side of the building where I could see activity.

By walking between the bowling pin machinery, Cpl. Nadeau and I entered into the main bowling area and down the bowling lanes towards the front counter.

For what I recall to be only a short few moments of triaging the scene, a second call came over the radio reporting an active shooter at Schemengees Bar & Grill in Lewiston. I returned to my cruiser and expedited to the scene at Schemengees on Lincon Street. On arrival the suspect had yet to be located and there were conflicting reports of where he was last seen

While still at Schemengees, information started to form about a suspect vehicle. There was mention of a white hatchback vehicle being involved and a short time later a report came in that a white hatchback had crashed near one of the exits on the highway. I responded to that scene however it was determined that this crash was not related and it was not the suspect vehicle.

I learned of a post setup at the Lewiston Police Department where officers were re-grouping for assignments. Just as I arrived at Lewiston Police Department, there was a report of a shooter at the Walmart Distribution Center. I responded with several others to the distribution center but upon arrival could not see any sign of a disturbance and the building was secured. As we stood at the locked front door,

The decision was made to break the glass out of the front door at the distribution center and make entry into the building. Myself and several other law enforcement officers searched the main floor and evacuated 30-40 employees that had been hiding under the belief that there was a shooter present. We did not locate any threats or any injured. After thorough review of video footage from the camera system at the business it was determined that although there had been a suspicious male that showed up at the front door, the shooter was never on site at the distribution center.

I later learned that the suspects vehicle had been located at a boat launch in Lisbon. The vehicle was found to be empty with no sighting of the suspect. I remained available and on patrol in the Lisbon area with Det. Nate McNally before eventually securing around 4:00 AM. In the following days I responded to the command post at the Lewiston High School each day and assisted as part of a response team to investigate any complaints or reported sightings. I continued to assist as I could until eventually receiving report that the suspect was located deceased.

On 10/25/2023 at approximately 7:11 PM, I received a notification from the Androscoggin County Regional Communications Center of two active shooter events at Spare Time (Just in Time) and Schmengees Bar and Grille.

I signed en route at 7:26 PM and arrived to Schmengees sometime prior to 7:40 PM. Upon my arrival, I found most of the injured had been transported.

While doing this, I heard several people yelling out there was a car crash at Exit 80 involving a white sedan. Dozens of patrol units responded to the crash and determined it was not involved.

Shortly afterwards, someone called out about an active shooter at DaVinci's Restaurant, dozens of officers left Schmengees in that direction only to be cancelled moments later when it was confirmed not to be an active shooter situation. I am not certain as to the origin for the report.

Very soon after the all clear was given for Davinci's.

Maine State Police Major Crimes Detective Michael Chavez was posted near the front door of Schmengees when I cleared for reports of an active shooter at the Wal-Mart Distribution Center off from Alfred A Plourde Parkway in Lewiston. This report came in somewhere around 8:12 PM. Numerous deputies from the Androscoggin County Sheriff's Office responded. Upon my arrival at around 8:16 PM, I saw Deputy Jason Chaloux at the front door. He advised no one was coming to the door which was locked. He smashed out the front door with a baton and we made entry.

Once we made our way to the back of the warehouse. I positioned myself near the hallway exit so I had direction communication with other ASO deputies as well as officers at the front entrance.

Employees were escorted out towards me. I spoke to a good percentage of them asking if they had seen anyone with a gun or if they had heard gunfire. All of the employees told me they did not see/hear anything. After the employees were escorted to the front of the building, Sabattus Chief Erik Baker, Det. Michael Mejia and I went with to his office where he was able to access video.

In summary, the video shows a maroon sedan racing through the parking lot before pulling up very close to the front door. The driver exits the vehicle leaving the drivers door open and walks into the foyer area. Since the building has restricted access, this subject was not able to get any further into the building. An employee is seen speaking with the subject before they both briskly leave the building.

provides some context to what was occurring with the unknown subject showed up.

In the video, you can see employees run from a front office area when the unknown subject enters the building. It's likely this is what trigger a moment of panic and spread of misinformation. There were

at least two 911 calls reporting a man with a gun and an "active shooter". At some point there was a report of two individuals with one being armed with a firearm and of middle-eastern descent. I do not know where those reports originated from.

While reviewing the video, I took several still images of the unknown subject and vehicle he was driving. The subject did not have a gun in his hand but did have a cell phone in his right hand.

Later, I noted similarities with the way the unknown person pulled up to the front doors of the building just like the shooter did at Schmengees and Spare Time. At this time, there is no indication the two events are related and I can say with certainty the person who entered the Wal-Mart Distribution Center was not Robert Card.

I provided all of my information to include still images to Lewiston PD Cpl. Brian Beauparlant who was responsible for documenting the Wal-Mart incident. Sometime between 8:30 and 9:00 PM, deputies cleared the Distribution Center, all ASO units were directed to the Colisee where all law enforcement was waiting further instructions. The first "BOLO" for Robert Card was documented at around 9:18 PM to include a possible vehicle description. The vehicle was a white 2013 Subaru Outback with a black front bumper.

While at the Colisee, Chief Deputy William Gagne emailed all deputies photos of Card and the vehicle.

Our units waited there without instruction so it was decided for all deputies to double up in patrol vehicles to conduct roaming patrols and respond to any possible sightings of Robert Card. Det. Mejia paired up with me and we utilized V109 for patrols. V109 is not equipped with a dash camera and neither of us are issued a body camera therefore no audio/video footage is available from either of us.

At around 9:57 PM, Lisbon PD advised they located what they believed to be Card's Subaru at a boat launch off from Route 196 in Lisbon.

Det. Mejia and I remained in the area and stationed ourselves for several hours on Webster Road at Upland Road. There were no sightings of Card, leads or updates for the remainder of the night. Det. Mejia and I secured at around 4:30 AM.

Det. Mejia and I met at the Command Post which had been set up at Lewiston High School. We had initially been told to be there for 9:00 AM for a briefing. We arrived only to find out a briefing was held at 8:00 AM I

while there, we teamed up with officers from Jay PD. Det. Mejia and I left the command post with the Jay PD units without assignment.

While on roaming patrol in Lisbon, we stopped a suspicious person on Route 9 close to the Route 196 intersection. The individual was identified and notification was made to Lisbon PD on his identify and where he was headed. Shortly after, we were asked to go relieve Sgt. Smith and his crew

on Frost Hill Ave in close proximity to the boat launch in Lisbon. After relieving Set. Smith, we

A SMS was sent and no response. The dispatcher reported on one of the calls he heard a loud thumping noise along with vehicles driving by.

On October 25, 2023, while off duty and at home I received a text message from dispatch requesting all available units to respond to Lewiston for the report of two active shooter situations. The messaged indicated Schmengees and Spare time were the locations to respond to. After receiving the message, I quickly got ready and left my residence in my fully marked police vehicle.

While driving south on the Turnpike near exit 80 I overheard dispatch advise the suspect vehicle had possibly crashed in the area of exit 80 which is the Lewiston exit. I exited the Turnpike and immediately noticed numerous police vehicles surrounding a car. It was quickly learned that the car was not the suspects.

After clearing from the Turnpike, I was told to go to the Lewiston Police Department to receive further information and instructions. While there for a very short time I was dispatched along with several other officers to the area of Stetson Road in Lewiston. We were sent there due to the report of a suspicious individual near the train tracks.





At approximately 3:00 a.m. I returned home. This concluded my involvement.





On 10/25/23 I was on duty as the Sheriff's Office Patrol Supervisor and was currently in the town of Poland. I was scanning all the police radio frequencies in the county as part of a normal routine. Most of the police agencies in Androscoggin County share the same records management system and likewise can see what each officer is responding to at any given time. Listening to each other's radio traffic is a common practice as well.

At 6:56 p.m. I heard radio traffic from the Lewiston/Auburn Communications Center indicating multiple callers were reporting shots fired at Just-In-Time Recreation (formerly and best known as Sparetime Recreation) located at 24 Mollison Way in Lewiston.

Corporal Nadeau radioed me asking if I had heard the Lewiston Police's dispatch traffic as he and Detective Mejia were enroute. I advised Corporal Nadeau that I too was responding. Deputy Tripp radioed to us that he was on Main St in Lewiston and responding with several Lewiston Police Units. Given the seriousness of the incident, I requested that Deputy Pealetere as well as the Mechanic Falls Police Units proceed to Sparetime as well. Deputy Bohacik, who had previously been on an unrelated traffic stop, cleared that stop and headed directly to Sparetime in addition.

At approximately 6:59 p.m. Deputy Tripp was first to arrive at Sparetime along with the Lewiston Police Units he had been responding with. A description of the active shooter was given out over the radio as a male with black hair and a hooded sweatshirt with what appeared to be a rifle.

Deputy Tripp entered the building and attempted to radio to our responding units that the male had already left and had run out the back towards the parking lot. His radio traffic was difficult to hear as he was broadcasting from inside a large building.

At approximately 7:02 p.m. Deputy Tripp gave out the description of the shooter indicating he was a white male approximately six feet tall with a beard, wearing a black sweatshirt and glasses, and carrying an "AR" (AR-15) that ran out the back.

At 7:08 p.m. Deputy Bohacik

I radioed to Deputy Bohacik if there was a known location on the shooter. He responded in telling me that he didn't have a good location for him at that time.

At 7:10 the Lewiston Auburn Communications Center radioed to all units that they were taking multiple calls for another active shooter at Schemengees located at 545 Lincoln St in Lewiston. I then radioed our dispatch to divert all remaining County units to Schemengees to assist with that scene. At 7:13 p.m. I arrived at Schemengees. Androscoggin County Dispatch radioed me that description for the shooter was possibly male

with a black sweatshirt headed towards the water treatment plant. I was met and joined by other Lewiston Police Officers including Officer's Simmoneau, Zawistowski, and Caouette, who were in plain clothes and had just responded from training at their firearms range on River Rd. when they heard the call.
The shooter was not found inside Schemengees nor the immediate area outside.
At approximately 7:18 p.m. I spoke with an unknown male witness who told me that shooter left in a white four door hatchback car. He couldn't tell me what type of car it was other than what he described. He said that car drove off on Lincoln St, then on to South Ave, and towards Lisbon St. I notified dispatch as to the description of the vehicle and last known location.

At 7:40 p.m. I coordinated with Lewiston Police Sergeant Joey Brown as well as Lieutenant Derrick St. Laurent in shutting down the city's bars and nightclubs. There was tremendous concern that another soft location was going to get attacked as the shooter's whereabouts were still unknown. This was the time that information had surfaced from the Sparetime location that the shooter was armed with an AR10 which shoots 7.62x51mm ammo (commonly referred to as .308 ammunition). I then had all available Deputy Sheriffs at Schemengees regroup at the Lewiston Police Department for assignments in shutting down the city.

At 7:43 p.m. I received a call from Deputy Marshall Ryan Guay of the U.S. Marshall Service based out of Portland, ME. He had heard reports of an active shooter in Lewiston. I spoke with him, advised that there were two locations with multiple fatalities and injuries. I requested he activate his team and assist in the manhunt. That request was granted and soon U.S. Marshalls from all over the state and New England began arriving.

At 7:45 p.m. a vehicle crash was reported near the on ramp to the Turnpike off exit 80 in Lewiston. One of the vehicles reported involved was a white hatch back sedan previously described as the shooter's getaway

car. Nearly a dozen Sheriff, State Police, and Lewiston cruisers responded to the on ramp however it was quickly determined that the car involved was not our suspect.

At 7:52 p.m. most of the available Sheriff units started arriving at the Lewiston Police Department for orders and assignments. There were reports of a possible active shooter at Davinci's Restaurant on Mill St in Lewiston, but that was quickly debunked as a false report. I then had Deputy Rider, Deputy Philips, Deputy Chaloux and Deputy Westleigh start visiting the local bars in Lewiston with instructions of them to shut down and/or shelter in place.

At 7:53 p.m. I received a photograph of the suspect in the mass shootings at both Sparetime and Schemengees. Officers inside Sparetime Recreation were able to review video footage and captured a still image of the active shooter. That picture was widely distributed to area law enforcement and ultimately to the public on social media pages. A second photograph was also sent out portraying the car used in the escape. It was a white Subaru with a different colored front bumper than the rear.

At approximately 8:12 p.m. reports started to come in of an active shooter at the Walmart Distribution Center in Lewiston on Goddard Rd in Lewiston. Once again, all Sheriff Units were directed towards that location. We arrived about three minutes later but saw no activity out-front or could hear anything inside. All the doors were secured and there was no one to meet us at the front entrance. There was confusion at the Distribution Center as we were hearing employees were taking shelter as there was a possible active shooter inside.

At approximately 8:20 p.m. entry was made into the facility. Detective Mejia, two Maine State Police Tac Team Units and I then started to clear the entire dry side of the facility as other officers began searching the refrigerated side. The WalMart D.C. is a very large facility covering the equivalent of 8-10 football fields. While searching Walmart D.C., we came across several employees who had hid themselves and were escorted to safety.

The entire search of the Walmart Distribution Center took nearly an hour to complete. All employees were found safe and unharmed. It was later determined that while a suspicious vehicle may have shown up outside the distribution center, there was never an active shooter.

At 9:25 p.m. all Sheriff's units were assigned to assemble at the Colisee parking lot in Lewiston. This would be the staging area for all incoming units to assist in the manhunt. Teams from Sheriff Offices, local police departments, and federal agencies all gathered and began waiting for instructions and assignments.

At approximately 10:07 p.m. we began hearing reports that the car in question was located by Lisbon Police Units on Frost Hill Ave in Lisbon by the boat launch from where the Sabattus River and the Androscoggin River meet.

I stayed on the bridge until a tow truck arrived on scene to impound the car. I would not have any direct knowledge as to the progress of the manhunt from this point on.
Sometime after midnight on 10/26/23 the Lisbon Police Department started to get calls of suspicious persons walking in the area or random gunshots heard. Sheriff units were dispatched to assist Lisbon in investigating those calls which mostly determined to be unfounded. I assisted Lisbon PD with checking at least two possible addresses for Robert Card
At approximately 1:20 a,m, on 10/26/23 rumors began to circulate that a possible boat or jet ski may have been used in Card's attempt to escape. I joined members Those searches didn't produce any results or clues.
At approximately 4:00 a.m. I learned from other officers that Card's former employment was through Maine Recycling located at 61 Capital Ave in Lisbon. This location is less than a mile from where his vehicle was found at the boat launch. At approximately 5:00 a.m. a representative from Maine Recycling arrived at the roadblock on Lisbon St at Graziano Square where some of my Deputies were stationed. This gentleman was allowed through as a v.i.p.
On 10/26/23 at approximately 12:00 p.m. I went back on duty and learned that more units and tactical
teams were responding to Lewiston to assist in the search.
Sometime in the afternoon of 10/26/23 A bolo was put out on area mobile data terminals to locate and stop him. He was eventually found by Lewiston police Unknown what his involvement was, if any.
At approximately 5:00 p.m. I learned via Fox News that a residence on Bowdoin was the scene of a large police response and sounds of explosions.
At approximately 8:00 p.m. I was asked to call a Border Patrol Agent for a special request and was given a phone number.

Throughout the next ten hours Deputies responded to several calls of gunshots and suspicious incident reports in Durham and surrounding communities as residents sheltered in place and businesses in Androscoggin County were closed. Opening day for deer hunting in Maine was on 10/28/23 and most of the gunshot calls could be attributed to hunters sighting in their rifles.

Many of the suspicious vehicle reports were resolved as unmarked law enforcement cars with out of state plates conducting their own investigations and searches.

Various wooded areas and banks of rivers were scarched again without success.

On 10/27/23 at 11:56 a.m.

They found the person who had mistakenly

called 911 and cleared without incident.

On 10/27/23 at 7:42 p.m. a mass text was sent out to available Deputies for help in conducting a line search at the boat launch the following day. Deputies were asked to assemble at the Lewiston High School command post the following morning at 7:30 a.m.

At 9:22 p.m. a mass text was sent to Sheriff Deputies that Robert Card had been found deceased.

The line search was subsequently canceled.

This ends my involvement with this case.
