NOW COMES the undersigned attorney for the State of Maine pursuant to M.R.U. Crim. P. 6(h) and certifies to the Court as follows:

1) As necessary to assist in the performance of my duty to enforce the criminal laws of the State of Maine, I have disclosed to members of the Maine State Police and Federal Bureau of Investigations matters occurring before the Grand Jury, namely materials provided in response to a Grand Jury subpoena to produce business records (basic account information and connection logs) which was issued to Meta Platforms, Inc. on October 27, 2023.

2) I have advised the members of the Maine State Police and Federal Bureau of Investigations that the Grand Jury materials may not be utilized for any purpose other than assisting the State's attorney to enforce the State's criminal laws, and that there exists an obligation of secrecy prohibiting the law enforcement officers from disclosing the Grand Jury materials to others, except as provided by Rule 6 of the Maine Rules of Unified Criminal Procedure or when so directed by the Court.
