## *BRUNSWICK POLICE SPECIAL RESPONSE TEAM*

### LEWISTON ACTIVE SHOOTER

#### AFTER ACTION REPORT

#### OVERVIEW

On 10/25/2023 at approximately 2000 hours SRT was activated to respond to Lewiston to assist with an Active Shooter situation. Earlier in the evening, at approximately 1930 hours, Lewiston PD reported an active shooter at two locations in their city with multiple fatalities. The shooter was still on the run. Multiple agencies responded.

#### SITUATION

Lewiston PD had reported two active shooter events at approximately 1930 hours. One event occurred at Sparetime Bowling alley and the other was at Schemengees Bar and Grille. Multiple agencies from Maine and surrounding states responded to the area. The shooter, later identified as Robert Card, was reported to still be on the loose. Brunswick SRT was activated via page at approximately 2000 hours and responded to the PD and then to the Lewiston Area to assist.

SRT operators remained on scene in the Lewiston area until approximately 0300 hours on 10/26/23. SRT was deployed back to Lewiston to assist later on 10/26 and again on 10/27/23. See Mission details below.

#### MISSION

##### **10/25/2023 (Per Lt Verrill)**

On 10/25/2023, Brunswick SRT was activated at 1957 hrs to respond to the Brunswick Police Department to prepare for deployment to the Lewiston area. Prior to the callout, agencies had responded to two locations in Lewiston for an active shooter situation involving many casualties and injured people. The suspect was still at large. Brunswick SRT responded to the staging area in Lewiston at the parking lot of the Colisee. There we were given a location near St. Marys hospital to stage as [REDACTED] if the suspect or suspect vehicle was located.

A short time later, the suspect's vehicle was found located in Lisbon. The team was then reassigned to a staging area at the intersection of Route 9 and Frost Hill in Lisbon. The team cleared some of the exteriors of the properties within the immediate area of the intersection and waited for any further assignments.

At approximately 0300 hrs on the morning of the 26th, SRT was sent home and told to be on standby for later in the day.

**10/26/2023**

On 10/26 SRT was put on High Ready Standby for deployment to Lewiston at 0705 hours by Commander Rinaldi. TL O'Connor and ATL Verrill responded to the Command Post at Lewiston High School at approximately 1100 hours and met with Chief Stewart and Commanders Rinaldi and Hansen. At 1207 hours SRT was activated and deployed to the Command Post in Lewiston.

Later in the day Brunswick SRT and Portland SRT were given a joint mission to clear the Maine Recycling building. We were advised this was an outstanding location to be checked on a list of locations created by State Police Major Crimes. We were advised that the state police [REDACTED] would be clearing a trail behind the property near the water while we cleared the building.

Brunswick SRT and Portland SRT traveled together to Lisbon to the Maine Recycling building [REDACTED]. Upon arrival of both teams Portland SRT left to check a suspicious male in an area nearby. Brunswick SRT began to clear the exterior trailers on the lot of Maine Recycling. Portland SRT returned as we completed clearing the trailers and both teams moved to the rear of the building to an open door to make entry.

Several members of both teams remained outside holding security while the remaining members of PPD SRT and BPD SRT entered Maine Recycling and cleared the building. A workshop/garage on the property was also cleared.

Sgt Moir and MW Sylvain were [REDACTED]. A storage unit located across the street was found open and was also checked. Nothing was located.

Nothing of significance was located in either building or any of the trailers. [REDACTED] [REDACTED]. SRT stood by awaiting additional assignments. SRT was relieved from the CP at approximately 1830 hours.

**10/27/2023**

SRT responded to the CP at approximately 0800 hours on 10/27. BPD SRT was again paired with PPD SRT and assigned to clear a residence and property [REDACTED] [REDACTED]. Information provided to us was that [REDACTED] [REDACTED]

[REDACTED] There was additional intel there might be deer blinds and stands in the adjacent woods.

Upon arrival Both teams [REDACTED] [REDACTED]. PPD's [REDACTED] into the [REDACTED]

driveway and began to loud hail to anyone in the residence. This was carried out for approximately 15 minutes. During this time [REDACTED] [REDACTED] There was no response from inside the residence to any of the hailing or sirens. PPD also had a [REDACTED] [REDACTED].

PPD SRT Commander Goodman was eventually able to make contact with the resident, who was not at home at the time. [REDACTED] [REDACTED] TL O'Connor and ATL Verrill linked up with PPD SRT members, [REDACTED] [REDACTED]. Nothing of significance was located.

Once cleared all team members exited the house [REDACTED] [REDACTED]. The woods were then cleared [REDACTED] [REDACTED] Nothing of significance was found during the woods search.

The barn at [REDACTED] was also cleared.

**October 25, 2023**

On this date, I, Detective Sergeant William Moir, was off duty when I became aware of a mass casualty shooting incident in Lewiston. I was directed to respond to the Brunswick Police Department.

Once at the station, I geared up and participated in a briefing. I was directed, along with other officers to respond to the Lewiston Police Department. I rode with Det. Justin Kittredge in his unmarked Ford Explorer cruiser. I was wearing my Brunswick Police Jacket and my ballistic resistant external carrier style vest, which is clearly marked on the front/back with "POLICE." This vest was worn on all operations described below.

Upon reaching the Lewiston Police Department, we were redirected to The Colisee for assignments.

At The Colisee, it was discovered the suspect was Robert Card, and he was driving in a white Subaru outback with a black bumper. SRT members were held for assignments and general officers were assigned in pairs to search for Card.

Det. Kittredge and I searched the Lewiston area to include Mixer's Bar in Sabattus, but we found it to be closed. I then heard excited radio traffic reporting "196." We made our way to Route 196 and found a caravan of police cruisers traveling Code 3 headed towards Lisbon. We joined the caravan and ended at Miller Park in Lisbon.

Upon arrival, other officers were already set up on a white Subaru Outback parked in the lot nearest to the Paper Mill trail. I deployed my department issued rifle [REDACTED] vehicle and surrounding woods. While in this position, I heard radio traffic that Card may have a night vision scope. [REDACTED]

Det. Kittredge went up the hill and parked on the side of the street across from the trail. We monitored the area for a considerable time with no contact.

We then went back down to Miller Park. By this point, MSP SRT had cleared the car [REDACTED]. I assisted BPD [REDACTED]

We were then cleared around 02:42 hours.

**October 26, 2023**

On this date, I was assigned to attend the command post (CP) in Lewiston. I was then tasked with assisting Brunswick PD/Portland PD SRTs [REDACTED]. M/W Dan Sylvain was also tasked with this assignment. I then traveled to Lisbon and parked my cruiser at K&M Tire on Capital Avenue. M/W Sylvain and I used this parking lot [REDACTED]. During this time, I provided overwatch with my department issued rifle slung. [REDACTED] searching/covering SRT while they searched Maine Recycling

Corporation (MRC). [REDACTED]  
[REDACTED]. Brunswick SRT then cleared this with nothing found. We then cleared and returned to the command post. We were later cleared.

### **October 27, 2023**

On this date, I returned to the CP. I was still attached to [REDACTED], which consisted of M/W Sylvain, Ofc. Bedard and myself. We were tasked with assisting Brunswick/Portland SRT with clearing a residence [REDACTED]. We followed them to the area.

Upon our arrival, I found that multiple members of the media had followed us. I then contacted Monmouth/Winthrop Police Chief Ferland and relayed we were in town for the op. He advised he would have officers respond to assist. [REDACTED] remained down the road [REDACTED] while SRT deployed to the house. I deployed with my department issued rifle and provided overwatch [REDACTED].

A short time later, Lt. Dana Wessling arrived and assisted us with traffic control, scene security and providing local intel.

At the conclusion of this mission, we returned to the CP. We stood by for further assignment and were relieved in the late afternoon.

I learned early evening that Card had been found dead.

No further involvement with this case.

On 10/25/2023, I recieved a call from a co-worker advising me of a mass casualty shooting in Lewiston. I was told to come in to operate [REDACTED]. I arrived at the station and loaded up all gear needed [REDACTED]. I then went to Lewiston PD where we were redirected to the parking lot of the Colisee for assignments.

Officers were given orders to double up and search for Card while SRT members were given assignments. Later in the night, Card's vehicle was found in Lisbon at Miller Park. Multiple SRT's responded to the area and cleared the scene. I was then sent to the scene to assist with the search of Card [REDACTED]. [REDACTED]

[REDACTED] I was advised to secure for the night.

The following day, 10/26, Det. Sgt. Moir had requested me to assist him [REDACTED]. I met up with Det. Sgt. Moir as well as Brunswick and Portland SRT's in Lisbon at K&M Tire, which was across the street from Maine Recycling Corporation, this was where SRT had completed their search for Card. [REDACTED]

[REDACTED], I did find an open door at Craft's Self Storage, across from MRC, which Brunswick SRT searched/cleared. No other actions were completed this day.

On 10/27/2023, I responded to CP [REDACTED]. I was with Det. Sgt. Moir and Ofc. Bedard when we were tasked to assist Brunswick and Portland SRT's with clearing a residence [REDACTED]. Upon arrival, [REDACTED]. After finishing this flight request, we returned to CP.

I learned later in the evening Card was found dead.

As a member of the Brunswick Police Department Criminal Investigations Division, I routinely assist with investigations associated with a variety of offenses. In this matter, the facts are as follows:

On 10/25/2023, at about 1950 hours, I became aware of an active shooter in Lewiston, Maine. Shortly after, available Brunswick Police Department (BPD) Officers organized at the BPD before convoying to the Lewiston Police Department (LPD), 171 Park Street, Lewiston, to offer any needed assistance. Upon arrival, I made LPD personnel aware we were available for any needs before assembling with other Law Enforcement Officers at The Colisee, 190 Birch Street, Lewiston. Soon after LPD Corporal Jeremy Somma briefed BPD personnel on the shooting at Just-In-Time Recreation, 24 Mollison Way, followed by the shooting at Schemengees Bar and Grille Restaurant, 551 Lincoln Street; Photos of the suspect shooter and vehicle were disseminated to BPD units. At about this time, the suspect was identified as 40-year-old Robert CARD believed to be operating Maine passenger car [REDACTED] a 2013 White Subaru with a dark-colored bumper.

At this point, BPD Sergeant Moir and I began patrolling the Lewiston area for the suspect vehicle, particularly at locations where people may congregate in groups. We made our way out Sabattus Street to Mixers Nightclub & Lounge, 136 Sabattus Road, Sabattus; the business was found to be closed. From here we made our way to Lisbon Street in Lewiston via Pond Road when we overheard State Wide radio traffic indicating the suspect vehicle had been located on route 196 in Lisbon. We immediately traveled outbound to Miller Park on Frost Hill Avenue at Lisbon Street, Lisbon. I subsequently moved to the [REDACTED]. Here I observed the suspect vehicle parked about 100 feet away with no occupants or movement observed. We held these positions for some time before relocating along Frost Hill Avenue with many other officers [REDACTED] to Miller Park. After a number of hours, it became clear no further action was to be taken [REDACTED] Miller Park, I cleared the area for the night at about midnight.

On 10/27/2023, at about 0800 hours, I traveled to Lewiston High School 156 East Avenue, Lewiston, with available BPD units to provide any needed assistance. During my time at Lewiston High School, I worked with a group of BPD Detectives who performed a handful of remedial tip line phone callbacks to gather more detailed information. The following is my involvement regarding the shooting event in Lewiston on 10/25/2023. My areas of operations were Lewiston, Lisbon and Monmouth.

**Day 1:**

On 10/25/2023, I, Officer Bedard, was off duty at home when I received an IMC page via text just before 2000 hours. The page advised there was an active shooter situation happening in Lewiston and Brunswick Police Department was requesting officers to come into the station for mutual aid assistance.

I responded to provide assistance with [REDACTED]

[REDACTED] At this point the number of suspects and shooting locations was unconfirmed. After a quick briefing at the station, members of the Special Response Team (SRT), Crisis Negotiations Team, UAS Operations and K-9 drove to Lewiston Police Department for further directions. Once at Lewiston PD we were redirected to the Command Post (CP) being set up at The Colisee in Lewiston.

While at The Colisee, Brunswick PD Officers were advised of the situation. There had been two different shootings, one at Spare Time Bowling and one at Schemengees, both in Lewiston. There had been multiple reports of other gun fire and possible active shooters in the Lewiston area but none had been substantiated. A picture of the suspect from Spare Time had been shared and eventually identified as **Robert Card**. A dispatch center later confirmed he owned a white 2010 Subaru Outback [REDACTED], which was connected to the shooting.

Lewiston PD requested patrol units canvas the city in search of the suspects vehicle. I was riding in the passenger seat with Officer Michaud. Officer Scott and K-9 Officer Wolongevicz also went to search and rode together. We were in Lewiston on ME-196 towards Lisbon, checking the area around Gridiron Restaurant and Sports Pub when we heard broken radio traffic on Statewide Car to Car (SWCC was the primary frequency being used). The radio traffic was an officer stating they were with the suspects vehicle on ME-196 in Lisbon. The location was unreadable. Officer Michaud and I started that way. We eventually found a group of four cruisers at the boat launch parking lot on the corner of ME-196 and Frost Hill Road. They were setup at the suspects vehicle. It was not clear if the vehicle was occupied or not. The first officers on scene were waiting for additional units to clear the vehicle.

On 10/25/2023, at approximately 2001 hours, I, Sgt. Patrick Scott, came into the police station to get ready for my shift when I saw multiple officers gathered in our dispatch center. I was informed there was a shooting in Lewiston and I needed to gear up right away.

Once I did I was in the roll call room with multiple other members of our agency. Commander Rinaldi eventually informed us that we were going to go as a large convoy to Lewiston PD. Off. Bedard, Michaud, and I gathered some equipment for a potential negotiation situation and put it in Off. Bedard's cruiser. I got into Off. Wolongevicz's cruiser and we started that way.

All units drove code 3 and we arrived at Lewiston PD. We were only there for a matter of minutes before we were directed to the Colisee. Once there multiple units stoodby on scene. We then got information that the suspect involved was **Robert Card**, and we got a description of his vehicle as well. Off. Michaud, Bedard, Wolongevicz, and I were asked to patrol the city in order to look for the vehicle.

We started to patrol the city for some time with no luck. While on a side road that intersected with Rt. 196, another officer pulled up next to us. We were scanning the channel "state wide car to car", when a broadcast went out that the vehicle was found. The other cruiser sped off and we followed it.

While driving down Rt. 196 for a few miles we saw the lone white vehicle abandoned in a parking lot surrounded by a significant police presence. Once out of the cruiser I noticed there were a significant amount of guns on the car, but nothing was happening. I attempted to get information from a State Trooper and Lewiston Officer, but no one knew who was in charge on scene. I was attempting to find an answer or start negotiations due to the long silence, but was then ushered up the road [REDACTED].

We drove up the road a bit and kept an eye on the area with Det. Kittredge, Off. Michaud, and Off. Bedard. We stayed there for hours until we were told we could clear. We eventually went to the end of Frost Hill Ave. where we spent some time with SRT. I ended up going back to the police station at approximately 0240 hours.
