

3. During my time on scene, no subjects entered or exited the area that had been marked off with crime scene tape and nothing of substance occurred.

### SYNOPSIS:

1. On Friday, 10.27.2023 I conducted scene security at Sparetime Recreation located at 24 Mollison Way in the City of Lewiston from 0800hrs-2000hrs. On Saturday, 10.28.2023, I conducted scene security at Spare Time Recreation located at 24 Mollison Way in the City of Lewiston from 1330hrs to 2000hrs.

### DETAILS:

1. On Friday, 10.27.2023, at approximately 0800hrs, I responded to Sparetime Recreation located at 24 Mollison Way in the City of Lewiston to relieve SS/A Matt CASHMAN and S/A William ROUSSEAU who had been providing scene security. I was paired with S/A Timothy FROST and tasked with continuing scene security from approximately 0800hrs to 2000hrs. My responsibility was to limit access to investigative and other authorized support staff at the back parking lot near the main entrance. During this time, there was nothing of significance to report. I was relieved from the scene by SS/A Pete MADOR at approximately 2000hrs.
2. On Saturday, 10.28.2023, at approximately 1330hrs, I responded to Sparetime Recreation located at 24 Mollison Way in the City of Lewiston to relieve SS/A Brandon VAFIADES who had been providing scene security. I was originally paired with S/A Steve SAUCIER who was later replaced by S/A Blake WILDER at approximately 1400hrs. I was initially positioned on the front side of the complex tasked with performing scene security from approximately 1330hrs to 2000hrs. My responsibility was to limit access to

investigative and other authorized support staff at the front of the building along Mollison Way.

3. Prior to departing after being relieved, S/A Steve SAUCIER provided contact information for Maine State Police Trooper Terry JAMES and directed me to forward information of the families who arrived at the location to retrieve their vehicles.
4. During this time, the following subjects arrived to retrieve their vehicles. Neither vehicle was removed from the scene. Their vehicle and contact information was forwarded on to Trooper JAMES;

6. At approximately 1630hrs, I received information from S/A Blake WILDER regarding direction to move the barricades from the intersection of the parking lot of the complex and Mollison Way allowing traffic to move freely through the parking lot of the complex.

7. Upon removal of the barricades, I joined S/A Jon RICHARDS at the back of the complex near the main entrance while S/A WILDER and S/A Chancey LIBBY remained on the front side of the complex.

8. While on the back side of the complex, in the large parking area that contained the vehicles of those who fled the scene the night of the incident, a small number of property owners began to arrive to retrieve their vehicles. Several vehicles were driven from the scene.

8. At approximately 1920hrs, a team of employees from New England Trauma Services began to arrive.

9. At approximately 1950hrs, S/A RICHARDS and I were relieved by Trooper Seth ALLEN and Trooper Elijah ELLIS-HATHAWAY.

### SYNOPSIS:

Security detail at 24 Mollison Way, Lewiston October 28, 2023

### DETAILS:

1. October 28, 2023 I was assigned security for the back parking lot and entryways to the "Sparetime Recreation" located at 24 Mollison Way in Lewiston. My assigned hours were between 08:00 and 20:00.
2. I arrived at approximately 07:30 and relieved MDEA Supervisor Agent Peter Madore. SSA Madore identified the area of responsibility and that there had been no attempts of unauthorized entry during his tour of duty, the pervious 12 hours.
3. I maintained a post [REDACTED] of the Sparetime Recreation center. Throughout the day, I had NO contact with any unauthrized persons.
4. At approximately 4 PM the entire search and recovery persons from the Maine State Police and the FBI left the area. I maintained control of my assigned area.
5. I was advised by SSA Chris Thornton that the evidence collection was complete however they requested that we maintaine our positions until our tour was over. It was also reported that persons would be coming to do "cleanup" of the scene at some point and the property had been released to the owners. Further people "may" show up to pick up their vehicles that had been a the scene sence the mass shooting.
6. I was able to secure the outside doors to the building pending authorized persons arrival.
7. Me and SSA Thornton remained in the parking lot and after a while, curious people started driving through the lot and immediately leaving.



8. Several persons arrived, identified themselves to me and SSA Thornton and requested their vehicles. SSA Thornton allowed persons to collect their vehicles from the parking lot. No log or record was kept of any of these transactions however everyone who asked for a vehicle had keys and explained that they had either been at the scene or had a family member at the scene.
9. At approximately 17:00 persons from the Bio-hazard cleanup crew started arriving, met with owners of Sparetime recreation, entered the building and began cleanup.
10. At approximately 20:00, me and SA Thornton was relieved by Trooper Seth Allen and another unknow trooper in their marked SP automobiles.
11. SA Richards left without incident or injury with persons or property.

We were asked to stage at the Bernard Lounge Bridge in Lewiston to watch for the suspect vehicle, identified as a white Subaru, in the event that the suspect attempted to leave Lewiston and head towards Auburn. We remained at the bridge until about 0300 hours, but we did not observe the suspect or his vehicle while at the post.
3. This concludes my involvement with this incident.
