## 1. CALL TO ORDER

Chair Steven Silver called the meeting to order at 9:00 am in person & via Zoom application online.

## 2. MINUTES REVIEW AND APPROVAL

### June 25 2024 Meeting Minutes Approval –

Board member Sari Greene moved to approve the June 25, 2024 meeting minutes. Board Chair Steven Silver seconded the motion. Moved to roll call vote.

## 3. OPERATIONS REPORT - Inspector Supervisor Vicki Gardner

In June 2024 there were 10 Shipments of machines and/or associated equipment shipped to or from licensed facilities. On-site inspectors completed 29 checklists which resulted in 0 complaints of potential violations. There was 1 formal complaint which was reported by Deputy Director Matthew Motti, regarding inadequate audio/visual monitoring. There were 3 minor violations which will continue to be monitored from the activity log, and 1 patron complaint. There were 9 self-exclusions.

Oxford Casino had 16 calls for service to Oxford PD, 5 in the parking lot, 1 in the hotel and 10 were Casino related, including, intoxication, trespass, requests for an office, suspicious activity, drug activity, agency assist, traffic offense, and vandalism. Hollywood Casino had 12 calls for service to Bangor PD, 4 in the parking garage or outside, 1 in the hotel or lobby, and 7 in the casino, including disorderly, intoxications, PD accident, 911 hangup, information, robbery, suspicious activity and wanted out.

### 4. FINANCIAL REPORT – Alex Joutov

Total Casino Tax Revenue paid to the State of Maine decreased by 4.31% in June 2024 for both facilities compared to the same months in 2023. Total revenue collected year to date is \$33,450,183.00, a decrease of 3.33% (or \$1,151,745.00) compared to the same months in the prior year.

Specifically, by Casino —

The Oxford casino reported total net win from Slot machines of 7.88% in June 2024. Reported total win from Table Games was 23.80% in June 2024. The Hollywood casino reported total net win from Slot machines of 8.24% in June 2024. Reported total win from Table Games was 24.81% in June 2024.

In the area of Advance Deposit Wagering -

We observed a decrease of 11% for June 2024, compared to the same month in 2023.

2024 Year to Date Tax Revenue collected from in-state and out of state races was \$109,129.00, a decrease of 7.4% (or \$8,708.00) compared to the same months in the prior year.

Board Chair Steven Silver asked if there is any sense of Sports Wagering causing the decreases that were observed in the Casino tax revenue. Board member Greene asked for the addition of Sports Wagering information in the auditor report to draw conclusions to this.

## 5. EXECUTIVE DIRECTOR REPORT

- Legal review of rules regarding chapter 28 advance deposit wagering has a deadline of Sept. 30.
- FBMS rules have been sent to the Secretary of State's office for a third publication.
- Director Champion will be meeting with GLI and BMM tomorrow to discuss other states certification process for labs and will present recommendations at the September meeting which may include rulemaking.
- Director Champion is working on rules for Chapter 13 for a public hearing and written comment.

### **8. NEW BUSINESS**

### a) Administrative Staffing levels – DPS Commissioner Michael Sauschuck

Commissioner Sauschuck discussed the current staffing levels and the increased workload that the Gambling Control Unit has experiences since 2017. Board discussion occurred at this time.

### b) Scheduling change rationale – DPS Commissioner Michael Sauschuck

Commissioner Sauschuck described the reasoning behind changing the inspector schedules, providing examples of facilities where there are days without inspectors on duty and facilities with inspectors on duty 24 hours a day, 7 days a week. Board Discussion occurred at this time.

## c) Review the rules affected by Schedule -

Board members discussed the different daily tasks/processes highlighted by the casinos that have been affected or may be affected by the inspector schedule change. Processes affected by the schedule change include the payout of jackpots exceeding \$2,500, the issuance of temporary ID's to employees, and ram clears for slot machines and other devices. The Board ultimately decided to have the Director pull back the current publication of the rulemaking package so the Board can consider whether and how to amend the rules with which licensees have encountered difficulty complying due to the schedule change.

Board member Sari Greene moved to retract rules currently submitted to the Secretary of State. Board Chair Steven Silver seconded the motion.
