The individual has since submitted an application for a new EMT license.

**MOTION** to issue the EMT license with a letter of guidance to be kept on file for five years, citing the importance of answering application questions completely and honestly and the responsibility to disclose any future criminal convictions to the Board within ten (10) business days. #### b. 23-351 Case Review

**Summary:** A licensee allegedly failed to complete the terms of the consent agreement resolving complaint No. 17-039; has since twice failed to answer a question regarding discipline against a professional license honestly on renewal applications; and was convicted of Class E Driving to Endanger in 2023.

**MOTION** to recommend the Board amend the consent agreement resolving case No. 17-039, to accept the two (2) letters of recommendation submitted in May 2024 to meet the terms of paragraph 8.B.1.; to stay the quality assurance review terms of paragraph 8.B.2 and require the licensee to notify Maine EMS within five (5) business days when they become affiliated with a Maine EMS service, and to require future EMS licensing applications(s) to come before the Maine EMS Board until the stayed terms of P.8.B.2. are completed; regarding the 2023 conviction for Driving to Endanger, to include a finding that the licensee has been sufficiently rehabilitated to warrant the public's trust.
