- d. Town of Rockport Application Review
 - i. The Town of Rockport has submitted an application to license the Rockport Fire Department as a new ground ambulance service. Their complete application package includes a new consultancy report.

The Board reviewed Maine EMS Rules Chapter 3, §4 and discussed whether or not the applicant meets the following criteria outlined in that subsection:

- A. The Board finds the applicant's proposed response time(s), enroute time(s), transport time(s), and time-tolerance(s) are sufficient to protect the health, welfare, and safety of the public within the 9-1-1 Primary Response Area based on evidence provided;
- B. If the 9-1-1 Primary Response Area is currently served by a licensed ground ambulance or non-transporting service, the proposed times above are maintained or improved;
- C. Public comment(s) received;
- D. Discipline undertaken by the Board and any Letters of Guidance that have not expired for the ambulance service currently serving the 9-1-1 Primary Response Area, and the service applying to serve the 9-1-1 Primary Response Area;
- E. An evaluation of the potential impact upon existing ground ambulance and non-transporting services; and
- F. The character of the ownership of a proposed service.

- g. Consideration of Public Comments & Proposed Responses, Basis Statement, and Proposed Modifications to Chapter 27: Implementation of EMS Sustainability Program
 - The Board reviewed the newly proposed language for Chapter 27 of Maine EMS Rules, which would govern the implementation of Maine EMS's Sustainability Program.
 - ii. Based on public comments received, the Rules Committee modified the proposed rule to change how grant funds are allocated to training centers. The maximum funding allocation was reduced to \$833,000. Additionally, the total available amount was reduced by \$1.5 million, with \$1 million being reallocated to transporting services and \$0.5 million being reallocated to non-transporting services. EMS Staff also proposed a change to the allocation algorithm.

Board Chair directed for a 10-minute break without objection.

MOTION: To publish for public comment the draft proposal of Maine EMS Rules Chapter 27 with the following modifications:

- Under Section 6.1.A., §2, delete criteria (a)-(e) and move the subsection's headers to Section 7;
- Under Section 6.1.A., remove §3: Scoring Range; and
- Under Section 6.1.A., §2, add in the staff-proposed allocation algorithm for the administration of funds, as amended during this meeting.
