Thresholds		
Only party committees that raise or spend more than \$1,500 during the calendar year are required to file Regular Reports. The requirement to file is triggered when the committee exceeds \$1,500 in contributions or expenditures. The first report due after exceeding \$1,500 in contributions or expenditures is the next scheduled report. A committee's first report in a year should include all activity since the beginning of the year.

24-Hour Report of Contributions and Expenditures (Supplemental Reports)		
If a committee receives more than \$5,000 from a single source or makes a single expenditure of \$1,000 or more during the below time periods then it must file a supplemental report within 24-Hours of that transaction, including Saturdays, Sundays, and Holidays. (If they have or will clear the \$1,500 threshold.) For expenditures, orders placed with or obligations made to vendors are considered expenditures at the time the orders or obligations are made. Overhead expenditures, such as rent, taxes, utilities, and some salary payments are exempt from this requirement.

Independent Expenditure Reports (Supplemental Reports)		
A paid communication that depicts clearly identified candidate(s) must be report via an independent expenditure report if the expenditure exceeds \$250 per candidate and the communication was made and disseminated independent of the candidate or the candidate's committee. These reports must be filed regardless of if the committee has reached the \$1,500 threshold.

1-Day Pre-General IE Report(s)	October 23 – November 4, 2024	Within 1 calendar day of the expenditure

Failure to seek out timely assistance from staff regarding the filing of reports will not be considered a mitigating circumstance if a report is filed late.
