MDIFW Fishing Regulation Proposals For the 2025 fishing season



The Maine Department of Inland Fisheries and Wildlife is proposing regulation changes for the upcoming ice fishing and open water fishing seasons. These regulations are needed to provide for the effective conservation of Maine's inland fisheries and to enhance fishing opportunities throughout the State. This rule-making packet includes 23 individual proposals presented in the following "themes":

Purpose of Change:

The Fisheries Division conducted a thorough review of the statewide lake inventory database and newly surveyed waters to identify candidates for potential inclusion as State Heritage Fish Waters. Aziscohos Lake is a wild brook trout water in the Magalloway River drainage containing multiple age classes of brook trout. This water was last stocked in 1999. Given it has now been 25+ years since that last stocking event, Aziscohos Lake meets all Heritage List eligibility criteria and is proposed to be added to the State Heritage Fish Waters List.

NOTE - State Heritage designation is proposed only for Aziscohos Lake and is not proposed for Sunday Pond (watcode 7646).

Upper South Branch Pond is a well-known wild brook trout water within Baxter State Park containing multiple age classes of brook trout. This water was last stocked in 1998. Given it has now been 25+ years since that last stocking event, Upper South Branch Pond meets all Heritage List eligibility criteria and is proposed to be added to the State Heritage Fish Waters List.

The Fisheries Division conducted a thorough review of the statewide lake inventory database and newly surveyed waters to identify candidates for potential inclusion as State Heritage Fish Waters. Thomas Lake is a small wild brook trout water in T16 R8 WELS, southeast of St. Francis. This small 5 acre water contains multiple age classes of brook trout. This water has never been stocked. Thomas Lake meets all Heritage List eligibility criteria and is proposed to be added to the State Heritage Fish Waters List.

Purpose of Change:

Crawford Pond (a State Heritage Fish Water) contains populations of wild brook trout and wild lake trout. In addition, there are many other wild brook trout ponds located upstream in the drainage. Since 2013, five landlocked salmon have been caught in Crawford Pond. While salmon can coexist with brook trout and lake trout in larger lakes, they are not native in Crawford Pond and are likely to compete with these native salmonids. Landlocked salmon are stocked and managed in downstream waters providing sport fisheries. There are several waterfalls on the outlet that were thought to be barriers to any upstream fish passage but on certain flows it appears that salmon have been able to navigate the outlet upstream. To date, no reproduction of landlocked salmon in Crawford Pond or its outlet has been documented by MDIFW. The purpose of this regulation is to allow anglers to harvest any landlocked salmon they may encounter.

Purpose of Change:

Snowshoe Lake contains populations of smallmouth bass and chain pickerel and is quite shallow with an average depth of 14 feet. However, there is one small deep hole with a maximum depth of 44 feet. Snowshoe Lake historically contained a population of lake whitefish (species of greatest conservation need), which until recently had not been encountered in MDIFW sampling events since 1962 (subsequent surveys in 1968 and 1980 failed to capture any whitefish). Recent efforts to better understand our lake whitefish populations prompted a survey in 2019, which resulted in one lake whitefish being caught. A follow up in 2023 resulted in a catch of six lake whitefish. While there is still more work to be done to better understand this population, it appears there has been some sporadic recruitment since the last time whitefish were encountered. The purpose of this proposal is to reduce the likelihood of an accidental introduction of rainbow smelt, which are not currently present in Snowshoe Lake by prohibiting the use of live fish as bait. In other waters, rainbow smelt have been shown to negatively impact lake whitefish populations, particularly those that are already stressed from other factors such as limited habitat and poor water quality.

Regulation Change Description:

Remove: "S-3" and "Areas in the lake within 100 feet of the mouth of any tributary are closed to the taking of smelts. Add: "All whitefish must be released alive at once."

Purpose of Change:

South Pond is one of the few southern Maine waters that contains a population of lake whitefish (species of greatest conservation need). However, the population is believed to be very low. The purpose of this proposal is an experimental effort to conserve lake whitefish and suppress rainbow smelt. Along with this proposal management priority would shift from landlocked salmon to lake whitefish and would include removal of current protections on the rainbow smelt population. In other waters, rainbow smelt have been shown to negatively impact lake whitefish populations. South Pond is a relatively small water (284 acres) and reductions to the smelt population may be effective at increasing whitefish recruitment. The landlocked salmon stocking program will continue for the next few years as they too will apply pressure to the smelt population. Once salmon growth and condition degrades, the stocking program will be proposed for termination.

Purpose of Change:

Little Wilson Hill Pond (a State Heritage Fish Water) was first surveyed in 2010 and contained a robust brook trout population representing various ages. Angler use appeared to be high at the time as access is relatively easy. Following angler complaints, a survey conducted in 2023 resulted in only one brook trout being caught. Additionally no fish were observed following the inspection of tributaries that contained numerous young of the year brook trout during the original survey. The cause of this decline is unknown, but may be related to previous drought years in Western Maine. The purpose of this proposal is to add temporary protection to the native brook trout population in Little Wilson Hill Pond by applying S-7 (all trout, landlocked salmon, and togue must be released alive at once.) The expectation is that this population will recover, at which time the regulations will be evaluated with the goal of resuming harvest.

Baker Pond (a State Heritage Fish Water) currently contains an overabundant population of wild brook. Sampling catch rates have increased in recent years and in 2023 60% of the brook trout captured were observed with high parasite loads, a sign of an overabundant/ unhealthy population. Additionally, the catch of wild landlocked salmon has declined and the population appears to currently be low. The purpose of this proposal is to liberalize the brook trout regulations in an effort to increase harvest and improve the quality and health of brook trout; and to limit the harvest of landlocked salmon by applying a one fish bag limit.

Little Concord Pond was chemically reclaimed in 2011 to eradicate competing fishes and enhance the stocked brook trout fishery. While the project was successful, angler use and harvest are below objectives contributing to an abundance of brook trout and a decline in fish size quality. The purpose of this proposal is to increase harvest of smaller brook trout to improve size quality. In addition, the steep sided nature of this pond makes fly fishing here challenging, particularly when doing so from shore. The secondary purpose of this proposal is to expand angling opportunities by shifting from "fly fishing only," to "artificial lures only" to allow for easier angling for more people.

Purpose of Change:

Access to Dixon Pond (a State Heritage Fish Water) has traditionally been difficult, requiring anglers to boat across Pierce Pond to a trailhead and then a hike of approximately 20 minutes. However, recent forestry activity and road construction has improved access and now requires only a short walk of just over 100 yards. Recent surveys indicate that angler use is increasing and that brook trout size quality is declining. The purpose of this proposal is to reduce brook trout harvest by going from general law to a two fish bag limit, with only one exceeding 12 inches.

Purpose of Change:

Recent regulation changes at Swan Lake have focused on increased ice fishing opportunity, with the intent of increasing harvest on togue. In 2018, regulations were changed to allow ice fishing from January 1 through ice out, where previously Swan Lake was open to ice fishing in January and February only. In 2023, the S-8 regulation was removed to allow ice anglers the use of five lines instead of two. Landlocked salmon stocking was temporarily suspended in 2023 and 2024 to reduce predation on the stressed smelt population.

The intent of this proposal is to reduce the overabundant and severely stunted togue population by allowing unlimited harvest of togue. Fish condition is currently poor and is not meeting objectives. The majority of togue are shorter than the current 18 inch minimum length limit.

This proposal would shift management priority from just one season and would expand angling opportunity to year round. In conjunction, this stocking program will be proposed for cancellation and anglers will have the opportunity to target the abundant largemouth bass population that exists in the pond. General Law provisions are adequate and are expected to increase angler use by allowing kids and adults to fish.

In an effort to improve catch rates, a brook trout stocking program was initiated in 2020. However, angler use is still low and this water is underutilized. This proposal would liberalize tackle/harvest regulations and open this water to ice fishing by reverting to general law.
