An amendment and fiscal note for LD 916 are attached for your review.

LD 916, An Act To Promote Investment in Maine's Communications Network and Natural Gas Network

The Committee voted on April 5, 2013, with a divided report of OTPA/ONTP.

- The amendment removes from the bill the sales tax exemption for natural gas heating equipment sold to a business or residential consumer.
- The fiscal note indicates that exempting telecommunication equipment sold to telecommunications services providers reduces General Fund revenue by \$4,561,648 in FY 2013-14 and \$5,608,145 in FY 2014-15 and Municipal Revenue Sharing by \$240,087 in FY 2013-14 and \$295,165 in FY 2014-15.
